Respectfully Sheweth;

Appellant humbly submits and requests as under:-

1. That the appellant was appointed as Qaria Teacher in BPS-12 on 09/10/2006 and still serving on the same post of Qaria Teacher BPS-12 at GGHS Shor Kot Dera Ismail Khan. The appellant has Master degree along certificates of Shahadat ul Almia, Tajveed ul Quran from Wafaq ul Madaris and is entitled for the promotion of SST General. On 09/03/2020 various teachers are promoted to SST BPS-16 but none of the Qaria teacher was promoted to the said post of SST General BPS-16. Copy of the notification regarding the promotion of various teachers other than Qaria is annexed as **Annexure "A"**.
2. That the seniority list in respect of promotion to the post of SST for the year 2020 consisting of all cadres teachers and from the cadre of Qaria the appellant is at serial No. 05 has top position for the promotion to SST General. Copy of the seniority list is annexed as **Annexure "B"**.
3. That the seniority list in respect of promotion to the post of SST for the year 2019 consisting of all cadres teachers and from the cadre of Qaria the appellant is at serial No. 24 has top position for the promotion to SST General. Copy of the seniority list is annexed as **Annexure "C"**.
4. That according to DPC (Departmental Promotion Committee) held on 11/11/2019 various post of SST General were vacant while 0.36 i.e. 3% quota is reserved for already working teachers as Qaria in Education Department. Copy of the working paper of DPC meeting showing the vacant post of SST General is annexed as **Annexure-D**.
5. That the notification dated 24/07/2014 1-B clause E provided the criteria for the promotion of Qaria teacher to the post of



SST General. According to which appellant is qualified for the promotion to the post of SST General. Copy of the notification is annexed as **Annexure-E**.

6. That the appellant submitted application to respondent#3 on 01/07/2021, for the consideration of her case for promotion but no order was passed. Copy of application is annexed as **Annexure-F**.
7. That up-till now no response has been shown from the respondents and after the laps of statutory limitation of departmental appeal, cause of action has been accrued to the appellant for the instant appeal, Hence the instant service appeal.
8. That jurisdiction of this worthy service tribunal is being invoked to direct the respondents to promote the appellant from Qaria Teacher to SST General according to seniority list 2020 and notification dated 24/07/2014, inter alia on the following grounds amongst others;


GROUND:-

- A. That the appellant was inducted into service as Qaria teacher on regular basis in BPS-12 on 09/10/2006 and is entitled for promotion to SST General BPS-16 according to the seniority list 2020-2019 and according to the notification dated 24/07/2014.
- B. That other various teachers were promoted to the SST in year 2020 but none of the Qaria teacher was promoted to the post of SST. Appellant is at top position in the cadre of Qaria in the seniority list of the post of SST General but respondents are reluctant to promote the appellant on the post of SST General BPS-16. Thus the act of the respondents is void,



illegal, and discriminatory against the merit and seniority list and violation of rules and regulations.

- C. That the appellant is serving as Qaria in the department since 2006 and the respondent event did not prepared seniority list of Qaria Teachers and did not promote her as Senior Qaria Teacher which also shows the mala-fide on the part of respondents. Moreover, the candidates who are much junior than the appellant (of other cadres) were promoted in the year 2020 to the post of SST (General) but the appellant is not promoted till now. This fact also reveals that respondents are deliberately intending to deprive the appellant.
- D. That despite receiving application department neither allowed nor refuse the said application and appellant has not been promoted to BPS-16. Various posts for SST General are available for promotion while appellant is on top position in seniority list 2020 amongst the Qaria cadre but appellant is deprived from her legal and fundamental right.
- E. That from year 2015 up till none of the Qaria teacher has been promoted to the post of SST General. according to the notification 24/07/2014 and seniority list 2020 appellant is fully entitled for the promotion to the post of SST General.
- F. That the appellant, time and again, requested the respondents and also submitted an application for her

promotion but due to the lethargic conduct of the respondents the requests of the appellant are shuffling from desk to desk and grievance of the petitioner has not been redressed as yet.

G. That counsel for the appellant may please be allowed to raise additional grounds at the time of arguments.

It is therefore respectfully prayed that on acceptance/issuance of instant appeal the respondents may kindly be directed to promote the appellant from Qaria teacher (BPS-12) to the post of SST General according to the seniority list 2020 and according to the notification dated 24/07/2014.

Any other relief deemed appropriate in the given circumstances may also be granted in the larger interest of justice.
