PRAYER IN APPEAL

By acceptance of instant appeal respondents No 1 to 3 may kindly be directed to promote appellant from Qaria teacher (BPS-12) to the post SST Bio-Chemistry according to the seniority list 2020 and according to the notification dated 24-07-2014. And Any other remedy deemed appropriate in the given circumstances may also be granted.

Respectfully Sheweth:

Brief Facts:

1. Appellant was appointed as Qaria teacher BPS-12 dated: 28-05-214 and till serving on the same post of Qaria teacher BPS-12 at G.G.H.S.S No.2 Dera Ismail Khan. The Appellant has bachelor degree with the combination of bio-Chemistry and entitle for the promotion of S.S.T Bio-chemistry. On 09-03-2020 various teachers are promoted to S.S.T BPS-16 but none of Qaria teacher was promoted for the said post SST BPS-16. Copy of the notification regarding the promotion of various teacher other than Qaria is enclose as **Annexure A.**

2. That the seniority list in respect of promotion to the post of S.S.T for the year 2020 consisting of all cadres teacher and from cadre of Qaria the appellant is at serial No. 9 has top position for the promotion of SST Bio Chemistry . Copy of seniority list is enclose as **Annexure B.**

3. That the seniority list in respect of promotion to the post of SST for the year 2019 consisting of all cadres teacher and from cadre of Qaria the appellant is at serial No. 28 has top position for the promotion to SST Bio-Chemistry. Copy of seniority list is enclosed as **Annexure C.**

4. That according to the DPC (Departmental Promotion Committee) held on 11-11-2019 one post of SST Bio-Chemistry was vacant. Copy of the working paper of DPC meeting showing the vacant post of SST Bio-Chemistry is enclosed as **Annexure D.**

5. According to the notification passed in the year 2018, eight teachers on the post of S.S.T Bio-Chemistry were appointed on open merit while one seat S.S.T Bio- chemistry was laying vacant for the promotion of serving teachers at that time .copy of the notification is enclosed as **Annexure E.**

6. That the notification dated 24-07-2014 1-B clause E provided the criteria for the promotion of Qaria teacher to the post of S.S.T Bio-chemistry .According to which appellant is qualified for promotion to the post SST Bio-chemistry .copy of the notification is enclosed as **Annexure F.**

7. That the appellant submitted application to the respondent No.3 on 23-06-2020,for the consideration of his case for promotion but no order was passed .copy of the application is enclosed as **Annexure G.**

8. Respondent No.4,5 are most junior than the appellant but the respondents No. 1 to 3 promoted them by violation the merit as well as seniority position of the appellant .

9. That Respondents No. 4,5 are included As per order dated 11-11-2021 Honorable this court.
10. That as per legal requirements, the appellant has been left with no other remedy except but to agitate her grievances before this Honorable Tribunal inter alia on the following ground :

Grounds :

1. Appellant was inducted into service as Qaria teacher on regular basis in BPS-12 in the year 2014 and is entitled for promotion to SST Bio -Chemistry (BPS-16) according to the seniority list 2020-2019 and according to the notification dated 24-07-2014.
2. That other various teachers were promoted to the SST in year 2020 but none of the Qaria teacher was promoted to the post of S.S.T. more over she is on the top position in the cadre of Qaria in the seniority list of 2020 for the post of SST Bio-chemistry but respondent to promote the appellant on the post of S.S.T BIO-Chemistry BPS-16. Thus the act of respondent is void , illegal ,and discriminatory ,against the merit & seniority list and violation of rules & regulations.
3. That despite receiving application department neither allowed nor refuse the said application and appellant has not been promoted to BPS-16 . one post for SST Bio-chemistry is available for promotion while appellant is on top position in seniority list 2020 amongst the Qaria cadre but she has been deprived from legal and fundamental right of promotion.

4. That according to the notification 24-07-2014 and seniority list 2020 petitioner is fully entitled for the promotion to the post of SST Bio-chemistry .

In the view of the above mentioned facts and grounds it is most humbly prayed that the instant appeal may kindly be accepted and respondents may kindly be directed to promote appellant from Qaria teacher (BPS-12) to the post SST Bio-Chemistry Bio-Chemistry BPS-16 according to the seniority list 2020 and according to the notification date 24-07-2014. Any other remedy deemed appropriate in the given circumstances may also be granted.

Reference to the original application received from Mrs. Farzana Naz, Qaria, GGHSS No.2, DIKhan, to Office of the DEO (Female) DIKhan vide diary No. 3054 dated 14.9.2020, and letter of the Director KP E&SE Department, No. 3941 dated 10.09.2020.

It is hereby stated that the undersigned has timely probed into appeal in the matter of promotion of the appellant and it is declared that she was not deserving promotion on the sought 3% quota due to insufficient service (less than 5 years) in the promotion order No.3927-32, dated 18.02.2019 issued by office of the director KP E SE Department Peshawar.

That the appellant has been appointed in June 2014 and could not be recommended for promotion to the post of SST dated 18.02.2019 for insufficient service length of the appellant. Then she had not completed her initial 5 years of service.

That there had been no candidate from amongst the Qaria cadre teachers who had already completed the initial 5 years' service and had prescribed qualifications; hence, due to non-availability of eligible candidate for appointment by promotion from lower cadre posts, EIGHT (08) No's of posts of the SST (BIO-CHEMISTRY) were duly advertised vide NTS for appointment from amongst the fresh candidates which was finalized vide order of the Director KP E SE Department Peshawar No. 5773-78 dated 19.06.2020.

That in the promotion order issued vide Director KP E&SE Department No 6270-75 dated 09.03.2020, there had been only 4 No's of posts for appointment on promotion as SST bio-chemistry for which there couldn't be allocated a 1 No's of posts to 3% Quota for Qaria cadre.

Respectfully Sheweth:

Brief facts

1. Petitioner was appointed as Qaria Teacherin BPS-12 in the year 2015 and still serving on the same post of Qaria Teacher BPS-12 at GGHSS No.2 D.I.Khan. The petitioner has Bachelor degree with the combination of Bio-chemistry and is entitle for the promotion of SST Bio-Chemistry. On 09-03-2020 various teachers are promoted to SST BPS-16 but none of the Qaria teacher was promoted to the said post of SST BPS-16. Copy of the notification regarding the promotion of various teacher other than Qaria is enclosed as Annexure A.
2. That the seniority list in respect of promotion to the post of SST for the year 2020 consisting of all cadres teacher and from cadre of Qaria the petitioner is at serial No.9 has top position for the promotion to SST Bio-Chemistry. Copy of seniority list is enclosed as Annexure B.
3. That the seniority list in respect of promotion to the post of SST for the year 2019 consisting of all cadres teacher and from cadre of Qaria the petitioner is at serial No.28 has top position for the promotion to SST Bio-Chemistry. Copy of seniority list is enclosed as Annexure C.
4. That according to the DPC (Departmental Promotion Committee) held on 11-11-2019 one post of SST Bio-Chemistry was vacant. Copy of the working paper of DPC meeting showing the vacant post of SST Bio-Chemistry is enclosed as Annexure D.
5. According to the notification passed in the year 2018, eight new teachers on the post of SST Bio-Chemistry were appointed on open merit while one seat of SST Bio-Chemistry was laying vacant for the promotion of serving teachers at that time. Copy of the notification is enclosed as Annexure E.
6. That the notification dated 24-07-2014 1-B clause E provided the criteria for the promotion of Qaria teacher to the post of SST Bio-Chemistry. According to which

petitioner is qualified for the promotion to the post SST Bio-Chemistry. Copy of the notification is enclosed as Annexure F.

7. That the petitioner submitted application to the respondent No.3 on 23-06-2020, for the consideration of his case for promotion but no order was passed. Copy of the application is enclosed as Annexure G.
8. That as per legal requirements, the Petitioner has been left with no other option but to agitate his grievances before this Honorable Tribunal inter alia on the following grounds:

Grounds:

1. Petitioner was inducted into service as Qaria Teacher on regular basis in PBS-12 in the year 2015 and is entitled for promotion to SST Bio-Chemistry (BPS-16) according to the seniority list 2020-2019 and according to the notification dated 24-07-2014.
2. That other various teachers were promoted to the SST in year 2020 but none of the Qaria teacher was promoted to the post of SST. Petitioner is at top position in the cadre of Qaria in the seniority list of 2020 for the post of SST Bio-Chemistry but respondents are reluctant to promote the petitioner on the post of SST Bio-Chemistry BPS-16. Thus the act of respondent is void, illegal, and discriminatory, against the merit & seniority list and violation of rules & regulations.
3. That despite receiving application department neither allowed nor refuse the said application and petitioner has not been promoted to B.P.S-16. One post for SST Bio-Chemistry is available for promotion while petitioner is on top position in seniority list 2020 amongst the Qaria cadre but petitioner is deprived from her legal and fundamental right.
4. From year 2015 up till none of the Qaria teacher has been promoted to the post of SST Bio-Chemistry. According to the notification 24-07-2014 and seniority list 2020 petitioner is fully entitled for the promotion to the post of SST Bio-Chemistry.

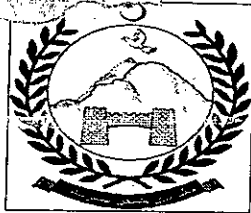

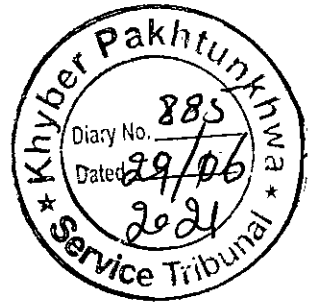
