

- That appellant was appointed as Constable in the Police Department D. I. Khan on Dated <u>es - ol - 2o/l</u>
- 2. That the appellant was performing his official duties regularly and in the meanwhile he was implicated in a criminal case by the Police Station Cantt D. I. Khan vide FIR No. 505 dated: 24.04.2020 Under Section 118 Police Act 2017. Copy of FIR is enclosed as <u>Annexure A.</u>
- That the respondent No. 4 issued statement of allegation and charged sheet dated 29.04.2020, Malafidely, illegally and unlawful. Copy of the same are enclosed as <u>Annexure B & C.</u>
- 4. That on the basis of so-called FIR, the District Police Officer D. I. Khan vide impugned office order bearing No.1253 dated 03.06.2020 imposed the penalty of dismissal from service upon the appellant. Copy of same is enclosed as <u>Annexure D.</u>
- 5. That Appellant was totally unaware of the one side decision vide Office Order bearing No.1253 dated 03.06.2020 and upon getting knowledge of the same, appellant filed a departmental appeal. Copy of Departmental is enclosed as <u>Annexure E.</u>

6. That aggrieved of the order dated 03.06.2020. The Appellant wants to impugn the same through the present appeal for setting aside the same on, inter alia, the following grounds.

GROUNDS

Í.

- That the impugned Office Order bearing No. 1253 dated 03.06.2020 are against law and facts, illegal, unlawful, based on malafide and against the admitted realities thus, the same is liable to be set aside.
- That the very foundation of impugned office Order No. 1253 dated 03.06.2020 i.e.
 The FIR is illegal, unlawful and without any legal backing.
- *iii.* That it is worthy to mention here that the inquiry officer recommended that inquiry papers may kindly be kept pending till the decision of Court.
- *iv.* That it is worthy to mention here that the case FIR No. 505 dated 24.04.2020, with triggered the departmental proceeding against appellant, is pending trial before the learned court D. I. Khan.\
- v. That the mandate of the Law for the purpose of the termination of the civil servant as provided in the KP Government servants (Efficiency & Discipline) Rules 2011, has not been fulfilled and as such the impugned office order are squarely illegal, unlawful and are without any legal backing. Thus, the same are not warranted under the law.
- vi. That the appellant has not been given a fair chance to defend his valuable rights rather he was condemned un-heard. Even no proper inquiry was conducted into the matter nor any proper legal procedure had been adopted before issuing the impugned Office Order dated 03.06.2020. Hence, a great injustice has been done to the Appellant.
- vii. That it is now settled that if a civil servant has a transparent service record then at the time of the awarding any penalty during departmental proceedings, his previous service record should be kept in mind.
- viii. That the impugned office order is based on malafide and the appellant has not been treated in accordance with the relevant law & record. There is flagrant violation of the law & rules dealing the matters pertaining to the civil servants and no proper procedure as provided under the law governing matters of civil servants, was adopted.

That the impugned orders are hit by the doctrine of audi alteram partem which are thus liable to be set aside.

x. That the counsel for appellant may be allowed to raise additional grounds at the time of hearing.



- 2. That the appeal is bad for misjoinder/nor-joinder of necessary parties.
- 3. That the appeal is badly barred by law & imitation.
- 4. That the appellant has not come to the Honourable Tribunal with clean hands.
- 5. That the appellant is estopped due to his own conduct.
- 6. That the appellant has concealed the material facts from the Honourable Tribunal.
- 7. That the instant appeal is badly time barred.
- 8. That the instant appeal is not maintainable in its present form.

REPLY ON FACTS

- 1. Correct to the extent that the appellant was enlisted in police department on 05.01.2011.
- 2. Correct to the extent that during the posting of appellant at Police Lines DIKhan, a criminal case vide FIR No. 505 dated 24.04.2020 U/S 118 Police Act, 2017 Police Station Cantt DIKhan was registered against him. Moreover, the appellant was also involved in two others criminal cases vide FIRs No. 1033 dated 06.09.2020 u/s 324/353/7ATA/474/448/15AA/186/148/149 PPC and FIR No. 1120 dated 17.09.2020 u/s 452/506/186/427/34 PPC PS registered at Police Station Cantt DIKhan. (Copy Annexed "A1, A2, A3")
- Correct to the extent that on the above misconduct, a charge sheet alongwith statement of allegation was served upon him in accordance with law/rules. (Copy <u>Annexed "B"</u>)

Incorrect. A departmental inquiry was conducted wherein he was found guilty and was awarded major punishment of dismissal from service vide OB No. 1253, dated 03.06.2020.

5. Incorrect. The appellant knew about it and he filed a departmental appeal and same was rejected by the Regional Police Officer, DIKhan (Respondent No. 3) on cogent reasons. Similarly, he was also involved in two criminal cases vide FIRs No. 1033 dated 06.09.2020 u/s 324/353/7ATA/474/448/15AA/186/148/149 PPC and FIR No. 1120 dated 17.09.2020 u/s 452/506/186/427/34 PPC PS registered at Police Station Cantt DIKhan.

6. Incorrect. That the instant Service Appeal is not maintainable on the following grounds.

REPLY ON GROUNDS

- Incorrect. The allegation of misconduct was proved against him, hence the order passed by Respondent No. 04 (DPO DIKhan) vide OB No. 1253, dated 03.06.2020 is legal, lawful, based on facts and in accordance with law/rules.
- 2. Incorrect. The appellant was involved in immoral/illegal activities and is addicted to drinking. Moreover, there are several complaints to the local police that the appellant organize drinking parties and selling drugs. His immoral activities have brought a bad name to the police department. A case to this effect vide FIR No. 505 dated 24.04.2020 u/s 118 Police Act, 2017 was registered against him at PS/Cantt DIKhan.
- 3. Incorrect. Criminal and departmental proceedings can run parallel side by side.
- 4. Pertains to record of Honourable trial Court needs no comments.
- 5. Incorrect. All the codal formalities were observed, hence the impugned order was passed in accordance with law/rules.
- 6. Incorrect. Ample opportunity of defence including personal hearing was provided to appellant but he failed to advance any plausible explanation in his defence.
- 7. As far as the previous service record of appellant is concerned, it reveals following bad entries in short term of service.



ORDER

This order is aimed to dispose of the departmental appeal of <u>Ex-Constable Arshad No.1378</u> of District Police DIKhan against the order of major punishment of Dismissal from service by DPO DIKhan vide his office OB No. 1253 dated 03.06.2020, on the following allegations:
