4. That on 1.04.2017 the said Department has promoted the several junior employees then the Appellant, but Petitioner was not considered by the Respondents due to suspension from his service. the Appellant after his reinstatement of his service being senior most employee made several oral/written requests to the Respondents to promote him from 01.04.2017 but the Respondents paid no heed to the request of the Appellant. Copies of application , office order dated 01.03.2017 and Seniority list are enclosed as **Annexure-D,E &F respectively.**
5.
