

1. Learned counsel for the appellant present and heard.

2. This application is for restoration of appeal dismissed in default vide order dated 16.12.2021. It appears that on 25.10.2021, the matter was fixed before the Tribunal at camp court D.I.Khan and was adjourned to 16.12.2021 on the request of appellant. On 16.12.2021, neither the appellant nor his counsel put appearance before the Tribunal and the appeal was dismissed in default due to non-appearance of the appellant and his counsel.
