

PRAYER: -

On acceptance of the instant Service Appeal, the impugned seniority lists dated 01.01.2006 and 31.12.2011 may please be set aside and the respondents may graciously be directed to prepare the seniority list keeping in view the entries of seniority list dated 30.04.2004 and by promoting the appellant w.e.f. 2006, the appellant may also be granted promotion back benefits or any other order or relief as this Honourable Tribunal deems fit and appropriate in the circumstances of the case, may also be issued/passed.

Respectfully Sheweth!

1. That, the appellant is a bonafide resident of District Mansehra who was initially appointed on 23.08.1978 through order No.6 as Forester.

(Copy of the appointment order is annexed as annexure "A").

2. That, the appellant was working in (SFDP) Mansehra of Siran Kaghan Forestry Project Abbottabad and transferred in Working Plan unit-V NWFP/KPK, Forestry pre-investment/FMC on 11.01.1996 through office order No.47.

(Copy of the officer order is annexed as annexure "B").

3. That, the respondents prepared initially seniority list in the year 2004 and as per the entries of the said seniority list, the appellant was shown at S.No.2.

(Copy of the seniority list of 2004 is annexed as annexure "C").

4. That, in the year 2006, the respondents again prepared the seniority list but illegally and wrongly placed the appellant at S.No.101 instead of serial No.4 without any reason whereas the appellant was the most senior than all.

(Copy of the seniority list of 2006 is annexed as annexure "D").

5. That, in the year 2011, the appellant was placed at S.No.75 while in column No.8, the date of appointment of the appellant was wrongly and illegally shown as 01.06.1994 instead of 23.08.1978.

(Copy of the seniority list of 2011 is annexed as annexure "E").

6. That, the appellant being aggrieved filed an appeal before the respondent No.2 on 22.11.2013.

(Copy of the appeal is annexed as annexure "F").

7. That, due correspondence was taken place in between the appellant and respondent but the respondents paid no heed to this effect and thus deprived the appellant from his legal and legitimate right.

Copy of the letter is annexed as annexure "G").

8. That, according to tentative seniority list of 2015, the appellant was placed at S.No.23.

(Copy of the tentative seniority list of 2015 is annexed as annexure "H").

9. That, the appellant again filed an appeal/reminder before the respondent No.2 for the correction of seniority list dated 31.03.2015.

(Copy of the appeal is annexed as annexure "I").

10. That, the respondents later on issued letter bearing No.2328-32 dated 16.02.2016 whereby the name of the appellant was nowhere exist for the purpose of promotion with the respondents whereas juniors than the appellant were included for the purpose of promotion and documents for promotion were also sought.

(Copy of the letter is annexed as annexure "J").

11. That, in the meanwhile, the inquiry officials of the respondents also conducted detailed and comprehensive inquiry in which the rights of the appellant were admitted by the respondents but despite that fact, no order for

promotion of the appellant was passed by the respondents nor the seniority lists were rectified by the respondents.

(Copy of the inquiry report is annexed as annexure "K").

12. That, the being aggrieved from the above stated position, the appellant initially filed a Writ Petition bearing No.295-A of 2016 before the Honourable Peshawar High Court, Bench Abbottabad which was later on entrusted to this Honourable Tribunal by way of Service Appeal No.1569/2018 which was listed before this Honourable Tribunal on 17.11.2021 and this Honourable Tribunal while permitted the appellant to withdraw his service appeal, allowed him to file fresh one on the basis of technical ground.

(Attested copies of order dated 17.11.2021 is annexed as annexure "L").

13. That, the appellant being aggrieved from the impugned seniority lists

prepared by the respondents and non-implementing the inquiry report by the respondents seeks the gracious indulgence of this Honourable Tribunal by way of instant Service Appeal, inter alia, on the following grounds: -

GROUNDS

- a. That, the acts of the respondents not meting out equal treatment of the appellant and non-treating the appellant in accordance with law are violation of articles 4 and 25 of the Constitution of Islamic Republic of Pakistan, 1973.
- b. That, the law enjoins a sacred duty upon all public functionaries to act in accordance with justice, equity, fair ply and good conscious. The act of the respondents in the matter in hand is an absolute disregard of the mandate of justice and fair play.
- c. That, admittedly, the appellant was appointed in the respondents'

department on 23.08.1978 hence the appellant being senior most was entitled for the appointment but the appellant has not been dealt with in accordance with law, rules and regulations rather the offices who were junior than the appellant have been promoted by the respondents in a sheer malafide manner.

- d. That, the inquiry officers of the respondents' department duly probed in the matter by way of detailed and comprehensive inquiry and it was found that the legal and legitimate rights of the appellant have been infringed by the respondents and after receiving the inquiry report, it was incumbent upon the respondents to promote the petitioner and also to pay all promotion back benefits to the appellant but despite clear cut findings of the inquiry officers, the respondents have not treated the appellant in accordance with law hence the valuable rights of the appellant have been infringed by the respondents.

- e. That, in the seniority list of 2004; the appellant has been placed at S.No.2 whereas the appellant was later on thrashed at bottom of the seniority lists later on prepared by the respondents without any legal, lawful and justified reasons.
- f. That, the promotion of the appellant was done, but due to intentional pre-planned malafide delaying tactics of the respondents, the appellant was deprived from his fundamental rights.
- g. That, the acts of the respondents and conduct of the respondents in the wake of whatever is stated above and the law, natural justice and fair play on the subject is colourable exercise of the authority tainted with malafide and alien to the concept of rule of law and duties of public functionaries.
- h. That, the respondents were bound to consider and decide the case of the appellant but they did not do so.
- i. That, the appellant has also been retired from service whereas as per

law, rules and regulations, the appellant is entitled for the promotion and all back benefits in this regard.

It is, therefore, most humbly prayed that on acceptance of the instant Service Appeal, the impugned seniority lists dated 01.01.2006 and 31.12.2011 may please be set aside and the respondents may graciously be directed to prepare the seniority list keeping in view the entries of seniority list dated 30.04.2004 and by promoting the appellant w.e.f. 2006, the appellant may also be granted promotion back benefits or any other order or relief as this Honourable Tribunal deems fit and appropriate in the circumstances of the case, may also be issued/passed.

Background of the Case

One Mr. Mukhtiar Ahmed, D/R posted in Working Plan Unit No. V, Manshra (resident of village Katha Dobandi, P/O Garhi Habibullah, Tensil and District Manshra) basically appointed as Forester in Hazara Forestry Pre-investment Project Manshra (HFPIM) purely on temporary basis vide Notification number SOK VII-1-G/66 dated 17/8/1978.

Hazara Pre-investment Project Terminated and consequently that staff re-adjusted in Siran Forestry Development Project later on the said forester was transferred to Working Plan Unit No. V, Manshra vide Office Order No. 47 dated 11-01-1996 issued by the Chief Conservator of Forests Territorial/Conservation Khyber Pakhtunkhwa Peshawar.

Later on during 2004 the synopsis of said forester asked for by the Conservator of Forests/PD Forestry Management Centre, Peshawar and consequently the Seniority list of Forester in respect of Foresters in Working Plan Circle Peshawar standing on 30-4-2004 was circulated in which the appellant Forester i.e. Mr. Mukhtiar Ahmed, Fr stood at Sr. No. 2 amongs 29 foresters in which 4 were in BPS-9 and 25 were in BPS-7 during 2006 in combined seniority list of Working Plan and Southern Circle Peshawar and whereas the same seniority list was circulated on 1-1-2006 wherein the appellant forester was kept at Sr. No. 101 deliberately similarly at Sr. No. 22 to Sr. No. 122 all foresters were in BPS-7 but the said forester placed after 78 forester of BPS-7. This situation deprived the appellant who preferred appeal in different forums.

Conclusion:

After Scrutiny of record and seniority list as stood on 30-4-2004 and as on 1-1-2006 it is clear that the appellant forester should had been at Sr. No. 4 in combined list instead at Sr. No. 101.

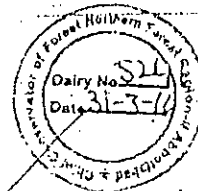

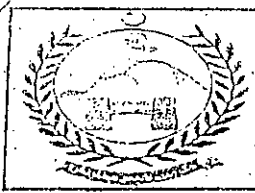

The undersigned is directed to say that the Honorable Supreme Court of Pakistan had passed judgment on 12-6-2013 on the subject petitions clubbed with a number of other petitions and had ordered that a copy of this judgment be sent to all the Chief Secretaries of the Provinces as well as the Establishment Secretary with the direction to streamline the service structure of civil servants in line with principles laid down in this judgment.

It was expected that afore-mentioned judgment was downloaded by all Ministries/Divisions for compliance. However, for the sake of convenience, the following guidelines/principles are highlighted: -

The Honourable Court has declared the following practices as illegal:-

(i) A civil servant, who after passing the competitive exam in terms of the recruitment rules, is appointed on merits, loses his right to be considered for promotion, when an employee from any other organization is absorbed without competing or undertaking competitive process with the backdated seniority and is conferred the status of a civil servant in complete disregard of recruitment rules:

ii. Absorption of a non Civil Servant conferring on him status of a Civil Servant and likewise absorption of a Civil Servant from non cadre post to cadre post without undertaking the competitive process under the recruitment rules.

iii. Introduction of any validation law in the nature of multiple or parallel legislation on the subject of service law.

iv. Conferral of seniority since 1994, with or without backdated seniority.

- (v) The re-employment / rehiring of the retired Civil / Government Servants being violative of the constitution are declared nullity.

The Apex Court has further held that: -

- (a) No non-civil servant can be transferred and appointed by way of deputation to any cadre. The procedure provided under Esta Code has been approved by this Court in the case of Mohammad Arshad Sultan.
- (b) No civil servant of a non-cadre post can be transferred out of cadre to be absorbed to a cadre post which is meant for recruitment through competitive process.
- (c) The procedure provided under ESTACODE requires that a person who is transferred and appointed on deputation must be a govt servant and such transfer should be made through the process of selection. The borrowing Govt has to establish the exigency in the first place and then the person who is being transferred/ placed on deputation in Govt must have matching qualification, expertise in the field with required experience.
- (d) An employee holding a post under any authority or corporation, body or organization established by or under any Provincial or Federal law or which is owned or controlled by Federal or Provincial Government or in which Federal Government or Provincial Government has controlling share or interest, could not conferred status of a civil servant.
- (e) It is settled principle of law that if the right of promotion is not blocked by re-employment then such powers can be exercised, then too in exceptional cases for a definite period. Besides it violates the fundamental rights of the serving civil servants, on account of such rehiring on contract are deprived of their legitimate expectancy of promotion to a higher cadre, which is violative of the provisions of Articles 4, 9 and 25 of the Constitution.
- (f) The absorption and out of turn promotion will also impinge on the self respect and dignity of the civil servants, who will be forced to work under their rapidly and unduly promoted fellow officers, those who have been inducted from other services / cadres regardless of their (inductees) merit and results in the competitive exams (if they have appeared for exam at all), hence are violative of Article 14 of the Constitution.
- (g) Principle of locus poenitentiae is the power of receding till a decisive step is taken but it is not a principle of law that order once passed becomes irrevocable and past and closed transaction. If the order is illegal then perpetual rights cannot be based on the basis of an illegal order.

(h) Any backdated seniority cannot be granted to any absorbee and his inter-seniority, on absorption in the cadre shall be maintained at the bottom as provided under the Rules regulating the seniority.



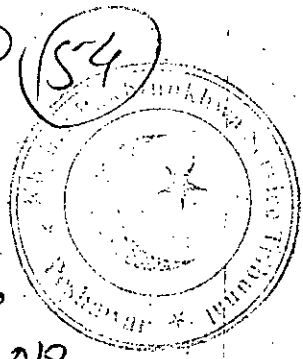

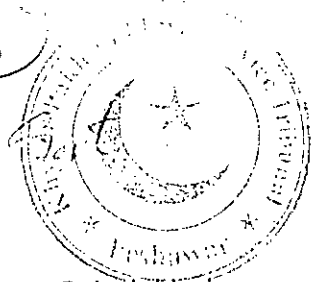

Counsel for the appellant and Mr. Muhammad Riaz Khan Paindakhel, Asstt. AG Allah Dad, Senior Clerk for the respondents present.

The appellant originally filed a Writ Petition for redressal of his grievance but the same for want of jurisdiction was converted into service appeal and sent to this Tribunal. Having heard the counsel for appellant at certain length, a proposition has developed that the prayer for relief as set in the Writ Petition being technically not efficacious is not workable for correction of the seniority of the appellant when the underlying seniority list has not been challenged in the appeal. Due to said deficiency, the appeal of the appellant is likely to face on a technical ground which may not meet to the ends of justice when the appellant has pursued the present appeal for a long time. Learned counsel for the appellant agreed with the proposition and requested for withdrawal of the appeal with permission to file the fresh appeal to challenge the seniority list and to seek consequential benefits. 

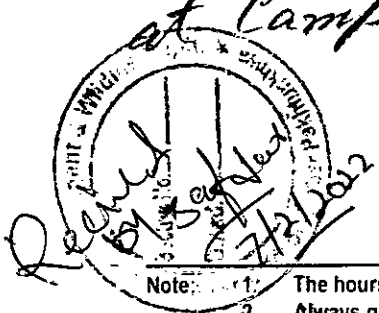
