APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNALS ACT, 1974 AGAINST THE IMPUGNED SENIORITY LIST DATED 31.12.2019, WHICH WAS NOT PREPARED ACCORDING TO LAW AND RULES AND AGAINST REJECTION ORDER DATED 15.12.2020 AND COMMUNICATION LETTER DATED 20.01.2020 WHEREBY THE DEPARTMENTAL APPEAL OF THE APPELLANT WAS REJECTED FOR NO GOOD GROUNDS.

PRAYER

ON THE ACCEPTANCE OF THIS APPEAL, THE RESPONDENTS MAY PLEASE BE DIRECTED TO CORRECT THE IMPUGNED SENIORITY LIST DATED 31.12.2019, ACCORDING TO LAW AND RULE, AND AS PER JUDGMENT OF SUPERIOR COURT, AND MAY BE DECLARE APPELLANT SENIOR TO PRIVATE RESPONDENT NO. 4 TO 12 AND PLACED AT PROPER PLACED I.E. S.NO: 26 INSTEAD OF S.NO: 36. ANY OTHER REMEDY WITH THIS AUGUST TRIBUNAL DEEMS FIT AND PROPER MAY ALSO BE AWARDED THE FAVOR OF THE APPELLANT.

FACTS

1. That the appellant is serving as Patwari in revenue deptt and performing his duties up to entire satisfaction of his superior and till date no complaint has been filed against the appellant.
2. That in year 2003 appellant appeared in patwar School exam along with other colleagues and passed the exam by the appellant by securing score of 421 and private respondent secure score less than the appellant. **Copy of result is attached as annexure-A.**
3. That on passing exam of patwar the order dated 24.11.2003 was issued whereby the name of appellant and private respondents was enlisted in patwar candidates register but with the condition that no candidate shall claim the seniority on the basis of this order sequence. Thereafter, appointment order dated 18.03.2004 was issued whereby the appellant and private respondents has been appointed in the same sequence as per order dated 24.11.2003. **copy of enlistment order and appointment order is attached as annexure-b & C.**
4. That before 2018 no seniority list was circulated if any the appellant have no knowledge about the same. Firstly 2018 seniority list came into the knowledge of the appellant wherein appellant was placed junior to the private respondent in violation of law and rules on which appellant properly submitted objection. **Copy of 2018 seniority list and objection application is attached as annexure-D & E.**
5. That another tentative and final seniority list has been issued on 31.12.2019 wherein appellant was placed at s.no 36 and shown junior to the private respondent irrespective of the fact that the appellant was secured higher marks than the private respondents. It is further added that all other employees was placed in seniority list with respect to their merit (secured marks). The appellant aggrieved filed departmental appeal for correction of the seniority list. In response to appeal deptt: issued letter dated 17.06.2020 to appellant for providing record which was properly provided by the appellant vide reply dated 19.06.2020. **Copy of 2019 tentative and final seniority list, departmental appeal, letter dated 17.06.2020 and reply dated 19.06.2020 is attached as annexure-F, G, H, I & j.**

6. That after receiving response from the appellant the DC Haripur wrote letter to secretary-1 of the Board of Revenue for guidance. In response the assistant secretary wrote letter to Dc for clarification why the appellant placed junior to the private respondent who secure less marks. In response DC Haripur wrote letter to Assistant secretary and explained the scenario. **Copy of letters is attached as annexure-K.**
7. That the assistant secretary in response of the letter dated 23.10.2020, wrote letter dated 15.12.2020 to DC Haripur and requested to direct the appellant knock the door of the competent court of law. Then DC Haripur communicated the same to the appellant in shape of rejection vide order dated 20.01.2020 for no good grounds without touching the merit of the appeal. **Copy of the letter dated 15.12.2020 and 20.01.2020 is attached as annexure-L & M.**
8. That the appellant come to this august tribunal on the following grounds amongst others.

GROUNDS

- A. That the rejection order dated 15.12.2020 and 20.01.2020 and the impugned seniority list is against the law, without lawful authority and against the spirit of the civil servant act and rule 17 of the APT rules 1989 thus calling interference of this learned tribunal.
- B. That the impugned seniority list is against the norms of service law and principles of natural justice and dictums of the apex courts.
- C. That in year 2003 appellant appeared in patwar School exam along with other colleagues and passed the exam by the appellant by securing score of 421 and private respondent secure score less than the appellant.
- D. That on passing exam of patwar the order dated 24.11.2003 was issued whereby the name of appellant and private respondents was enlisted in patwar candidates register but with the condition that no candidate shall claim the seniority on the basis of this order sequence. Thereafter, appointment order dated 18.03.2004 was issued whereby the appellant and private respondents has been appointed in the same sequence as per order dated 24.11.2003. and further seniority list was also issued on same sequence without any criteria in violation of section-8 of civil servant act 1973 and Rule-17 of APT Rules 1989.
- E. That tentative and final seniority list has been issued on 31.12.2019 wherein appellant was placed at s.no 36 and shown junior to the private respondent irrespective of the fact that the appellant was secured higher


marks than the private respondents. It is further added that all other employees was placed in seniority list with respect to their merit (secured marks), Which is evident from the seniority list and also from the patwar exam, register and appointment orders. Which is discriminatory and malafide. Hence the seniority list is liable to be modified. Copy of relevant document is attached as annexure-N.

- F. That the impugned seniority list is the worst example of favoritism, nepotism and colorful exercise of powers which is not warranted under law.
- G. That every seniority gave fresh cause of action and the appellant when know about the seniority challenge the same on the ground that the seniority issued discriminatory and against the norms of justice.
- H. That according to Section-8 of the Civil Servant Act 1973 and section-17 of APT Rules 1989, it is the legal right of every civil servant to properly placed in seniority list according to his seniority position, but the same benefits was not extended to the appellant which is the violation of law and rules.
- I. That the appellant was not treated according to the law and rules and has been deprived from his legal right of seniority in arbitrary manner without fault on his part.
- J. That the appellant craves permission of this honorable tribunal to rely on other grounds at the time of arguments and produce any additional document if required in support of instant service appeal.

It is therefore most humbly prayed that the appeal of the appellant may be accepted as prayed for.

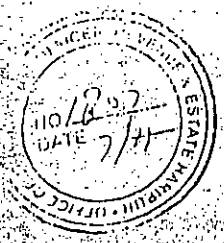

Detail in support of my claim is as under,

Brief :

I passed patwar exam from revenue academy Karak and result was notified by DLR Peshawar, K.P.K. No 3831-3854 dated 31-10-2003. According to this notification, Mr. Khanzada Khan secured 493 marks and stood 1st, Zameer Haider Shah with 440 marks 2nd, Zameer Afzal 434 3rd and I with 421 marks stood at 4th position in own district. Unluckily, beside Khanzada Khan, we three are not at proper place in tentative seniority list 2019 and this mistake is cause of my appeal.

Routine procedure/SOP for preparation of seniority list:

On receiving result notification from Director Land Record, District Officer (R&E)/Deputy Commissioner directs his staff by a notification to enlist the names of passed patwaris in the descending order of their marks obtained in patwar exam in candidates register. Entries of this register act as source for appointment As well as preparation of seniority list.

Unfortunately, this procedure/sop was not adopted with our badge. Interestingly, before and after our badge, same mechanism/sop applies/being applied but our names in enlistment register entered randomly, without considering SOP. Adopted approach deprived us from our proper place in cited list and is denial of fundamental rights.

R/Sir,

It is requested that my name may please be entered at proper place i.e., just after Khanzada Khan in seniority list 2019 and also correction be made in candidate register accordingly.

OFFICE ORDER.
