Respectfully Sheweth;-

That Facts forming the background of instant service appeal are arrayed as under;-

- That the appellant was appointed as a Constable in Police Department in July 2007.
- 2. That the appellant performed his duty in the Department to the satisfaction of his Superior as well as officer and length of service of the appellant till dismissal is 13 years.
- 3. That the appellant absent form his duties on 12/03/2019 to date of Dismissal due to illness of Shahtika and serious illness of his Mother, who Continuously remained under Treatment and she was admitted in various Hospital.

- 4. That the appellant during the period of absence alone was fully engaged with his Mother because there was no other Male Member to take care arranged the treatment.
- 5. That the appellant sent application for leave to Respondent No. 4 along with Medical Certificate Mother of appellant but Respondent No. 4 not intimated the appellant regarding non acceptance of leave application. Copy of Application is attached as Annexure "A".
- 6. That after recovery Mother of appellant he reported arrival on duty First in P.S Bakot and then in Police Line Abbottabad where the appellant handed over copy of charge sheet statement of allegation and order of dismissal from service on 21/04/2020. Copy of charge sheet statement of allegation and impugned order for Dismissal from service is attached as Annexure "B" "C" & "D".
- 7. That the appellant after receiving of impugned order Dismissal from service filed representation before respondent No. 3 and respondent No.3 reject the representation of the appellant without



hearing of the appellant on 07/07/2020. Copy of representation and order of respondent No.3 are annexed as Annexure "E" & "F".

- 8. That the appellant filed revision petition before respondent No.4 and respondent No.4 reject the revision of the appellant on 10/03/2021 but the order was communicated to appellant on 09/06/2021. Copy of revision petition and order is annexed as Annexure "G" & "H".
- 9. That the feeling aggrieved the instant appeal inter alia on the following grounds amongst other.

GROUNDS:

a) That the impugned order of dismissal from service was passed against the appellant without conduct of regular inquiry charge sheet final show cause notice personal hearing of the appellant thus impugned order against appellant is illegal, void, corum non-Judice and against the law and not sustainable under the law.

- That the appellant was entitled for same relief, which was given by the respondents to other Constable who was also discharge form his service on the basis of unauthorized absences and respondent No.3 on acceptance of representation reinstated other Constable in his service while representation of the appellant was rejected thus the Act of the respondentis malafide and discriminatory which is illegal and against the article 4 & 25 of the Constitution. Copies of reinstatement order of other Constable are annexed as Annexure "I" "J" "K" & "L".
- c) That according to the law respondents was duty bound to intimate the appellant regarding non acceptance of leave application but they were not intimated the appellant.
- d) That the punishment awarded to appellant without conduct of regular inquiry, which was against the provision of law and as such is not sustainable under the law.

e) That the respondents passed the impugned order against the appellant without considering of 13 years length of service and valid revision of illness. Thus not sustainable and liable to be set aside.

This is an order on the representation preferred by Ex-Constable Imitiaz Sultan No. 1342 of Abbottabad District against the order of discharge from service vide OB No. 149 dated 29-04-08.

The Enquiry file and service record of the appellant was perused minutely. He is a youngman and only source of livelihood for his poor family. He has submitted Medical Certificate for the said absence period duly verified by Deputy Medical Superintendent Ayub Teaching Hospital Abbottabad.

Therefore taking into consideration the above facts, I take lenient view of the matter, the order passed by the District Police Officer, Abbottabad vide OB No. 149 dated 29-04-08 is set aside on humanitarian grounds and he is re-instated in service from the date of his discharge. His period of absence and the period he remained out of service is treated as leave without pay. However he is reprinted to the last warning to remain careful in future.

This is an order on the representation of Ex-Constable Shahzeb No. 120 of Abbottabad District.

Facts leading to his discharge from service are that he while posted in Police Lines Abbottabad was caught red handed when carrying iron pipe from General Godown to his home dishonestly. He also absented himself from duty with effect from 02-05-2007 to 08-05-2007 i.e. 7 days.

The defaulter constable was proceeded against departmentally under removal from service (Special Power) Ordinance 2000 and DSP, Headquarters, Abbottabad held him responsible for the misconduct, therefore, District Police Officer, Abbottabad discharged him from service under PR-12-21, vide OB No. 204-A, dated 08-05-2007.

The enquiry file was perused, heard him in person in orderly room held in 113-117-2007. His explanation was found plausible. He is a young man and is a source of livelihood for his poor and miserable family.

Therefore taking into consideration the above facts. I take a lenient view The order passed by District Police Officer, Abbottabad, is set-a-side. He 18 re-instated in service from the date of his discharge. The period he remained out of . Service is treated as leave without pay.

He should be detailed for recruit course/ training immediately.
