APPEAL UNDER SECTION 4 OF THE KP SERVICE TRIBUNAL ACT, 1974 IMPUGNING THEREIN THE ORDER DATED 28.04.2021; WHEREIN MINOR PENALTY OF WITHHOLDING TWO ANNUAL INCREMENTS IS IMPOSED UPON THE APPELLANT: CONTRARY TO THE LAW AND JURISPRUDENCE

### **Respectfully Sheweth**,

- That the Constitution of Islamic Republic of Pakistan aims at protecting civil servants in order to ensure smooth running of affairs of the Government and Institutions so as to benefit the public citizenry.
- 2. The Constitution of Islamic Republic of Pakistan equally beshields civil servants from being treated otherwise than in accordance with law.

In Sheikh Riaz-ul-Haq's Case<sup>1</sup>, it was held that, "Admittedly, civil servants being citizens of Pakistan have

fundamental rights including the right to access to justice as envisaged under Article 9 of the Constitution".

3. That the Constitution of Islamic Republic of Pakistan evenly emphasizes on equality for the citizens and by the citizens; aimed at underpinning rule of law.

### ON FACTS

- 4. That the appellant while serving as Patwari Halqa Ghazi was served with a show-cause notice 20.04.2021 premised upon recommendations made and de-novo inquiry conducted dated 08.04.2021. (Copy of the show-cause notice dated 20.04.2021 along with relevant details are annexed as Annexure "A" and A-1).
- 5. That given the statement of allegations and show-cause coupled with reply dated 21.04.2021; minor penalty of withholding two annual increments was imposed upon the appellant. (Copy of the statement of allegations; reply dated 21.04.2021 and impugned order dated 28.04.2021 is annexed as Annexure "B" and "B-1")
- 6. That it is important to note that; the appellant has been performing as Patwari Halqa to the best of his abilities, determination and perseverance; to the entire satisfaction of the competent authority from the date of inception with impeccable service record in the respondent Department.
- 7. That for the sake of brevity and information; the appellant has preferred a departmental appeal dated 26.05.2021 which remains unattended till date. (Copy of the Departmental Appeal dated 26.05.2021 is annexed as Annexure "C")

In Suo Moto Case No. 19 of 2016<sup>2</sup>, it was held that, "Good governance was not a favour to be bestowed on the people; it was their right".

8. That the appellant beseechs for intervention of the Hon'ble Court given the impugned order 28.04.2021; inter-alia on the following grounds:-

### <u>GROUNDS</u>

- **A.**That the impugned order dated 28.04.2021; is uncalled for; contrary to law and well-settled jurisprudence.
- **B.** That the impugned order is issued without taking into consideration the relevant record; unblemished service career of the petitioner; malafide floating on the surface; as such the edifice built is liable to crumble down on that score alone.
- **C.** That treatment in dissonance with law/rules and jurisprudence smacks malice and ill-will on the part of respondent(s).
- **D.**That carte-blanche exercise of power; abdicates the wellentrenched principle of "structured discretion".
- E. That the purported omission(s) of non-disclosure of the relevant material; taking away right of cross-examination, on the part of respondent(s); itself speaks volumes engraving danger to the notion of good governance, hence requires interference of the Hon'ble Court.
- **F.** That the palpable omission(s) stands in violation of the law laid down by Hon'ble the Supreme Court of Pakistan.

In Qaiser Iqbal's Case<sup>3</sup>, it was held that, "Rule of Law meant supremacy of law as opposed to arbitrary authority of the Government; said supremacy guaranteed three concepts; first, the absence of arbitrary power; second, equality before law and third the rights of a citizen".

- **G.**That it is cardinal principle of law and justice that what cannot be done directly cannot be done indirectly.<sup>4</sup>
- **H.**That public functionary has to reinforce good governance, observe rules strictly and adhere to rule of law in public service; public functionaries were not obliged to follow illegal orders of higher authorities<sup>5</sup>.
- I. That "Expressio Unis Est Exclusio Alterius", commanding that when law requires a thing to be done in particular manner then, it should be done in that manner as anything done in conflict of the command of law shall be unlawful being prohibited.
- **J.** That "*Ignorantia juris non excusat"*, commanding that ignorance of the law excuses not.
- **K.**That further necessary grounds will be raised during the course of arguments.

### PRAYER

It is therefore humbly prayed that on acceptance of this Service Appeal: -

**1.** The impugned order dated 28.04.2021; allowing imposition of withholding two annual increments upon the



That in-spite of written as well as verbal warning by Assistant Commissioner, Ghazi you did not bother to comply with the instruction issued by visiting officer as the said person was again found present with same state during another surprise inspection on 07.01.2021. This act shows gross inefficiency and negligence on your part and tantamount to misconduct.

You are, therefore, directed to show cause as to why any of the minor penalties should not be imposed upon you. Furthermore, you are directed to appear on 21.04.2021 at 11:00am before the undersigned for personal hearing.

If no reply to this Notice is received within 07 days of its delivery, it shall be presumed that you have no defense to put in and, in that case, ex-parte action shall be taken against you.

#### **BACKGROUND.**

The undersigned was appointed as Inquiry Officer by the Competent Authority under Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules, 2011 vide Office letter No. 2328/P.E/HCR/DC(H) dated: 02-09-20219-03-2021 (Annexure-A) to investigate the charges / allegations against Mr. Ghulam Dastagir Ex- Patwari Halqa Ghazi, Tehsil Ghazi & District Haripur leveled against him in the Charge Sheet / Statement of Allegations.

i. That as per inspection report of Assistant Commissioner Ghazi vide letter No.PA/1-70/AC(G)/1420-23 dated 0-01-2021, a private person namely Sader Shah s/o Mardan Shah was found in Patwari office personating/ working as revenue official & dealing with general public in violation of the standing instructions of the Board of Revenue Khyber Pakhtunkhwa.(Annexure-B).

Consequently, he was warned by the inspection officer to mend his ways but he did not bother to comply with the instruction issued by Assistant Commissioner Ghazi as the Asaid person was again found present with same state during another surprise inspection. This act shows gross inefficiency and negligence on his part and tantamount to misconduct.

#### **PROCEEDINGS:**

In order to probe the above charges / allegations, the undersigned (Inquiry Officer) summoned Mr. Ghulam Dastaghir Ex- Patwari Halqa Ghazi, Tehsil Ghazi & District Haripur and private person namely Mr. Sader Shah s/o Mardan Shah r/o Sheikh Chor p/o Mian Dheri, Tehsil Ghazi & District Haripur, for personal hearing on 01-04-2021. Statements of Assistant Commissioner Ghazi and Tehsildar Ghazi have been also been recorded and placed in file.

#### Statement of Assistant Commissioner Ghazi:

Assistant Commissioner Ghazi in his statement stated that he paid surprise/ inspection of Patwar Halqa Ghazi on 04-01-2021 and found that an unknown private person namely Sader Shah s/o Mardan Shah was dealing with the general public and working as an official instead of



Patwari. Assistant Commissioner Ghazi directed the Patwari Halqa to submit an explanation on the gross negligence and incompetence on 05-01-2021. However AC (G) conducted another inspection of Patwar office on 07-01-2021 and found the same violation being repeated with Sader Shah acting as an official. (Annexure- C).

#### <u>Statement of Tehsildar Ghazi:</u>

Tehsildar Ghazi expressed his complete satisfaction with the accused regarding fulfilment of his official duties as well as his conduct. Tehsildar (G) stated that he did not receive any complaint regarding private person working with accused. (Annexure-D).

#### Statement of Mr. Ghulam Dastagir Ex- Patwari Halqa Ghazi:

According to the written statement of Mr. Ghulam Dastagir Ex- Patwari Halqa Ghazi, has denied all the allegations and stated that Assistant Commissioner Ghazi paid surprise visits to his Patwar Halqa Ghazi on 04-01-2021 and 07-01-2021, at the time of visit Patwari was present in the his Patwar Khana and some visitors/landlords were also present. Mr. Sader Shah s/o Mardan Shah was also present alongwith some landlords. AC (G) directed/ ordered Sader Shah to leave the Patwar Khana and also took office key. He also stated that during the visits AC (G) did not express any concern neither did he receive written explanation order till 11-01-20 21 whereby he was informed that he has been suspended. Patwari Halqa further pleaded for exoneration from the charges levelled against him in the above mentioned view. (Annexure-E).

#### Statement of Mr. Sader Shah (Private Person):-

Mr. Sader Shah s/o Mardan Shah r/o Sheikh Chor p/o Main Dheri in his statement stated that being a trainee at Bar Council Haripur he deals with general public in various cases. He visits offices for resolution of different issues faced by public including Patwar Khanas. On the inspection dates he was there with his clients regarding some civil suit nonetheless he has no connection with Patwar Halqa. (Annexure-F).

#### **Findings:**

During the course of inquiry, the following findings surfaced as a result of the personal hearing, perusal of written statements and relevant record.

- During AC (G) surprise visit to Patwar Halqa Ghazi private person Sader Shah s/o Mardan Shah
  was present alongwith others and Patwari Halqa dated 04-01-2021 and 07-01-202.
- Although AC (G) issued written explanation as well as verbal warning to Patwari Halqa to abstain from involving private person dealing with public instead of him still in his next surprise visit within 03 days, the same private person was in Patwari Halqa office dealing as an official.
- Written explanation was issued on the very next day of first surprise visit. However, Patwari Halqa has denied receiving the same and hence, being unaware of any explanation/ warning/displeasure of AC (G).
  - Tehsildar (G) has expressed full satisfaction regarding discipline and indent of Patwar Halqa.

### Conclusion:-

- 1. In view of the above findings it has been deduced that private person namely Sader Shah s/o Mardan Shah was present in the Patwar Halqa Ghazi office during the surprise visits of AC (G) date 04-01-2021 and 07-01-2021. In-spite of written as well as verbal warning by AC (G) same person was found working in Patwar Halqa Office.
- 2. Therefore, the Patwari Halqa has been found inefficient hence, it is recommended that Minor Penalty of holding annual increments for the period of 03 years as per rule 4(a) (ii) of Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) rules 2011, may be imposed on the Patwari so that such like practices may be desisted in future.

WHEREAS, Mr. Ghulam Dastagir Ex-Patwari Halqa Ghazi was suspended from service in pursuant to the recommendations of Assistant Commissioner, Ghazi submitted vide Inspection report bearing No. PA/1-70/AC(G)/1420-23 dated 07.01.2021 on the charges of repeated presence of a private person namely Sader Shah S/o Mardan Shah in his Patwar office personating / working as revenue official & dealing with general public despite strict warning issued to him by Assistant Commissioner, Ghazi.

AND WHEREAS, Assistant Commissioner Haripur was appointed as Inquiry Officer to conduct inquiry into the aforesaid charges / allegations and to submit his report. The Inquiry Officer has submitted his report vide No. Inquiry/2030/AC(H) dated 04.02.2021. After perusing the inquiry report it was deemed expedient to order De-novo Inquiry against the accused official. ### BACKGROUND.

The undersigned was appointed as Inquiry Officer by the Competent Authority under Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules, 2011 vide Office letter No. 2328/P.E/HCR/DC(H) dated: 02-09-20219-03-2021 (Annexure-A) to investigate the charges / allegations against Mr. Ghulam Dastagir Ex- Patwari Halqa Ghazi, Tehsil Ghazi & District Haripur leveled against him in the Charge Sheet / Statement of Allegations.

vide report of Assistant Commissioner Ghazi letter No.PA/1-70/AC(G)/1420-23 dated 0-01-2021, a private person namely i. Sader Shah s/o Mardan Shah was found in Patwari office personating/ working as revenue official & dealing with general public in violation of the standing instructions

of the Board of Revenue Khyber Pakhtunkhwa.(Annexure-B). Consequently, he was warned by the inspection officer to mend his ways but he did not bother to comply with the instruction issued by Assistant Commissioner Ghazi as the Nsaid person was again found present with same state during another surprise inspection. This act shows gross inefficiency and negligence on his part and tantamount to misconduct.

### PROCEEDINGS:

In order to probe the above charges / allegations, the undersigned (Inquiry Officer) summoned Mr. Ghulam Dastaghir Ex- Patwari Halqa Ghazi, Tehsil Ghazi & District Haripur and private person namely Mr. Sader Shah s/o Mardan Shah r/o Sheikh Chor p/o Mian Dheri. Tehsil Ghazi & District Haripur, for personal hearing on 01-04-2021. Statements of Assistant Commissioner Ghazi and Tehsildar Ghazi have been also been recorded and placed in file.

Statement of Assistant Commissioner Ghazi:

Assistant Commissioner Ghazi in his statement stated that he paid surprise/ inspection of Patwar Halqa Ghazi on 04-01-2021 and found that an unknown private person namely Sader Shah s/o Mardan Shah was dealing with the general public and working as an official instead of Patwari. Assistant Commissioner Ghazi directed the Patwari Halqa to submit an explanation on the gross negligence and incompetence on 05-01-2021. However AC (G) conducted another inspection of Patwar office on 07-01-2021 and found the same violation being repeated with Sader Shah acting as an official. (Annexure- C).

#### Statement of Tehsildar Ghazi:

Tehsildar Ghazi expressed his complete satisfaction with the accused regarding fulfilment of his official duties as well as his conduct. Tehsildar (G) stated that he did not receive any complaint regarding private person working with accused. (Annexure-D).

#### Statement of Mr. Ghulam Dastagir Ex- Patwari Halqa Ghazi:

According to the written statement of Mr. Ghulam Dastagir Ex- Patwari Halqa Ghazi, has denied all the allegations and stated that Assistant Commissioner Ghazi paid surprise visits to his Patwar Halqa Ghazi on 04-01-2021 and 07-01-2021, at the time of visit Patwari was present in the his Patwar Khana and some visitors/ landlords were also present. Mr. Sader Shah s/o Mardan Shah was also present alongwith some landlords. AC (G) directed/ ordered Sader Shah to leave the Patwar Khana and also took office key. He also stated that during the visits AC (G) did not express any concern neither did he receive written explanation order till 11-01-20 21 whereby he was informed that he has been suspended. Patwari Halqa further pleaded for exoneration from the charges levelled against him in the above mentioned view. (Annexure-E).

#### Statement of Mr. Sader Shah (Private Person):-

Mr. Sader Shah s/o Mardan Shah r/o Sheikh Chor p/o Main Dheri in his statement stated that being a trainee at Bar Council Haripur he deals with general public in various cases. He visits offices for resolution of different issues faced by public including Patwar Khanas. On the inspection dates he was there with his clients regarding some civil suit nonetheless he has no connection with Patwar Halqa. (Annexure-F).

#### Findings:

During the course of inquiry, the following findings surfaced as a result of the personal hearing, perusal of written statements and relevant record.

- During AC (G) surprise visit to Patwar Halqa Ghazi private person Sader Shah s/o Mardan Shah was present alongwith others and Patwari Halqa dated 04-01-2021 and 07-01-202.
- Although AC (G) issued written explanation as well as verbal warning to Patwari Halqa to abstain from involving private person dealing with public instead of him still in his next surprise visit within 03 days, the same private person was in Patwari Halqa office dealing as an official.
- Written explanation was issued on the very next day of first surprise visit. However, Patwari Halqa has denied receiving the same and hence, being unaware of any explanation warning/displeasure of AC (G).

Tehsildar (G) has expressed full satisfaction regarding discipline and indent of Patwar Halqa.

### Conclusion:-

- 1. In view of the above findings it has been deduced that private person namely Sader Shah s/o Mardan Shah was present in the Patwar Halqa Ghazi office during the surprise visits of AC (G) date 04-01-2021 and 07-01-2021. In-spite of written as well as verbal warning by AC (G) same person was found working in Patwar Halqa Office.
- 2. Therefore, the Patwari Halqa has been found inefficient hence, it is recommended that **Minor Penalty** of **holding annual increments** for the period of **03 years** as per rule 4(a) (ii) of Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) rules 2011, may be imposed on the Patwari so that such like practices may be desisted in future.


