It was further contended that neither proper inquiry was conducted nor appellant was associated in the inquiry proceeding nor opportunity of personal hearing and defence was provided to the appellant therefore, the appellant was condemned unheard. It was further contended that the departmental authority was required to mention specific period of withholding of two increments but the respondent/department has not mentioned any specific period under FR-29 therefore, the impugned
