



Reply on pre-admission notice has not been submitted. The appellant among other relief sought, has also opted for compulsory retirement as a matter of relief. At page 13 of the appeal file, there is an order of District Education Officer (M) Dir Lower (respondent No. 2) wherein, it has been affirmed that the appellant remained in service of the department w.e.f. 11.05.1983 to 25.09.2001. It is also mentioned in the said order that he remained absent from duty w.e.f. 26.09.2001 as confessed by him. However, the order of respondent No. 2 is silent as to whether any action under due course was taken against the appellant on account of that absence or not. On one side there is an admitted absence from duty of the appellant and on the other side there is omission of taking lawful disciplinary action. When the appellant has opted for compulsory retirement having on his credit the length of service shortly less than 20 years, let the respondent No. 2 come up with leave account and service record of the appellant so as to see whether any leave is available for the appellant or not for meeting the shortage of petitioner's service in 20 years. 


