



This office order will dispose off the departmental enquiry proceeding against Constable Munir No. 111 who was proceeded against departmentally with the allegation that while he was posted in summons/warrants branch, Session Court Mansehra was involved himself in case FIR No. 83 dated 16-02-2020 u/s 324 PPC PS Garhi Habibullah vide Superintendent of Police, Investigation, Mansehra letter No. 1282/Inv: dated 19-02-2020.

The Enquiry Officer i.e. Mr. Ajmal Khan Inspector RI Mansehra after conducting proper departmental enquiry has submitted his report stating therein that, I being enquiry officer came to the conclusion that the allegation leveled on the basis of which alleged Constable Munir No. 111 was Charge Sheeted based on facts and proved, hence he is recommended for some suitable punishment.

On 21-04-2020 the delinquent Constable Munir No. 111 was heard in person but he could not convince the undersigned in his defense.

I, the District Police Officer, Mansehra, therefore award major punishment of "dismissal from service" to the delinquent Constable Munir No. 111 under Khyber Pakhtunkhawa Police, Disciplinary Rules 1975 (amended in 2014).

#### **Respected Sir**,

The brief facts leading to the instant appeal are arrayed as follows: -

Aamir one of us was in possession of pistol who resorted to aerial firing and an empty stuck in the chamber. Aamir asked me to extract the empty and for that purpose handed over pistol to me and I extracted the empty from the chamber. In the meanwhile while putting magazine, the pistol went of accidentally and Aamir sustained injuries on his person. He was to KATH Mansehra rushed and thereafter referred to Abbottabad. It altogether а vismajor or was visdivina that the pistol went of and Aamir sustained injuries.

That, we all were/are fast friends since childhood and it was altogether an accidental act which was beyond the control of the appellant. The appellant while removing the empty and putting magazine in the pistol, the pistol went of and Aamir was hit. There was no mensrea nor any



intention rather it was an accidental act.

- 3) That, during the inquiry the statements of the other companions/ friends were recorded and according to their respective statements it was altogether an accidental affair where the intention or mensrea was lacking altogether.
- **4)** That, the said Aamir got his statement recorded wherein he entered into a compromise with the appellant and also submitted an affidavit in this respect.
- 5) That, from the entire resume it is quite crystal clear that this incident took place accidentally. There was/is no any intention, mensrea or motive.
- 6) That, during the inquiry after recording the statements of the witnesses the inquiry officer also gave his opinion that it was an accidental occurrence.

It is, therefore, most humbly prayed and requested that on acceptance of appeal the impugned order of dismissal may kindly be set-aside and the appellant may be reinstated in service.

#### <u>ORDER</u>

This order will dispose off departmental appeal under Rule 11-A of Khyber Pakhtunkhwa Police Rules, 1975 submitted by Ex. Constable Munir Nisar No.111 of District Mansehra against the order of punishment i.e. Dismissal from service awarded by District Police Officer, Mansehra vide OB No.93 dated 21.04.2020.

NO:

Brief facts leading to the punishment are that the appellant while posted at summon/warrants branch, Session Court Mansehra involved himself in a criminal case FIR No. 83 dated 16-02-2020 u/s 324 PPC PS Ghari Habibullah.

The appellant was issued charge sheet along with summary of allegations and RI Police Lines, Mansehra was deputed to conduct departmental enquiry. During the course of enquiry the allegations leveled against the appellant were proved and EO recommended him for suitable punishment. He was heard in person, however he failed to advance any cogent reason in his defence. Consequently, DPO Mansehra awarded him major punishment of dismissal from service.

After receiving his appeal, comments of DPO Manselira were sought and examined/perused. The Undersigned called the appellant, complainant of the case namely Aamir s/o Muhammad Javeed and eye witnesses in OR, heard them in person and examined the available record. The parties already entered into compromise while complete challan in the case has been subniitted to the court. Complainant of the case, during interview in OR also affirmed that the compromise has been affected with his free consent without any undue pressure. Therefore, keeping in view the above, I take lenient view and in exercise of the powers conferred upon the Undersigned under Rule 11-4 (c) of Khyber Pakhtunkhwa Police Rules, 1975 major punishment of Dismissal from service is set aside and converted into minor punishment of stoppage of 03 years increments with cumulative effect with immediate effect. The period during which the appellant remained out of service may be treated as leave without pay.
