16) W.E.F 13-3-2009, WHEN JUNIOR RESPONDENT NO.4 WAS PROMOTED AND TO PLACE HIS NAME IN THE SENIORITY LIST OF ASSISTANT OVER AND ABOVE THE NAME OF THE PRIVATE RESPONDENT WITH ALL BACK BENEFITS. ANY OTHER REMEDY WHICH THIS AUGUST TRIBUNAL DEEMS FIT AND APPROPRIATE THAT MAY ALSO BE AWARDED IN FAVOUR OF APPELLANT.

RESPECTFULLY SHEWETH:

FACTS:

1. That the appellant joined the Education Department as Junior Clerk on 24-10-1979. The appellant was further promoted as Senior Clerk on 24-2-1990 and further promoted to the post of Assistant on 28-5-2014. The appellant has more than "34" year Service at his credit with good record throughout. All the dates are recorded in the departmental appeal. (The copy of which is already attached as Annexure-C)
2. That the private respondent no.4 was appointed as Junior Clerk on 15-1-84 and was promoted as Senior Clerk on 25-5-1995. Further promoted to the post of Assistant on 13-3-2009. It is also worth to mention here that, the appellant was also senior in seniority list issued in the year 1995/1996, wherein appellant name is appearing in S.no 266, while the private respondent no.4 in S.no 691. (The copy of Seniority list is attached as Annexure "A")
3. That when the department issued the seniority list of Assistant (BPS-16) on 31-7-2015. There then the appellant come to know that the Junior Respondent No.4 was promoted as Assistant on 13-3-2009 by ignoring the appellant. The appellant forthwith filed departmental appeal on 27-8-2015 and waited for 90 days but that appeal was not responded and not decided despite the lapse of statutory period. (Copy of Seniority list of 2015 and departmental appeal are attached as Annexure-"B"&"C")

4. That now the appellant comes to this august Tribunal on the following grounds amongst others.


GROUNDS:

- A) That not antedating the promotion of appellant from the date (13-3-2009), when the junior private respondent no.4 was promoted and not deciding the departmental appeal of appellant in statutory period is against the law, facts and norms of justice and material on record.
- B) That the appellant was ignored and deprived from the date when he was eligible and entitled for promotion in an illegal manner and as such, such action on the part of respondent department is not sustainable in the eyes of law.
- C) That Valuable rights of the appellant have been affected by not granting him, his due promotion from the date of his actual entitlement.
- D) That the appellant is not treated according to law and rules and has been deprived from his due right and benefits of promotion in an arbitrary manner.
- E) That the Supreme Court held in many cases that though the Civil Servant could not claim promotion as matter of right but it was incumbent upon the department/Authority, that when they grant promotion, then in that case the promotion should be granted from the due date of Civil Servant / Availability of post. Thus the appellant is entitled to antedated promotion w.e.f 13-3-2009.
- F) That it is proved and evident from the record that the private respondent no.4 was junior to appellant as Junior Clerk & Senior Clerk but due to illegal favour to the private respondent no.4, the respondent No.4 was granted promotion as Assistant by , by passing


the appellant seniority. Thus appellant has been deprived from his due rights in illegal manner.

- G) That the appellant is legally entitled to the promotion as Assistant w.e.f 2009.
- H) That the appellant seeks permission to advance others grounds and proofs at the time of hearing.

It is, therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.
