



Service Appeal under Section 4 of the K.P Service Tribunal Act, 1973,
against the impugned office order No even and date ,18.8.2022 of the
Respondent whereby the Appellant is transferred from GGHSS Badwan
to GGHSS Panikhel , Kotkay Lower Dir against the law and policy with
immediate effect and her Appeal is kept pending till today without any
order over it .

Prayer:-

- A. On acceptance of this Appeal the impugned office order No- Nil
dated 18.8.2022 of the Respondent may kindly be set aside ,
be declared without lawful Authority and couple policy as well
as policy of the government towards female civil servant , with
no effect upon the rights of the Appellant. And the Appellant be
allowed to work in her school OR
- B. May be transferred to home district where new posts are
created.
- C. Any other relief which this Honourable Tribunal may deem just
in the circumstances.

Respectfully Sheweth: - The need for the instant Appeal before the Tribunal arises due to the following facts:

Facts:

1. That the Appellant was recruited by Executive District Officer (EDU) Malakand as a PTC teacher on contract basis in BPS -9 on 23.11.2002.
2. Then on the recommendation of Provincial Public service Commission was appointed female SET general BS-16 on 30.8.2005 and posted against the vacant post at Government Girls High School Talash Dir Lower.
3. Then on the recommendation of Departmental Promotion Committee was upgraded to Bs-17, on 10.11.2016, and was posted GGCMS No-1 Tarnaw Dir Lower.
4. Then on the recommendation of Departmental Promotion Committee was promoted On 14.11.2017 to the post of Subject Specialist BS-17 and was posted against the vacant post at GGHSS Badwan Dir Lower

(Copies of all orders are attached as Annexure A).

5. That the Appellant was transferred to home District on 19.9.2018 i.e. Government Girls High Secondary School Allah Dand Dehri Malakand but the influential used influence and the transfer order of the Appellant was withdrawn without allowing her to take charge but in the best interest of service discipline the appellant tolerated the injustice .

(Copy of the order is attached as Annexure B)

6. That all of sudden and without any summary or proposal the Respondent on the political interference and just making happy the concerned MPA transferred the Appellant on 18.8.2022 and adjusted her in Panikhel Kotkay . The interesting aspect of the transfer order is that it is with immediate effect.

(Copy of the impugned order is attached as Annexure C).

7. That the Appellant filed a representation and handed over it even by hand to the Respondent to withdraw the order as earlier such orders are withdrawn and even so many times prayed for reply on

the Representation but no reply is given so far and the Representation is hold with no order over it.

Being aggrieved and no other forum available under the law hence this Appeal is preferred before this Tribunal on the following grounds:

Grounds:-

- A. That the Appellant transfer by the authority is against law and Rules and without approval of summary, or giving any reason by the order issuing authority.
- B. The impugned order is void ab initio, this is without lawful authority, is arbitrary and is liable to be set aside and requires the interference of this honourable tribunal to declare it as such.
- C. That earlier the orders were issued but on the request of the transferees these were withdrawn but the order of the appellant is not withdrawn for reasons best known to them. This conduct of the Respondent is discriminatory and against the Constitution of the Country.
(Copy of such orders and its withdrawal is attached as Annexure E)
- D. The Appellant husband is serving at GSASHS No-1 Thana District Malakand as SCT BPS-16 but the appellant was not asking for transfer to home District as the School concerned was near to her home so the transfer of the Appellant to a far flung area of District Lower is against the couple policy of the Province.
(The service certificate is attached as Annexure F).
- E. That the Principal of the GGHSS Badwan has recommended the withdrawal of the impugned order as many other posts of subject Specialist are lying vacant in her school and the Appellant transfer may augment her problems.

(Copy of the vacant post is attached as Annexure G).

F. That the Appellant has a legitimate expectancy to be retained as her immediate boss is happy with her and she is satisfied with her performance.

G. That the Appellant husband is suffering from multiple diseases and the doctors has advised him proper care. The apex court in Pakistan while interpreting the Right to life has held that the female civil servant shall be posted near to her home so that she may take care of her children. Thus the transfer of the appellant to far away from home is against the judgment of the court and so is violation of Article 5 of the Constitution of Pakistan. New posts are created in the home District of the Appellant for which the Appellant may be considered by the Respondent.

H. That the mandate of Constitution of Islamic Republic of Pakistan is that every person shall be treated in accordance with law and no act shall be done which is detrimental to his health, body and property of a person.


I. That it is established Principle of law that When law permits an act to be done in a particular manner then that act must be done as such and not otherwise.

J. That Section 24-A of the General causes Act provides that the state functionaries must act fairly, justly and in transparent manner but it transpires that the act of the Respondent department is tainted malafide and is non transparent.

Therefore this Appeal may be accepted as prayed above.

Respectfully Sheweth:-


May this Honourable Tribunal be graciously kind enough to grant an Interim injunction in the form of above inter-alia on the following grounds:

- 8 Their services will be liable to terminate on one month's prior notice from either side. In case of resignation without prior notice their one-month pay/allowances, if any shall be forfeited to Govt.






Subject: Representation against the Impugned order No SO(S/E)E&SED/4-16/2022/Posting/Transfer/40 dated 18th August, 2022 whereby the petitioner is transferred from GGHS Badwan and adjusted at GGHS, Panikhel, Kotkay, Lower Dir.

Respected sir,

1. That the petitioner joined the department as PST, in 2002, and was posted GGPS Totar, Malakand, then after passing the commission examination for SST, was appointed and posted at GGHS Talash, Lower Dir. Needless to mention that the petitioner has a domicile of District Malakand.
2. That the petitioner served at GGCMS Tarnaw, Shaban, Dir Lower and was granted personal scale BPS-17, while posted at the same school.
3. That the petitioner is promoted on the basis of seniority and was posted at GGHS Badwan, in Pashto subject.
4. The Petitioner was transferred to GGHS Dheri Alladand, but the Department retained the other influential and even denied the petitioner to take charge. The school was near to the home town of the petitioner, but the unfair treatment of the Department compelled her to stay at Badwan. The petitioner avoided to challenge the order for paying respect to the officials.
5. That the unfair treatment did not stop here and now without any summary and proposal and even the time fixed by the provincial department the petitioner is again transferred which is unjust and unfair.

Being aggrieved hence this department appeal is preferred on the following grounds:

- A. That the order directed by your honor is smacked of arbitrariness and influence by the influential.
- B. That the sudden transfer of the petitioner ^{*transfer*} that the highly influential and political influence is the force behind it.
- C. That the constitution of Pakistan provide that every citizen shall be treated in accordance with law but the department has violated this in the petitioner case.
- D. That the husband of the petitioner is posted at Government Shahid Adil Shehzad, High school No. 1, Thana, which is near to GGHS Badwan, so as per couple policy the transfer of the petitioner is isolation of the policy which is framed and made by the department herself, keeping in view the right to family enshrined in the constitution of Pakistan.
- E. That the petitioner is suffering from diabetes with consequential diseases and severe lower back pain so any transfer from home town to such a long distance place is unjust.

Therefore, it is prayed that the impugned order may be withdrawn.
