JUDGMENT

ATIQ-UR-REHMAN WAZIR MEMBER (E):-

Brief facts of the case are that the appellant was appointed as Lecturer Statistics on 25-03-2010 at Government Girls Degree College(GGDC) Miran Shah, North Waziristan. During the course of her service, the appellant was transferred and posted at various colleges and lastly she performed her duty in GGDC Miran Shah from 01-01-2018 until 30-11-2020. The appellant filed numerous applications to respondents to transfer her to Peshawar under spouse policy, as her husband is also posted in Peshawar, but the respondents transferred her to GGDC Kohta Swabi vide impugned order dated 30-11-2020. Feeling aggrieved, the appellant filed departmental appeal dated 07-12-2020, which was not decided within the statutory period, hence the instant

service appeal with prayers that the impugned order dated 30-11-2020 may be set aside to the extent of the appellant being passed against the spouse policy and the appellant may be transferred to Peshawar under spouse policy as well as on humanitarian grounds.

02. Learned counsel for the appellant has contended that the impugned order dated 30-11-2020 is void ab-initio, as it has been passed against the transfer posting policy; that the appellant had already submitted so many application to respondents department as well as there is no hostel and water facilities at GGDC Kohta Swabi. That there is not a single student of Statistics at the GGDC Swabi; that during pendency of the departmental appeal, transfer orders dated 06-01-2021 and 20-01-2021 has been issued, whereby stance of the appellant has not been considered.

03. Learned Assistant Advocate General for respondents has contended that the appellant has filed numerous applications for her transfer to Peshawar, but since no vacant post was available in district Peshawar, hence she could not be transferred but her name was included in the list of placement committee; that under Section-10 of Khyber Pakhtunkhwa Civil Servants Act, 1973, a civil servant is liable to serve anywhere within or outside the province and it is not upon choice of the civil servant to be transferred to the posting of her choice.

04. We have heard learned counsel for the parties and have perused the record.

05. Record reveals that the appellant completed her tenure in GGDC Miran Shah, which is a hard area and had submitted numerous applications for her transfer to Peshawar under spouse policy, as her husband is a doctor and is serving in Peshawar. The respondents admitted to the fact that the appellant requested repeatedly for her transfer to Peshawar but she could not be transferred due to non-availability of vacancy in district Peshawar. On the contrary, we have observed

that during pendency of departmental appeal of the appellant, the respondents made two transfers vide order dated 06-01-2021 and 20-01-2021 in district Peshawar, which shows that respondents had not taken into consideration her genuine request.

06. We have also noted that child of the appellant, who is patient of fits (epileptic) and who was also presented before us, was a hardship case, as it would not be possible for the appellant to handle him without aide of her husband. The appellant had not claimed any vested right against any particular post but only wanted implementation of wedlock policy in her case and that too, due to compelling reason of illness of her child. Such policy was introduced keeping in view the socio-economic problems and hardships faced by husbands and wives in government service due to posting in different stations. Respondents are expected to ensure that unless there were insurmountable hurdles, requests of the husband and wife to be posted at one station were required to be considered with an element of compassion and kindness. Question of transfer/posting under Section-10 of Khyber Pakhtunkhwa Civil Servant Act, 1973, though fell within the domain of respondents, but such discretion had to be exercised judiciously and in accordance with settled norms of justice, equity and fair-play.

07. The instant appeal is disposed of on the above terms with direction to the respondents to consider transfer of the appellant to Peshawar under spouse policy as well as on humanitarian consideration on occurrence of vacancy in Peshawar on priority. Parties are left to bear their own costs. File be consigned to record room.
