Representative of the respondent No. 2 and 3 vehemently contended that vide order sheet dated 18.10.2021 they were exempted from implementation of the judgement of Service Tribunal dated 03.05.2017 on the ground that the matter pertains to reinstatement of the petitioner as well as back benefits are related to MTI (respondent No. 1) Chief Executive, Group of Teaching Hospital, Bannu. It was however pointed out that during the proceedings in the instant execution petition on 14.04.2012, the court was not properly assisted and concealment of facts made on part of the representative of department. It is observed that the reinstatement order bearing No. 1030/Estb/BMC/021 dated 16.11.2021 has been issued by respondent No. 1 and as such all back benefits of the petitioner would also be given by the said respondent. Moreover, it is also directed that order sheets dated 18.10.2021 as well as dated 05.01.2022 seem to have not been placed before the authority. Attested copies of both the order sheets be therefore provided to representative of respondent No. 1 to be placed before the authority for conclusive and final implementation of the Service Tribunal judgement dated 03.05.2017. To come up for implementation report on 06.07.2022 before S.B positively.


