In terms of normal procedure, the appeal appears to be barred but in view of particular legal position to be discussed herein-after, the bar of limitation for the time-being is immaterial. In wake of COVID, 19, the Government of Khyber Pakhtunkhwa for the first time declared Public Health Emergency in March, 2020 for three months which was extended from time to time for further term and presently it has been extended by the Government vide Notification No. SOG/HD/1-102/Covid-19/2020/3062, dated 30.06.2021 for the period 01.07.2021 to 30.09.2021. That the appellant was initially appointed in Live Stock Research Center at Balogram Swat in BPS-5 as Junior Clerk vide appointment order No.7616-22/DVRI/ESTB:II(13q)88 dated 25/10/1989, while promoted to Senior Clerk Post in BPS-7 2001 and promoted as office Assistant in BPS 16 at 2013. (Copies of First Appointment as annexure A, promotion to BPS-7 as annexure B and promotion to BPS-16 as annexure C).

That the appellant was transferred to Mansehra poultry research Institute at march 2019, it is pertinent to noted that feed tender was issue by respondent No.3 for the year of 2018 & 2019, it is to be noted that Farm Manager / respondent No.1 issue a letter dated 25/7/2019 for due / pending feeds on the part of contractor / Sarhad Trader to respondent No.3, on continuation of the above latter dated 25/7/2019, the respondent No.3 issue a letter to SARHAD Trader for out standing 36 feed Bages on dated 29/7/2019. (Copy of tender annexure D, copy of letter dated 25/7/2019 is annexure E, and dated 29/7/2019 is annexure F).

That on 28 June 2019 once again for the feed supply of 4800 KG order were issue to SARHAD Trader through Cheque payment. It is pertinent to be noted that the bills were already verified by respondent No.8 and the storekeeper had enter in stock register, and after all coddle formalities the payment was made as D.D.O (Drawing dispersing Officer), issued to M.S, Sarhad Traders. However, the SARHAD Trader deny from the supply of feed begs and return the paid money 2,80,000/- in cash to the storekeeper Arshad Iqbal, instead of Rs. 301937. The appellant due security and short payment of feed bags deposited the return / less amount to his own bank account. (Copy of Sarhad Trader is annexure G).

That on the basis of above mention letter the fact finding inquiry was conducted by respondents No.4,5, the respondent No.4 not heard the appellant nor visit the spot. In the whole inquiry the appellant remain condemned unheard, and the inquiry was based on their own whims, therefore, needed to be set aside to the extent of appellant. The competent officer / respondent did not issue charge sheet to appellant prior to an inquiry. The respondent No.4,5 submitted its inquiry report to respondent No.2 on 01/10/2019. In the conclusion of inquiry submitted to make recovery of 10.75 bags of poultry feed from appellant. (Copy of inquiry report is annexure H).



BACKGROUND:

In pursuance to the complaint lodged by Director Poultry Research Institute Jaaba Mansehra and fact finding inquiry report against Ahmad Khan Office Assistant (BPS-16) the competent authority constituted a formal inquiry committee vide Notification No.DG (R)/L&DD/E-II (169)/2018/Vol-IV/4136-4 dated 14/05/2019 (Annex-I) in order to probe in to the allegations levelled against the accused.

PROCEEDINGS:

The Inquiry Committee visited PRI Jaaba Mansehra on 03.032020 in order to probe in to the allegations levelled against Mr. Ahmed Khan Office Assistant PRI, Jaaba Mansehra, wherein Director PRI nominated Dr. Nagash Khalid Research Officer/DDO Departmental Representative to assist inquiry committee vide office order No. 21-01-2020 (Annex-II). PRI/Order F-47/2019-20/522-25 dated: Questioners were served to the following officers/ officials i.e Director PRI, DDO PRI, Farm Manager PRI and accused Mr. Ahmad Khan Office Assistant, most of the officers/ officials submit their replies along with necessary enclosures (Copy Annexed) as mentioned below against each to the inquiry committee on the same day. However, Director PRI submitted his reply late due to his health problem. The inquiry committee requested the DG(R) L&DD for provision of Personal file of Mr. Ahmad Khan Office Assistant and Fact finding Inquiry (Annex-III) which were provided by the Office superintendent establishment section along with fact finding inquiry report which was examined in detail in light of the charge sheet and statement of allegations.

ALLEGATIONS/FINDINGS:

In light of the Charge Sheet and Statement of Allegations the findings are as under:

1. THAT HE HAS MISBEHAVED WITH AN OFFICER IN THE PRESENCE OF SENIOR OFFICER IN VIOLATION OF OFFICE DECORUM.

Inquiry Committee deliberately discuss the matter with Director PRI, Dr. Zubair and Mr. Ahmad Khan and question in written was also served and the all stake holders including complainant agreed that the matter was based on a misunderstanding and the verbal apology by the accused (Mr. Ahmad Khan) was also accepted by Dr. Zubair Ali SRO which he has been submitted in written to the inquiry committee (Annex-X). As per statement of Accused (Annex-XVI,Q-2), Farm Manager (Annex-XIV-D) and Director PRI (Annex-VI), that the pending 36 bags have been received by the farm manager and no pendency exists against supplier (M/S Sarhad Traders). However, the committee has the opinion that receiving cash from the supplier and transferring of that amount to personal account of the accused instead of actual feed supply by supplier (Annex-IV) and then purchasing feed from local market by the accused is accountable as Irregularity.

5. THAT HE FURNISHED EXPENDITURE STATEMENT TO THE INQUIRY COMMITTEE WHICH WAS FOUND FAKE/FORGED/TEMPERED AND DID NOT TALLY WITH THE ACTUAL RECONCILED EXPENDITURE.

During the process of preliminary inquiry most of the items were left over and the receiving's, proper entries in relevant registers were also not found, due to which the reconcile statement did not tally with actual expenditure. However, during the Formal Inquiry the committee examined the evidences available on record in light of the documents provided by accused and end users, which are shown that the deficiencies mentioned in the preliminary inquiry were found completed.

CONCLUSION AND RECOMMENDATION:

As per evidence available on record and thoroughly examination of Preliminary inquiry Report and the replies of its incumbents against their questioners:

- 1. That the accused is responsible for mis-behavior and may be treated as per rules.
- 2. That the inquiry committee does not found any major Miss Appropriation except that the expenditure incurred worth Rs.296,099/- for Purchase of Poultry Feed, instead of feed supply by the concerned firm, Cash was received from the supplier for purchase of feed from open market. Though the expenditure utilized on its right place but the method adopted for purchasing feed from open market was wrong and thus it may be count as Irregularity.
 - 3. That the Expenditure from MA 4352 and financial power is the primary domain of Director PRI, Jaaba Mansehra. Director PRI has entrusted his power to another officer/official for his support. Therefore, both Director PRI and Mr. Ahmad Khan are responsible for such malpractice. This also shows lose control of Director Poultry Research Institute Jaaba Mansehra on his subordinates.



COURTENION WHEREAS disciplinary proceeding were initiated against Mr. Ahmad Khan, Assistant (BS-16) PRI, Jaba Mansehra under Khyber Pakhtunkhwa (Efficiency & Discipline) Rules, 2011 for the charges mentioned in the Charge Sheet and statement of allegations.

- WHEREAS an Inquiry Committee conducted formal Inquiry against the accused official for the charges levelled against him and proved the main allegation of misappropriation of government funds mentioned in the charge sheet and statement of allegations.
- WHEREAS on the basis of the findings & recommendations of the formal inquiry, a Show Cause Notice was served upon the accused official as to why Major Penalty of removal from service under Khyber Pakhtunkhwa (Efficiency & Discipline) Rules, 2011 may not be imposed upon him. The official was also offered personal hearing to defend his offences.
- WHEREAS the accused official furnished reply to the Show Cause Notice and sought opportunity of personal hearing, which was granted and authorizing Dr. Muhammad Ljaz Ali, Director VRI Peshawar (BS-19) to conduct personal hearing of the accused.
- WHEREAS after having examined the relevant record, inquiry report, written defense as well as verbal submissions made by the official before the authorized officer during the personal hearing, the authorized officer concluded that the charges of "Misappropriation of Government Funds" stand established in a way that keeping funds in personal account for later procurement of feed was roc endorsable. Although no loss to Government occurred as the required feed was actually procured and proper entries verified but the process adopted was wrong proving inefficiency on part of the official. The Authorized officer recommended to exonerate the official from major penalty of removal from service but with imposition of some other penalty to discourage such practices in future.





Respectfully Sheweth;

Prefiminary Objections:

- a- That the Appellant has got no Locus Standi to file the instant appeal.
- b- That the Appellant has not come to the Tribunal with clean hands. He has suppressed the material facts from this honorable Tribunal and thus the appeal deserves dismissal on this score alone.
- c- That the Appellant is not an aggrieved person within the meaning of Article-199 of the constitution of Islamic Republic of Pakistan, 1973.
- d. That the factual controversy is involved in the case, which cannot be adjudicated upon.
- e. That the instant Appeal is barred by law.
- f. That the appeal is time barred.

Facts

- Pertains to record.
- 2. Correct to the extent that respondent No. 3 issued a letter to the contractor Sarhad Traders for the outstanding feed of 36 bags but it is the appellant who received the cash amount of Rs. 280,000/ instead of feed from the contractor and transferred it in to his personal bank account at HBL Mingora Swat which has been proved both in preliminary as well as in formal inquiry.

- 3. Pertains to record. However when the contractor failed to supply the required poultry feed and returned the already paid amount Rs. 280,000/- to the appellant which he kept in his personal account illegally. (Annexure- A).
- 4. Incorrect. After the preliminary inquiry dated 01-10-2019, the charge sheet was issued dated 05-11-2019 and the appellant was given full chance to be heard and was called for personal hearing vide letter dated 12-12-2019. (Annexure-B).
- 5. Incorrect. The amount Rs. 280,000/ was found in the appellant personal bank account, the then DDO at PRI Mansehra. (Annexure- C).
- 5. Correct to the extent that the preliminary inquiry committee has verified the depositing of public funds in personal account of the appellant and its use for personal gains. (Annexure- D).
- 7. Incorrect. The appellant has been given full opportunity to all documents as per rules and regulations and also given an opportunity for personal hearing as mentioned in above para 4. (Annexure- E).
- 8. Incorrect. The questionnaire was issued on 2-3-2020 for conducting formal inquiry constituted on 14-05-2019. (Annexure- F).
- 9. Correct to the extent that both the preliminary and formal inquiry committees have proved that the appellant has received cash from the contractor instead of outstanding feed, and then depositing the same public money in his personal bank account and hence committed irregularities.
- 10. Correct to the extent that the appellant asked for personal hearing which was given to him as mentioned in para 4.
- 11. Correct to the extent that the appellant being aggrieved from the order of the competent authority, made departmental_appeal_which_was_partially_accepted_and_the_penalty_of "withholding promotion for two years" has been withdrawn vide letter No SO (LFC)/AD/3-1/2020 dated 16-06-2021. (Annexure-G).

12. Correct to the extent that the respondent No- 1 rejected the departmental appeal but then the appeal was reviewed on the request of the appellant where the penalty of "withholding promotion for two years" has been withdrawn as mentioned in above para 11

.. GROUNDS:

- 1. Incorrect. The order has been issued under law and is according to the rules and regulations which have been mentioned clearly in the said order dated 17-08-2020. (Annexure- H)
- 2. Incorrect. In the formal inquiry, the mis-behavior and irregularities, committed by the
- * appellant has been proved. (Annexure-1)
- 3. Incorrect. The respondents have no personal clashes with the appellant and both the preliminary and formal inquiries have been conducted as per government rules.
- 4. Incorrect. Both the orders are issued according to the law but as per the request of the appellant, his appeal has been reviewed by the appellate authority where the penalty of "withholding promotion for two years" has been withdrawn vide letter No. SO (LFC)/AD/3-1/2020 dated 16-06-2021.
- 5. Incorrect. The appellant blocked the government money by depositing it in his personal bank account at HBL Mingora Swat.
- 6. Incorrect. The appellant was heard in personal and has access to all relevant documents as per law as mentioned in para 4 of the FACTS.
- 7. Incorrect. The appellant as being the DDO, has kept the government money in his personal bank account and committed irregularity. Hence punished accordingly after being proved as convicted.

8. It is therefore humbly prayed that the appeal being devoid of merit may be dismissed.

NOTIFICATION

No. DG(R)/L&DD/E-II/PF(63)/89/ WHEREAS disciplinary proceeding were initiated against Mr. Ahmad Khan, Assistant (BS-16) PRI, Jaba Mansehra under Khyber Pakhtunkhwa (Efficiency & Discipline) Rules, 2011 for the charges mentioned in the Charge Sheet and statement of allegations.

- WHEREAS an Inquiry Committee conducted Formal Inquiry against the accused official for the charges levelled against him and proved.
- WHEREAS the inquiry committee after considering the allegations, evidence on record and explanation of the accused official furnished its report, wherein the main allegation of misappropriation of government funds mentioned in the charge sheet and statement of allegations:
- WHEREAS on the basis of the findings & recommendations of the formal inquiry, a Show Cause Notice was served upon the accused official as to why Major Penalty of removal from service under Khyber Pakhtunkhwa (Efficiency & Discipline) Rules, 2011 may not be imposed upon him. The official was also offered personal hearing to defend his offences.
- WHEREAS the accused official furnished reply to the Show Cause Notice and sought opportunity of personal hearing, which was granted and authorizing Dr. Muhammad Ijaz Ali, Director VRI Peshawar (BS-19) to conduct personal hearing of the accused.
- WHEREAS after having examined the relevant record, inquiry report, written defense as well as verbal submissions made by the official before the authorized officer during the personal hearing, the authorized officer concluded that the charges of "Misappropriation of Government Funds" stand established in a way that keeping funds in personal account for later procurement of feed was not endorsable. Although no loss to Government occurred as the required feed was actually procured and proper entries verified but the process adopted was wrong proving inefficiency on part of the official. The Authorized officer recommended to exonerate the official from major penalty of removal from service but with imposition of some other penalty to discourage such practices in future.
- NOW THEREFORE the undersigned, being Competent Authority in this case after having considered all the charges; evidence on record; findings of the formal inquiry; the explanation of the accused official; outcome of personal hearing and the recommendations of the Authorized officer, and exercising powers under Rule 14 (5) and Rule 4 (1) (a) (ii) of the Khyber Pakhtunkhwa (Efficiency & Discipline) Rules, 2011 has been pleased to impose Minor Penalty of "Withholding promotion and two increments for a period of two years" with immediate effect.

Therefore, both Director PRI and Mr. Ahmad Khan are responsible for such malpractice. This also shows lose control of Director Poultry Research Institute Jaaba Mansehra on his subordinates.
