

Learned counsel for the appellant present and submits that the appellant is aggrieved of transfer order issued vide Notification No. SO(PROs)/HD/Post&Trans/2022, dated 10.06.2022, against which he had filed representation on 13.06.2022, which was filed on the same day vide letter No. SO(Pross)/HD/1-31/Inquiry/2022, dated 13.06.2022. It is further contended that despite the fact the appellant was a heart patient and there was no facility of treatment at the place where he was transferred. That he had been posted under his junior, which pointed towards malafide of the respondents and which was also against the posting/transfer policy of the government. Moreover, there was no substitute provided against the post from which the appellant was transferred and the post was thus lying vacant. Points raised by the learned counsel need probe. The appeal is admitted to full hearing. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents. 




