The appellant had approached this Tribunal earlier through Service Appeal No. 1002/2015, seeking proforma promotion to BPS-17 and 18 from the date when his junior colleagues were promoted and for inclusion of his name at right position of the seniority list of those SETs who were appointed during the same year in which the appellant was appointed as SET. The said appeal was disposed of by judgment dated 03.01.2019 with the relief only to the extent of including name of the appellant in seniority list after necessary verification of his B.Ed Degree as acquired by him during service. However, no direction was given for promotion in consequence of inclusion of his name in the seniority list. The appellant through the present appeal has again invoked the jurisdiction of this Tribunal for proforma promotion with only difference of the fact that his name has been included in the seniority list in compliance with judgment of this Tribunal. On admission of this appeal for hearing, let it be determined whether the matter of proforma promotion can be taken as question relating to execution of the previous judgment dated 03.01.2019 or it should be dealt with independently. This appeal is admitted for regular hearing, subject to all just and legal objections, including that of limitation to be determined during the course of full hearing. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents for submission of written reply/comments in office within 10 days after receipt of notices, positively. If the written reply/comments are not submitted within the stipulated time, or extension of time is not sought through written application with sufficient cause, the office shall submit the file with a report of non-compliance. File to come up for arguments on 23.12.2021 before the D.B.
