

Learned counsel for the appellant argued that the appellant is aggrieved of the impugned order dated 16.03.2021 whereby, his colleagues were confirmed in the rank of SI from 2016 whereas he was confirmed w.e.f 21.01.2021. He preferred departmental appeal on 30.03.2021 but the same was not replied, responded or decided within the stipulated statutory period, hence, the instant service appeal filed before the Service Tribunal on 15.07.2021. Contention of the learned counsel for appellant is that he was entitled to be promoted to the rank of officiating S.I w.e.f 16.04.2014 instead of 21.01.2021.

Points raised need consideration. The appeal is admitted to regular hearing, subject to all just and legal objections. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents for submission of written reply/comments in office within 10 days after receipt of notices, positively. If the written reply/comments are not submitted within the stipulated time or extension of time is not sought, the office shall submit the file with a report of non-compliance. File to come up for arguments on 23.11.2021 before the D.B.
