



SERVICE APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE ORDER ENDST: NO. 5347-49/F.NO. 414/SST (M) DISCIPLINARY ACTIONS SWAT DATED 28-02-2022, WHEREBY THE MAJOR PENALTY OF COMPULSORY RETIREMENT WAS IMPOSED UPON THE APPELLANT AGAINST THE LAW, RULES AND FACTS, AGAINST WHICH THE APPELLANT PREFERRED A DEPARTMENTAL APPEAL, BUT THE SAME WAS NOT RESPONDED TO DESPITE THE LAPSE OF STATUTORY PERIOD OF TIME.

PRAYER:

That on acceptance of this appeal the order impugned may very kindly be set aside and the appellant reinstated back into service with all back/ consequential benefits.

Respectfully Sheweth:

Facts:

- i. That the Appellant was appointed as TT on 30-10-1986 and since then is regularly performing his duties to the best of his abilities and without any complaints, whatsoever.
- ii. That as a result of the satisfactory services of the Appellant he was promoted as SST (G) on 01-08-2017.
- iii. That the Appellant had submitted an application for extraordinary leave on various occasions, which were all sanctioned by the authority. Copies of the Sanction orders along with the joining reports / adjustment orders are enclosed as Annexure "A". That all the necessary entries in this regard are also being made in the service book of the Appellant, copy of which is enclosed as Annexure "B".
- iv. That on 26-07-2021 the Appellant received a Show Cause Notice from the office of the Respondent. No. 2 regarding visiting abroad without getting the NOC for travelling abroad,

along with alleged absence from personal hearing. Copy of the Show Cause Notice is enclosed as Annexure "C".

- v. That the Appellant submitted a detailed reply to the Show Cause Notice, copy of which is enclosed as Annexure "D".
- vi. That the Appellant has been so careful even in case of proceeding on casual leave that the Appellant submitted a proper application for the same as well. In this regard the application for casual leave dated 21-12-2021 along with the prescription of the doctor is enclosed as Annexure "E" and "F", respectively.
- vii. That in the year 2019 after an inquiry the Respondent No. 3 warning Endst: No. 3593/ dated 29-10-2019 the issue raised in the instant Show Cause Notice was already decided. Copy of the warning is enclosed as Annexure "G". in this regard to honor the said warning the Appellant submitted an application subsequently dated 10-12-2019 for permission to proceed for "Umrah", copy of the application is enclosed as Annexure "H".
- viii. That again in the year 2020 a complaint was filed after conducting an inquiry. In the inquiry recommendations the Appellant was duly found present in the station of duty and thus the complaint was disposed off. Copy of the inquiry

report dated 15-02-2020 is enclosed as Annexure "I".

- ix. That astonishingly letter vide No. 10557 dated 26-10-2020 the Appellant was again asked to provide produce documents and also appear for personal hearing. The Appellant reported at the DEO (M) office and submitted all the requisite record and also submitted a reply to the letter *ibid*. Copy of the letter dated 26-10-2020 is enclosed as Annexure "J" and that of the reply as Annexure "K", respectively.
- x. That flabbergasting enough the Appellant once again received a memo No. 819 dated 30-08-2021, whereby the Appellant was directed to submit a reply to a Show Cause Notice, the Appellant submitted a detailed reply to the same. Copy of the memo is enclosed as Annexure "L" and that of the reply dated 05-09-2021 is enclosed as Annexure "M", respectively.
- xi. That vide letter No. 5503/F.No. 414/SST (M) / Disciplinary Actions District Swat dated Peshawar the 06-09-2021 was received whereby the Appellant was called for personal hearing. Copy of the letter dated 06-09-2021 is enclosed as Annexure "N".
- xii. That astonishingly an anonymous complaint was received on the Pakistan Citizen's Portal (PCP), but the same was resolved in favour of the Appellant as the same allegations were found

to be totally wrong. Copy of the PCP along with the remarks is enclosed as Annexure "O".

- xiii. That the Appellant has remained very punctual and regular and regularly performed his duties to the satisfaction of the authorities and no lapse was ever found on the part of the Appellant. In this regard the Monitoring Report since 15-09-2015 is enclosed as Annexure "P", which shows that the Appellant has regularly been performing his duties.
- xiv. That furthermore the FIA report regarding the departure and arrival of the Appellant is enclosed as Annexure "Q" and that of the photocopies of the Attendance Register along with the relevant pages of the Passport are also enclosed as Annexure "R", which shows the dates on which the Appellant has proceeded only for "Umrah" and never has overstayed.
- xv. That strange enough and to the utter surprise of the Appellant was imposed upon major penalty of compulsory retirement from service vide Notification Endst: No. 5347-49/F.No. 414/SST (M) Disciplinary Actions Swat dated Peshawar the 28-02-2022, which Notification is against the law and rules on the subject and is liable to be set aside. Copy of the Notification dated 28-02-2022 is enclosed as Annexure "S".
- xvi. That feeling aggrieved of the order impugned Notification the Appellant preferred a

departmental appeal on 18-03-2022 for the redressal of his grievances. Copy of the departmental appeal is enclosed as Annexure "T". That when the same was not responded to the Appellant once again submitted another appeal, copy of which is enclosed as Annexure "U".

xvii. That the on one hand the Appellant is still performing his duties regularly, while on the other hand the respondents have not yet responded to the departmental appeal despite the lapse of statutory period of time, hence this Honourable Tribunal is approached for the redressal of the same on the following grounds. Copy of the attendance register is enclosed as Annexure "V".

Grounds:

- a. That the Appellant has not been treated in accordance with law and rules on the subject.
- b. That no enquiry was conducted against the Appellant despite the imposition of major penalty. Moreover the service record of the Appellant is such that it required a complete enquiry to reach just conclusion before the imposition of the major penalty, but the same was not done.
- c. That the Appellant has been condemned as unheard and also his defense version is not considered bald of any reasons.


- d. That the Appellant has been discriminated to his utter detriment.
- e. That the Appellant has never absented himself willfully neither has remained absent from his duties, which is clear from the record annexed.



NOTIFICATION

1. **WHEREAS**, Mr. Jamshid initially appointed as TT in this department vide Order bearing Endst: No. 26548-52 dated 30-10-1936 and promoted to SST (G) vide Notification bearing No.167-72 dated 1-08-2017.

4. **AND WHEREAS**, DEO (M) Swat handed over the show cause notice to the teacher concerned dated 26/07/2021 as per his letter bearing No. 7562 dated 28/07/2021.
5. **AND WHEREAS**, Mr. Jamshid SST GMS Kalagay Swat submitted his reply to the show cause notice dated 04/08/2021
6. **AND WHEREAS**, this office called Mr. Jamshid SST GMS Kalagay Swat for personal hearing on dated 09/09/2021 at 11:00 AM at committee room of this office vide letter No. 5503 dated 06/09/2021.




