




TRIBUNAL ACT, 1974.

Respectfully Sheweth:

1. That appellant is a regular employee of Elementary & Secondary Education Department Khyber Pakhtunkhwa, who was initially appointed as Theology Teacher in the year 2005 (Copy of appointment order dated 26-03-2005 is attached as Annexure "A").

2. That various posts of Senior Theology Teachers (BPS-16) fell vacant in District Swat, which were to be filled by departmental appointment by way of promotion amongst the Theology Teachers.
3. That consequent upon the recommendation of the Departmental Promotion Committee, the appellant alongwith 53 other aspirants was promoted as Senior Theology Teacher (BPS-16) vide order Endst: No.6856-60 dated 27-02-2013 (Copy of promotion order dated 27-02-2013 is attached as Annexure "B").
4. That consequently, the appellant forthwith assumed charge of his posts as STT (BPS-16) at his place of posting.
5. That very recently, the relevant seniority list was circulated, whereby the appellant was enlisted at S.No.60 of the said list. On the other hand, junior teachers in terms of qualification and age were placed senior to the appellant in the said list (Copy of seniority list is attached as Annexure "C").
6. That after receiving copy of the above mentioned seniority list, the appellant filed departmental appeal before respondent No.2 on 22-03-2021 for redressal of the appellant's grievances (Copy of memo of Departmental Appeal is attached as Annexure "D").
7. That the above mentioned appeal has not been responded to as yet, hence the appellant files the instant Service Appeal before this Hon'ble Tribunal, inter alia, on the following grounds:

GROUND:

- A) That the impugned seniority list whereby junior teachers to the appellant has been placed senior to him to such extent is illegal, unilateral and violative of due process, hence, liable to be declared as nullity in the eyes of law.
- B) That the appellant is nowhere deficient in terms of the requisite experience and other requirements as required by the law. Hence, the appellant deserves to be given proper place in the seniority list.
- C) That in terms of age, the appellant is older than respondents No. 4 & 5. To be precise, the appellant's year of birth is 1969 while respondents No. 4 & 5 were born in the year 1980 and 1973 respectively.
- D) That in terms of charge assumption, the appellant is not lacking behind respondents No.4 & 5. The appellant assumed charge of his initial post on 27-03-2005 and so did respondent No.5 while respondent No.4 assumed the same on 29-03-2005.
- E) That in terms of academic qualification, again the appellant is not deficient vis-à-vis the private respondents as all of them possess degrees in Master of Arts alongwith Bachelor of Education.
- F) That taking stock of the above, the appellant is senior than the private respondents for the reason that as per the prevailing law, a candidate older in age shall fall senior to the others in case where the educational qualifications are equal,

appointment order is the same and charge assumption date is also the same.

G) That further grounds with leave of this Hon'ble Tribunal will be raised at the time of oral submissions.

It is, therefore humbly prayed that on acceptance of this appeal, the impugned seniority list to the extent of appellant be set aside. Consequently, the appellant may be given his due place in the relevant seniority list by ordering his enlistment above respondents No.4 and 5. Any other remedy, though may not specifically prayed for but which the ends of justice would demand in the circumstances, may also be granted.







1. No TA / DA is allowed.
2. Charge report should be submitted to all concerned.
3. All the certificates / degrees will be verified from the concerned authority. In case any certificate / degree found incorrect / Un-verified the appointment order of the candidate should be automatically cancelled.
4. The original certificates / degrees of the candidates should be checked before handing over charge to the candidate concerned.
5. The contract candidates / officials will sign an agreements form before taking over charge.
6. They will be governed under terms and conditions as prescribed by the Government.
7. The appointment / posting of contract teachers in the schools is no transferable.
8. The contract teacher will not consider for regularization at any time.
9. The services of contract teacher can be terminated at any time in case their performance is found un-satisfactory and they will be preceded under special power ordinance 2000.


