1. Kanungo:

Following (1) the judgment in Write Petition No. 1245-M/2018 in case titled Sarmir Khan & others VS Deputy Commissioner Buner & Others i.e. if the respondents find the petitioners fit for promotion as a result of inquiries, their promotion orders shall be passed from the back date when the meeting of the Departmental Promotion Committees were held for the first time in Districts Swat and Buner wherein the petitioners were considers as candidates but they were differed while their juniors were promoted. Moreover, the promotion orders of the petitioners so passed shall be subject to final decision of the august Supreme Court in Suo Motu Case No.17/2016 and (2) in compliance with the letter No. SO(PSB)ED/1-25/2019/KC dated 15.05.2019 of the Government of Khyber Pakhtunkhwa Establishment Department received through the Board of Revenue, Revenue & Estate Department's letter No. Estt:V/PF/Suo Moto/F.2/2016/20588-629 dated 31.05.2019, the cases of the following Patwaris were scrutinized thoroughly and it was decided that four (04) Patwaris will be promoted to Kanungo subject to the final decision of the august Supreme Court in Suo Mc.o Case No. 17/2016.



ORDER 26/09/2019

This is an appeal filed by the appellant Mr. Sani Mullah s/o Haji Mullah, presently serving as Halqa Patwari Banchkara, District Buner against the decision of the Departmental promotion committee vide minutes of the meeting dated 10.07.2019, held under the chairmanship of Deputy Commissioner Buner, whereby promotion of the appellant to the post of Kanungo was deferred.

A cursory glance over the record revealed that the appellant Mr. Sani Mullah is serving as Halqa Patwari Banchkara, District Buner. As three posts of Kanungos were laying vacant in District Buner. In order to fill up these seats a meeting of the Departmental Promotion Committee was held on 10.07.2019 under the Chairmanship o Deputy Commissioner Buner. The Departmental Promotion Committee recommende 03 Patwaris for promotion to the post of Kanungos. Although the appellant was senic one but his case was not considered for promotion and two junior patwaris i.e Sarm Khan and Bakht Ghafoor Shah were promoted to the post of Girdawar. Aggrieved fro the said order the appellant preferred the instant appeal.

In light of the opportunity of Personal hearing given to the appellant. Perusal the comments received from respondent i.e Deputy Commissioner, Buner coupled $\ensuremath{\mathbf{w}}$ the available record it appears that on 13.11.2017 the then Deputy Commissioner Bu arranged a Departmental Promotion Committee meeting in order to promote Se Patwaris to the post of Girdawar BPS-11. In the said meeting name of the cur appellant was not considered for promotion on the ground that he had not passed Kanungo Examination which is mandatory for promotion. The Departmental Promo Committee also not considered name of certain other Patwaris for promotion of ground that their name reflects in NAB voluntary return list in spite of the fact that fulfilled all the pre-requisite for promotion. Amongst them were Mr. Sarmir Kl Bakht Ghafoor Shah, who are junior to the appellant. Against the said Departmen

Promotion Committee order Mr. Sarmir Khan and Bakht Ghafoor Shah etc filed v petition No. 1145-M of 2018 before Hon'ble Peshawar High Court, Mingora Bench/Darul Qaza, Swat. The Honorable Peshawar High Court, Mingora Bench/Darul Qaza, Swatcepted petition of the appellants and directed to conduct inquiries against petitioners and if in the result of inquiries they are not found guilty and they are fit promotion, their promotion orders shall be passed from the back date when meeting the Departmental Promotion Committee were held for the first time in District Swat: Buner wherein the petitioners were considered as candidates but they were defer while their juniors were promoted.

In compliance to the directions of the honorable Court the Deputy Commission Buner arranged meeting of the Departmental Promotion Committee on 10.07.2019; promoted Mr. Sarmir Khan and Bakht Ghafoor Shah Patwaris to the post of Girdav BPS-11 from the back date i.e 13.11.2017.

As the appellant didn't qualify Kanungo Examination in the year, 2017 theref he was not considered for promotion while Mr. Sarmir Khan and Bakht Ghafoor Sl Patwaris junior to the appellant fulfilled all the pre-requisite for promotion, but the name reflected in the NAB Voluntary Return list, therefore their promotion was defer against which they filed a writ petition in Peshawar High Court and the Hon Peshawar High Court decided the petition in their favor.

In light of the above mentioned facts, the appeal having no weight, is theref dismissed, however the Deputy Commissioner, Buner is directed that if posts Girdawars are vacant in District Buner, arrange a meeting of Departmental Promot Committee in a shortest possible time and consider promotion case of the appellant priority basis strictly on merit.






