Counsel for the appellant present. Preliminary arguments heard.

Learned counsel states that the appellant pursued the tentative seniority list with objection and after competition of the final seniority list vide notification dated 10.06.2020, he filed departmental appeal against the final seniority list on 28.10.2020 which remained un-responded so far. Although the departmental appeal is time barred in routine but in view of Section 30 of the Khyber Pakhtunkhwa Epidemic Control and Emergency Relief Act, 2020, the limitation period provided under any law shall remain frozen. This appeal having been filed after promulgation of the said Act, is not affected by bar of limitation. Points raised need consideration. The appeal is admitted to regular hearing. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents for submission of written reply/comments in office within 10 days of the receipt of notices positively. If the written reply/comments are not submitted within the stipulated time, the office is directed to submit the file with a report of non-compliance. File to come up for arguments on 07.10.2021.


