ON THE ACCEPTANCE OF INSTANT SERVICE APPEAL. BY DECLARING THE SENIORITY OF BE RECKONED FROM TO TIME TIME

APPOINTMENT I.E 24-04-1995 WITH ALL BACK BENEFITS AND FURTHER PRAYED THAT APPELLANT BE TREATED LIKE OTHER COLLEAQUES AS PER RULES OF CONSISTENCY AND MAY NOT BE DISCRIMINATED.ANY OTHER RELIEF WHICH THOUGH HAS NOT BEEN SPECIFICALLY PRAYED FOR BUT FOR WHICH THE APPELLANT ARE OTHERWISE ENTITLED, MAY ALSO BE GRANTED PLEASE.

#### Respectfully Sheweth:

Brief facts giving rise to the instant appeal are as under:

- 1) That the appellant is a permanent and bonafide resident of Saidu Sharif, Tehsil Babozai, District Swat.
- 2) That the appellant was appointed to the post of PTC vide appointment order bearing 1648-50 Dated 24-04-1995, The appellant was appointed on post of PTC vide ibid order on 24-04-1995 by the District Education Officer, District Swat. Copy of the appointment order is annexed herewith as "Annexure A".
- 3) That, the appellant performs his duty with great zeal and zest and to the satisfaction of the competent authorities without any complaints, whatsoever.
- 4) That in the year 1997 duties of the appellant along with other employees was sacked with one stroke in contravention of law and rules. (Copy of termination order is annexed as Annexure "B").
- 5) That the Government of Khyber Pakhtunkhwa passed an Act called as Khyber Pakhtunkhwa Sacked Employees Act 2012 under which all those employees whose services were sacked were to be appointed against 30% quota for them in all fresh recruitments in

# their respective cadre. (Copy of sacked Employees (Appointment) Act is annexed herewith as annexure "C")

- 6) That the appellant has submitted his application within stipulated time according to Sacked Employees (Appointment) Act 2012 but his application was not entertained at all.
- 7) That the appellant filed an appeal to the Service Tribunal whereas the Hon'ble Service Tribunal decided the appeal vide Appeal No. 1497 on Dated: 12/07/2016 in favor of the appellant. (Copy is annexed herewith as annexure "D").
- 8) That respondent No. 5 ignored re-instatement of appellant on pretext that appointment of the appellant was irregular, void ab initio and against prescribed rules.
- 9) That some colleagues of the appellant were re-instated into service by department himself, some colleagues were re-instated by tribunal and others in light of judgment Peshawar High Court, Mingora Bench, Swat under the umbrella of Sacked Employees Act 2012. Copy of appointment order is annexed as "Annexure E".
- 10) That the appellant was appointed on 15-02-2020 instead of reinstatement. (Appointment letter is annexed F)
- 11) That the appellant moved an application to District Education Officer (Male) Swat/ Respondent No. 5 for consideration of seniority of the appellant but the ibid officer did not bother to answer the appellant and the respondent No. 5 turned deaf ears upon the application of the appellant. (Copy is annexed as annexure G)

- 12) That having so dishearten and dissatisfied, the appellant then preferred departmental appeal/representation dated 19-01-2021 to the respondent No. 3 to grant them seniority giving effect from date of initial appointment i.e 30/04/1995 with all back benefit but that too fell on deaf ears. Copy of departmental appeal is annexed as "Annexure H".
- 13) That the Department not included the name of appellant in seniority list, which is illegal and injustice
- 14) That having no other adequate remedy and to entertain the constitutional right to appeal, the appellant prefers the instant appeal before this Hon'ble Tribunal for granting of all back benefits *inter alia* on the following grounds/reasons with so many others:
- 15) That the appellant is discriminated and not re-instated by the department, so the appellant filed W.P No. 1001-M/2018 for re-instatement being discriminated. The honorable Court is kind enough to accept the W.P and the appellant is re-instated into services. The department is directed to give seniority to the appellant with his colleagues.
- 16) That the department should have to pass an order of reinstatement in light of the Order of the worthy High Court, Mingora Bench, Swat on dated: 22/10/2019. Hence the department made illegality and irregularity. (Peshawar High Court Order Dated: 22/10/2019 is annexed I)

#### **GROUNDS**:

a) That after regularization the appellant entitled for benefit of pay protection and seniority from the date of initial

appointment along with all back benefits but respondent No. 5 in this regard not treating the appellant according to the law.

- b) That after regularization the period already served by the appellant entitled him to benefit of pay protection in the form of increment and salary etc as normally available to civil servant.
- c) That the appellant has a legitimate right of seniority, increment from his initial appointment but contrary to his legitimate expectation the appellant has been deprived.
- d) That there is no efficacious remedy available to the appellant except to file the instant appeal.
- e) That the as per the requirements of law, advance copies of the instant appeal have been sent to the respondents via registered mail and receipts have been annexed with the instant appeal.
- f) That further grounds will be agitated at the time of arguments with prior permission of this hon'ble Tribunal.

In light of the above submissions, it is, therefore, humbly prayed that on the acceptance of instant appeal, seniority of the appellant be reckoned from reckoned from date of initial appointment i.e 30-04-1995 with all back benefits and further prayed that appellant be treated like other colleagues as per rules of consistency and may not be discriminated. Any other relief which though specifically has not been prayed for but for which the appellant is otherwise entitled may also be granted, please.



THE KHYBER PANATUNKHWA | SACKED EMPLOYEES (APPOINTMENT) ACT, 2012.

(KHYBER PAKHTUNKHWA ACT NO. XVII OF 2012)

[first published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of Khyber Pakhtunkhwa (Extraordinary), dated the 20th September, 2012]

AN ACT

o provide relief to those sacked employees in the Government service, who were dismissed, removed or terminated from service, by appointing them into the Government service.

WHEREAS it is expedient to provide relief to those sacked employees who were appointed on regular basis to a civil post in the Province of the Khyber Pakhtunkhwa and who possessed the prescribed qualification and experience required for the said post, during the period from 1<sup>st</sup> day of November 1993 to the 30<sup>th</sup> day of November, 1996 (both days inclusive) and were dismissed, removed, or terminated from service during the period from 1<sup>st</sup> day of November 1996 to 31<sup>st</sup> day of December 1998 on various grounds;

WHEREAS the Federal Government has also given relief to the sacked employees by enactment;

AND WHEREAS the Government of the Khyber Pakhtunkhwa has also decided to appoint these sacked employees on regular basis in the public interest;

It is hereby enacted as follows:

- 1. Short title, extent and commencement.---(1) This Act may be called the Khyber Pakhtunkhwa Sacked Employees (Appointment) Act, 2012.
- (2) It shall apply to all those sacked employees, who were holding various civil posts during the period from 1<sup>st</sup> day of November, 1993 to 30<sup>th</sup> day of November, 1996 (both days inclusive).
  - (3) It shall come into force at once.
- 2. <u>Definitions.</u>— In this Act, unless the context otherwise requires, the following expressions shall have the meanings hereby respectively assigned to them that is to say,





- (a) "civil post" means a post created by the Finance Department of Government for the members of civil service of the Province;
- (b) "Department" means the Department and the Attached Department as defined in the Khyber Pakhtunkhwa Government Rules of Business, 1985, including the Divisional and District Offices working thereunder;
- (c) "Government" means the Government of the Khyber Pakhtunkhwa;
- (d) "Prescribed" means prescribed by rules;
- (e) "Province" means the Province of the Khyber Pakhtunkhwa;
- (f) "rules" means the rules made under this Act; and
- (g) "Sacked employee" means a person who was appointed on regular basis to a civil post in the Province of the Khyber Pakhtunkhwa and who possessed the prescribed qualification and experience for the said post at that time, during the period from 1<sup>st</sup> day of November 1993 to the 30<sup>th</sup> day of November, 1996 (both days inclusive) and was dismissed, removed, or terminated from service during the period from 1<sup>st</sup> day of November 1996 to 31<sup>st</sup> day of December 1998 on the ground of irregular appointments;
- 3. Appointment of sacked employees.— Notwithstanding anything contained in any law or rule for the time being in force, on the commencement of this Act, all sacked employees subject to section 7, may be appointed in their respective cadre of their concerned Department, in which they occupied civil posts before their dismissal, removal and termination from service:

Provided that the sacked employees shall be appointed against thirty percent of the available vacancies in the said Department:

Provided further that the appointment of sacked employees shall be subject to the medical fitness and verification of their character antecedents to the satisfaction of the concerned competent authority.

dismissed, removed or terminated from service, till the date of their appointment shall be deemed to have been airtomatically relaxed and there shall be no further relaxation under any rules for the time being in force.





5. Sacked employees shall not be entitled to claim seniority and other back benefits.— A sacked employee appointed under section 3, shall not be entitled to any claim of seniority, promotion or other back benefits and his appointment shall be considered as fresh appointment.

- 6. <u>Preference on the basis of age.</u>— On the occurrence of a vacancy in the respective cadre of the concerned Department of the sacked employee against the thirty percent available share, preference shall be given to the sacked employee who is older in age.
- 7. Procedure for appointment.—(1) A sacked employee, may file an application, to the concerned Department within a period of six months from the date of commencement of this Act, for his appointment in the said Department:

Provided that no application for appointment received after the due date shall be entertained.

- The concerned Department shall maintain a list of all such sacked employees whose applications are received under sub-section (1) in the respective cadres in chronological order.
- If any vacancy occurs against the thirty percent available share of the sacked employee in any Department, the senior in age from such sacked employee shall be considered by the concerned Departmental Selection Committee or the District Selection Committee, as the case may be, to be constituted in the prescribed manner, for appointment:

Provided that no willingness or response is received within a period of thirty days, the next senior sacked employee shall be considered for appointment.

- (4) The Concerned Departmental Selection Committee or District Selection Committee, as the case may be, will determine the suitability or eligibility of the sacked employee.
- (5) If no sacked employee is available against thirty percent vacancy reserved in respective cadre in a Department, then the post shall be filled through initial recruitment.
- 8. Removal of difficulties.— If any difficulty arises in giving effect to any of the provisions of this Act, the Chief Minister Khyber Pakhtunkhwa may issue such order not inconsistent with the provision of this Act as may appear to him to be necessary for the purpose of removing the difficulty:

Provided that no such power shall be exercised after the expiry of one year from coming into force of this Act.

9. Act to override other laws.---Notwithstanding anything to the contrary contained in any other law or rules for the time being in force, the provisions of this Act shall have overriding effect and the provisions of any other law or rules to the extent of inconsistency to this Act, shall cease to have effect.

10. Power to make rules. Government may make rules for carrying out the purposes of this Act.

- This judgment shall dispose of Service Appeal No. 1497/2013 preferred by Mr. Ali Rahman and Service Appeal No. 1583/2013 preferred by Mr. Irshad Ahmad as identical questions of facts and law are involved in both the appeals.
- Brief facts of the cases of appellants Ali Rahman as well as. Irshad Ahmad are that they were appointed as PTC Teachers on regular basis vide order dated 30.04.1995 and while serving so their service were terminated vide order dated 13.02.1997 alongwith similarly placed other employees. That services of other similarly placed employees were restored but appellants discriminated with despite the fact that they were also entitled







to reinstatement in service.

- Learned counsel for the appellants has argued that the appellants were also entitled to same treatment. That during the process of departmental appeals of the appellants a letter dated 26.10.2013 was issued by the District Education Officer (Male) District, Swat addressed to the Director of Education, Khyber Pakhtunkhwa Peshawar wherein it was pointed out that the process of appointment of the appellants was stopped due to status-quo order passed by a Civil Court. He further argued that despite withdrawal of the said civil suit the process of appointment is still held in abeyance and the appellants deprived of their due rights.
- Learned Senior Government Pleader argued that process was not resumed as the appellants were not found eligible to reinstatement due to lake of prescribed qualification.
- 6. We have neard arguments of learned counsel for the parties and perused the record.
- 7. Letter dated 26.10.2013 referred to above would suggest that the applications of the appellants were processed and appellants interviewed in the light of provisions of the Sacked Employees Act No. XVIII 2012 but no final orders were passed due to status quo order issued by a civil court. Though the said status quo order was no longer in field yet the relevant authority did not process cases of the appellants despite their commitment reflecting in the said letter. We are not in a position to consider cases of the appellants for reinstatement in service at this stage and deem it





appropriate that cases of the appellant be considered and decided by the relevant authority within a period of one month from the date of receipt of judgment of this Tribunal keeping in view the contents of letter dated 26.10.2013 referred to above. In case the authority fail to consider and decide cases of the appellants within the prescribed period of one month from the date of receipt of this judgment then in such eventuality they shall be liable to be proceeded against for omissions on their parts. Both the appeals are disposed of in the above terms. Parties are left to bear their own costs. File be consigned to the record room.





On promulgation Khyber Pakhtunkhwa Sacked Employees (Appointment) Act, 2012 (hereinafter referred to as 'the Act'), they filed applications to the respondents department and requested for their re-instatement but same was not entertained. Thereafter, they filed appeals before the Khyber Pakhtunkhwa Service Tribunal for redressal of their grievances. During pendency of their appeals, respondent No. 3 issued a letter dated 26.10.2013, wherein it had been stated that "applications from sacked employees including the appellants i.e. present petitioners have been received, processed in due time and interview conducted but due to status quo order passed by a local civil Court, the appointment process was still pending. As and when the status quo is vacated, than their appointments will be considered on priority ligh Court Bench basis." In light of the letter dated 26.10.2013, the Khyber Pakhtunkhwa Service Tribunal Camp Court, Swat vide its judgment dated 12.07.2016 disposed of appeals of the appellants (petitioners) and directed the respondents to consider and decide cases of the appellants (petitioners) within a period of one month, keeping in view the

Against that, the petitioners filed the instant constitutional petition.

- 3. Comments were called from the respondents No. 2 & 3, who filed the same and have contended that the petitioners were appointed on temporary basis and they were also not professionally trained at the time of their appointments, therefore they did not deserve re-instatement under the Act.
- 4. Arguments heard and record perused.
- *(*-, ) Perusal record reveals that respondents have mainly taken two defences in their comments viz;
  - a) that the petitioners had been appointed on temporary basis;
  - b) that they had not been trained teachers at the time of appointment.
- 6. Their first defence is belied by the very

appointment order dated 30.04.1995 of petitioner No. 1 namely Irshad Ahmad, which states that he was appointed on PTC post in BPS-07 @ Rs. 1480-81-2695 per month fixed puls allowances with immediate effect in the interest of public service as per terms and conditions given therein. Though the order was temporary but it has nowhere been stated that it had been made against a leave vacancy or as a stopgap arrangement. Same was the case with the appointment order dated 25.04.1995 of petitioner No. 2 namely Ali Rahman.

petitioners had been untrained teachers at the time of their appointment, is concerned, it is pertinent to mention here that this Court vide judgment dated 24.12.2014 given in the case of Hazrat Hussain etc vs The Government of Khyber Pakhtunkhwa through Chief Secretary. Civil Secretariat, Peshawar (Writ Petition bearing No. 1662-P/2013) has already resolved the controversy and has held that the appointment of untrained teachers was allowed and being made in routine under the prevalent policy at the relevant time. been extended the behefit of re-instatement : Act. The petitioners have stated in para-5 of the writ petition that they had filed an application within stipulated time after commencement of the Act, but their application had not been entertained. In respect of the said para, the respondents have stated in their comments that the said para was irrelevant, therefore no comments. The para had not been specifically denied by the respondents in their comments. Same shall therefore be accepted as admitted. The petitioners have also annexed with their writ petition a letter bearing No. 600 dated 26.10.2013 of the Office of respondent No. 3 at page 24, wherein it had been stated that both the petitioners had filed their applications under section 7 of the Act within the stipulated time. #### Parawise Comments on Behalf of the Respondents:

#### Respectfully Shewith

#### Preliminary objections

- 1. That the Appellant is not an aggrieved person within the meaning of Section 4 of the service Tribunal Act, 1974.
- 2. That the Appellant has no cause of action / locus standi.
- 3. That the Appellant has not come to this Honorable Court with clean hands.
- 4. That the Appellant has filed this instant service appeal just to pressurize the respondents.
- 5. The present service appeal is liable to be dismissed for non-joinder/miss joinder of necessary parties.
- 6. That the instant service appeal is against the prevailing law and rules.
- 7. That the Appellant has filed this instant Service Appeal on malafide motives.
- 8. That the instant appeal is badly time barred.
- 9. That the Appellant has been appointed conditionally in compliance with the Honorable Peshawar High Court Mingora Bench/Dar Ul Qaza Swat judgment and under the provision of Sacked Employees Appointment Act, 2012 wherein it is clearly mentioned that the appointment of Sacked employees will be considered as fresh appointment and they shall not be entitled to claim any seniority, promotion or other back benefits.
- 10. That the instant service appeal is not maintainable in the present form, and above in the present circumstances of the issue.
- 11. That the Appellant has estopped by his own conduct.
- 12. That the Appellant has concealed the material facts from this Honorable Tribunal.

#### **FACTS:**

- 1. That the Para No.1 pertains to his personal information. Hence no comments.
- 2. That the Para No.2 pertains to record. Hence no comments.
- 3. That the Para No.3 is irrelevant. Hence no comments.
- 4. That the Para No.4 is incorrect and denied. The Appellant was terminated from service in accordance with the terms and conditions of the appointment order wherein it is clearly mentioned that his appointment is temporary and is liable to termination/reversion at any time without any reason being assigned. Moreover, the appointment order of the Appellant was irregular, ab-initio, void and against the prescribed rules. Therefore, the appointment was liable to termination and the Appellant was terminated from the service.
- 5. That the Para No.5 is correct to the extent of promulgation of the Sacked Employees (appointment) Act, 2012. However, it is worth to mention here that according to the section 2 (g) of the said Act, the Appellant did not come in the definition of Sacked employee as the Appellant was appointed on purely temporary basis and was liable to termination.
- 6. That the para No. 6 pertains to record. Hence no comments.
- 7. That the para No. 7 is correct to the extent of filing of Service Appeal No 1497. The rest of the para is incorrect and denied. This Honorable Tribunal has **not decided** his Service Appeal dated 12-07-2016 in his favor. In fact, this Honorable Tribunal sent his Appeal to the relevant authority/Department for decision. The Department constituted an enquiry committee. The committee concerned submitted enquiry report wherein it was recommended that the Appellant was appointed on 25-04-1995 and got PTC training on 2-08-1995 means at the time of appointment he was not having prescribed qualification. Therefore, he was not considered for appointment. (Service Tribunal Judgment dated 12-07-2016 is already Annexed with the instant Service Appeal as Annexure D)
- 8. That the Para No. 8 is correct.
- 9. That the Para No. 9 is incorrect and denied. The order annexed with the instant Service Appeal by the Appellant has not been issued under the provisions of the Sacked Employees Act, 2012. The two appointees (Mr. Muhammad Shereryar and Mr. Anwar Zeb) mentioned in the appointment order had filed service Appeals no. 532/2008 and 533/2008 before this honorable Tribunal in the year 2008. This Honorable Tribunal decided their services appeals vide order dated 04-01-2013 and accordingly they were appointed in pursuance to the order of this Honorable Tribunal dated 04-01-2013 vide DEO (M) Swat Office order Endst No.727-32 dated 05-07-2013 meaning there by that they had filed appeals well before the promulgation of the Sacked Employees Act, 2012. Therefore, the present appellant cannot claim same treatment.
- 10. That the Para No.10 is correct to the extent of appointment date of the Appellant. The rest of the para is incorrect and denied. The Appellant is

conditionally appointed with immediate effect into services under Khyber Pakhtunkhwa Sacked Employees (appointment) Act, 2012 and in compliance with the Honorable PHC Mingora Bench/Dar Ul Qaza Swat. According to section 5 of the said Act, "A sacked employee appointed under section 3, shall not be entitled to any claim of seniority, promotion or other back benefits and his appointment shall be considered as fresh appointment." Hence, the Appellant is not entitled for seniority and back benefits. If the Appellant felt aggrieved of the Honorable Court judgment, he should have filed appeal in the proper forum against the said judgment. The Appellant accepted the appointment order as well as the judgment of the PHC Mingora Bench/Darul Qaza Swat. (Sacked Employees Act, 2012 is already Annexed with the instant Service Appeal as Annexure C)

- 11. That the Para No. 11 is the repetition of the above paras. Detail reply has been given in para No. 10 above.
- 12. That the para No. 12 is again the repetition of the para No. 10 above. Hence, no comments.
- 13. That the Para No. 13 is incorrect and denied. The Appellant has been appointed in compliance with the Honorable PHC Mingora Bench/Dar Ul Qaza Swat order dated 22-10-2019 in W.P No. 1001-M/2018 under the provisions of the Sacked Employees Act, 2012. The Appellant is not entitled for seniority before his appointment.
- 14. That the para No. 14 is irrelevant. Hence, no comments.
- 15. That the para No. 15 is correct to the extent of Writ Petition of the Appellant. The rest of the para is incorrect and denied. No discrimination whatsoever has been made with the Appellant. He has been conditionally appointed subject to the final judgment of the Honorable Apex Court in CPLA filed by the Department. As for as seniority of the Appellant is concerned, his name will be included in seniority list with effect from his appointment dated 15-02-2020.
- 16. That the para No. 16 is incorrect and denied. The Honorable PHC Mingora Bench/Dar Ul Qaza Swat clearly denied back benefits to the Appellant while determination of seniority has been kept on the disposal of the Department. Hence, accordingly he will be given seniority w.e.f his appointment dated 15-02-2020.

That the instant service appeal of the Appellant is bereft of any merit, hence liable to be dismissed inter alia following grounds.

#### **GROUNDS**

- a) That the Para No. a is quiet astonishing and not clear about the regularization of the Appellant. Hence, denied
- b) That the Para No. b is again the repetition of the above paras. Hence, no comments.
- c) That the Para No. c is incorrect and denied. The Appellant has not served the Department. Therefore, he is not entitled to increments and seniority from his initial appointment. It is further stated that the

Honorable PHC Mingora Bench/Dar Ul Qaza Swat has also denied the claim of the Appellant regarding back benefits.

- d) That the Para No. d is legal hence no comments.
- e) That the para No. e pertains to record. Hence, no comments.
- f) That the para No. f is irrelevant. However, respondents also seek permission of this Honorable Tribunal to advance further grounds at the time of arguments.

It is, therefore, very humbly prayed that the instant service appeal of the Appellant may be dismissed with cost in favor of the respondents.


