

- That, in light of the above stop gap arrangement basis promotion most of other colleagues of the appellant were given promotion to the post of Budget & Account Officers (BPS-17) on regular basis on the proper recommendation of the Departmental Promotion Committee vide order dated 18.07.2017 while the appellant was ignored due to non inclusion of his name in the seniority list of Superintendents circulated for the year 2015. Copies of the promotion order and seniority list are attached as annexure
- 10- That, the appellant got retired on attaining the age of superannuation vide order dated 18.09.2018 w.e.f. 19.04.2017 as per his Date of birth dated 20.04.1957. Copy of the retirement order is attached as annexure
- 11- That, the appellant filed a Departmental Appeal before the competent authority for the grant of pro forma promotion to the post of Budget & Accounts Officer (BPS-17) w.e.f. 18.7.2017 but no reply has been received so for. Copies of the Departmental Appeal & letter are attached as annexure
- 12- That feeling aggrieved and having no other remedy the appellant filed the instant appeal on the following grounds amongst the others.

GROUNDS:

- D- That, the respondents acted in a malafide manner while not including the name of the appellant in the seniority list prepared for the cadre of superintendents for the year 2015 despite the fact that clear

direction has been issued for the adjustment of the appellant to the post Superintendent w.e.f. 14.10.2015.

- E- That the respondents acted in arbitrary and malafide manner by not allowing/ granting proforma promotion to appellant to the post of Budget & Accounts officer (BPS-17) despite the fact that the appellant was adjusted against the post of Superintendent w.e.f 14.10.2015 vide corrigendum dated 21.12.2016 hence the appellant is eligible for proforma promotion according to service rules.
- F- That the inaction of the respondents by not allowing/granting pro forma promotion to the appellant to the post of Budget & Accounts Officer (BPS-17) is violative of section-9 of the Civil Servant Act 1973 read with Rule-7 of the (Appointment, Promotion & Transfer) Rules 1989.
- G- That as per Rules and regulation the appellant is entitle for proforma promotion to the post of Budget & Account Officer (BPS-17) with all consequential benefits.







ABDUL LATIF, MEMBER:- Counsel for the appellant (Mr. Muhammad Asif Yousafzai, Advocate), and Mr. Muhammad Jan, GP for the respondents present.

- 2. The instant appeal has been instituted by the appellant Mr. Anwar Badshah Ex-B&AO (E&SE) Department under Section-4 of the Khyber Pakhtunkhwa Service Tribunal Act-1974 against the order dated 10.10.2011 whereby the appellant was reduced to lower grade BPS-14 and against order dated 15.10.2012 whereby his departmental appeal was filed. The appellant also prayed that respondents may be directed to grant monthly salaries to the appellant w.e.f March 2011 till date which had been stopped illegally.
- 3. The learned counsel for the appellant argued that the orders of penalty and rejection of departmental appeal were against the laws rules, norms of justice and material on record hence not tenable. That no charge sheet was issued to the appellant and enquiry proceedings done on questionnaire form were against the law and verdict of superior Court. He further argued that no statement of other officials was recorded in presence of the appellant nor the appellant was allowed to cross examine. That the reduction was made by two stages which is not permissible under the law and no period has been specified in the impugned order which is violation of FR-29. He further submitted that stoppage of pay of appellant since March 2011 was illegal and without lawful authority. He prayed that the appeal may be accepted and the impugned order may be set aside.
- 4. The learned Government Pleader argued that EDO was not competent authority to detail/transfer the appellant from Shangla to Peshawar. That the so called order of detailment was withdrawn by EDO Shangla but the appellant defied the same and remained absent willfully from his original office at Shangla. That proper enquiry was conducted against the appellant and charge sheet, statement of allegations was served upon him. All the relevant record was examined in the presence of the appellant and he was given full opportunity of defense and opportunity of personal hearing before imposition of penalty. That the appellant was



willfully absent from his duties, hence was not entitled as per law and rules to salary for the period of absence. He prayed that the appeal may be dismissed.

- 5. Arguments of counsel for the parties heard and record perused with their assistance.
- It transpired from the perusal of the record that the appellant was 5: basically posted as Budget and Account Office in office of EDO (E&SE) Shangla. It appears that he was lent to assist the office of EDO (E&SE) Peshawar by the then EDO Shangla. On his transfer, the incumbent EDO Shangla cancelled the previous order and directed the appellant to resume duty at Shangla. We have carefully pursued the record and unable to see that in spite of cancellation of his detailment order by EDO Shangla vide order dated 09.06.2010 the appellant would have performed duty at Shangla for a single day. The record shows that he simply wanted to remain in Peshawar with his family in which EDO Office Peshawar seems to be facilitating him, however all this happened at the cost of his office work at Shangla. His non performance of duty at Shangla is not simply absence from duty but the service conduct as appears from the materials on record seems to be not becoming of a Civil Servant and that unquestionably amounts to his misconduct. In the said situation, he was duly proceeded against after affording him opportunity of defense. In this situation the penalty of his reduction from the Selection Grade BPS-16 to BPS-14 is not excessive. However the impugned order is modified and the penalty is converted to reduction to have post for a period of four years. As for the stoppage of salaries since 2011, the appropriate departmental authority shall examine the same in the light of actual performance of duties in the EDO (E&SE) Peshawar and decide it on merits. Parties are left to bear their own costs. File be consigned to the recor







- 7. That I have approached many time to the authority i.e. Director E&SE Peshawar (copy attached) for my original position as B&AO but in vain and have not fruit full result.



AMENDMENTS

- In rule 4,in sub rule (1), in clause (b), for sub-clause (i), the following shall be substituted, namely:
 - "(i) reduction to a lower post of pay scale or to a lower stage in a time scale for a maximum period of five years:

Provided that on restoration to original pay scale or post, the penalized Government servant will be placed below his erstwhile juniors promoted to higher posts during subsistence of the period of penalty;".

- 2. 1 In rule 8, in clause (a), in the proviso, the word "immediate Committee", occurring second time, the words "subject to sub-rule (7) of rule 11" shall be added.
- In rule 14, in sub-rule (6), after the words "Inquiry Committee", occurring second time, the words "subject to sub-rule (7) of rule 11" shall be added.
- 4. In rule 19, in sub-rule (2), for the word "thirty", the word "ninety" shall be substituted.
- Rule 22 shall be deleted.
