THAT ON ACCEPTANCE OF THIS APPEAL, THE RESPONDENTS MAY BE DIRECTED TO CONSIDER THE APPELLANT FOR PROMOTION AS HEADMASTER BPS-17 FROM THE DATE WHEN THE OTHER OFFICIALS FROM SERIAL NO.193 AND ONWARD PROMOTED VIDE ORDER DATED 26.2.2013 BY CONSIDERING THEIR DATE OF TAKING OVER CHARGE FOR THEIR SENIORITY. ANY OTHER REMEDY, WHICH THIS AUGUST TRIBUNAL DEEMS FIT AND PROPER THAT MAY ALSO BE AWARDED IN FAVOUR OF APPELLANT.

RESPECTFULLY SHEWETH:

1. That the appellant was appointed as SET by the competent authority vide order dated 4.12.1989. The appellant was having the qualification of B.A and B.Ed at that time and was trained teacher. The appellant took over charge on 7.12.1989 (F.N) which is duly recorded in the Service Book. Copies of Order and Relevant Pages of the Service Book are attached as Annexure-A and B.
2. That the appellant has been serving as SET since 4.12.1989 till-date and has 24 years length of service at his credit with good record and results.
3. That the appellant was also regularized vide order dated 29.7.1991. Copy of Order is attached as Annexure-C.
4. That on 4.5.2012, the Directorate of Education (E&SE) requested to all other concerned offices to furnish the PERs of certain officials for promotion to BPS-17 regular. In the said letter at Serial No.3427 the name of one Mian Shah Said was also included who was not only appointed along-with the appellant in a single order but also regularized along with the appellant through the same and one order. Copy of Order is attached as Annexure-D.
5. That on 26.2.2013 round about 290 SETs were promoted in which those officials have also been included who took over charge on 9.12.1989 meaning thereby after the date of taking over charge of the appellant. The appellant name was required in the promotion list at Serial No.193 because the official from 194 and onward are those who took over charge as SET on 9.12.1989 or afterward. Copy of Order is attached as Annexure-E.
6. That the appellant filed Departmental Appeal against the discriminatory treatment and not considering him for promotion on 26.3.2013 and waited for statutory period of 90 days, but no reply has been received to the appellant. Hence, the present appeal on the following grounds amongst the others. Copy of Departmental Appeal is attached as Annexure-F.

GROUNDS:

- A) That not considering the appellant for promotion as Head Master and not taking any action on the departmental appeal of the appellant within statutory period, is against the law, rules, norms of justice and material on record, therefore, such inaction of the respondents is not tenable.
- B) That the appellant has more than 24 years service with good record throughout his career and was also trained teacher from the very first date of appointment, therefore, the appellant has the legal right to be considered for promotion as Head- Master.
- C) That the appellant has not been treated according to law and rules and the appellant has been kept deprive from the benefits of promotion in an arbitrary manner.
- D) That there is nothing on the record as adverse against the appellant which could be based for denying promotion to the appellant.
- E) That as per Section-9 of the Civil Servant Act, 1973 the appellant has a legal right for consideration for promotion to higher post reserved under the promotion quota but in the case of appellant, the respondents have not even considered the name of the appellant for his promotion despite of having 24 years length of service and eligibility with seniority.
- F) That as per instructions of the Government contained in the ESTA CODE the Departmental Promotion Committee / P.S.B shall consider the cases of all eligible civil servants for promotion.
- G) That the appellant has been discriminated because in the impugned promotion order, the officials from serial No.194 and onward were considered for promotion even the date of taking over charge (SETs) of those officials later than the date of taking over charge of the appellant.
- H) That the appellant has not been given his due right and the promotion order dated 26.2.2013 is based on pick and choose of the blue eyed person because no strict criteria has been followed while granting promotion.

- I) That the appellant has not been treated according to law and rules made for the civil servant.
 - J) That the appellant seeks permission to advance others grounds and proofs at the time of hearing.

It is, therefore, most humbly prayed that the appeal of the appellant maybe accepted as prayed for.

ON GROUNDS

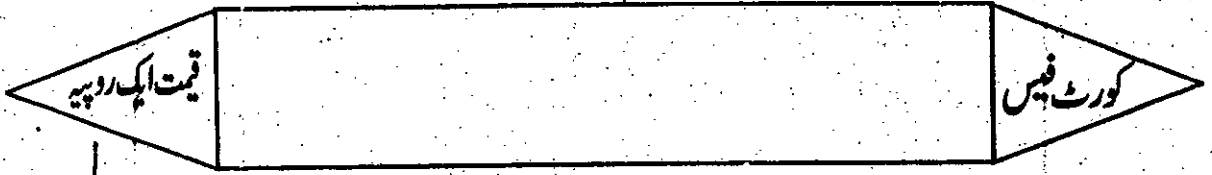
