Learned counsel for the appellant while arguing the case, highlighted that the appellant was serving as District Accounts officer (BS-18) and being senior most on the seniority list, he was posted as District Comptroller Accounts (BS-19) in own pay scale (OPS). The appellant was at serial No.3 of the DAO seniority list as it stood on 31.12.2019 and there were three (03) vacant posts of DCA on 31.12.2020. However, no meeting of the PSB was held despite the fact that he submitted an application on 21.07.2020 intimating therein that he was going to retire from service on attaining the age of superannuation on 01.02.2021. It was further contended that after retirement of the appellant, PSB meeting was held and his junior on seniority list (Mr. Rab Nawaz) promoted to BS-19 just one day before 🗬 his retirement, on notional basis w.e.f 28.04.2021 vide Notification dated 21.05.2021, Whereas the appellant was ignored and deprived of his due rights. He preferred departmental appeal on 08.06.2021 which was not responded to within the statutory period and then approached the Service Tribunal in service appeal on 30.09.2021. The impugned Notification dated 21.05.2021 has been challenged and assailed in the Service appeal.
