Appellant Depos Security & Proc Counsel for the appellant present. Preliminary arguments heard.

Learned counsel for the appellant while arguing the case contended that the appellant is aggrieved of the impugned order dated 23.12.2021 whereby this services were placed at the disposal of Directorate of Elementary and Secondary Education and private respondent No.5 was posted against his position despite the fact that private respondent No.5 is an officer of management cadre in BS-19. There are only two posts of BS-20 in the respondent-department and as per seniority list circulated vide notification dated 17.06.2019, the appellant stands at serial No.2. In presence of the officer in BS-20 in the management cadre, posting of a junior officer (BS-19) against a BS-20 post in own pay scale is against the law and judgements of the superior courts. In support of his arguments he relied on 2014 SCMR 1189 and 2018 SCMR 1411. According to the spirit of these judgements the practice of appointment on OPS basis did not have any sanction of law and such postings/transfers are not legally permissible. In addition to the aforesaid judgement, attention of the Bench was drawn towards instructions of former S&GAD circulated on dated 20.08.1979 and which appears at page-73 of the Provincial Esta Code. The appellant preferred review petition against the impugned order to the Chief Minister, Khyber Pakhtunkhwa on 24.12.2021 but the same was not responded, hence, the instant service appeal was instituted in the Service Tribunal on 24.02.2022.

The appeal is admitted for regular hearing subject to all just legal objections. The appellant is directed to deposit security and process fee within 10 days. Thereafter notices be issued to respondents for submission of reply/comments. To come up for reply/comments on 25.04.2022 before S.B.

Application for suspension of impugned order dated 23.12.2021 has also been submitted with memo of service appeal which is also served on the respondents for submission of their reply. The impugned transfer order dated 23.12.2021 is suspended, if not already acted upon, till the date fixed
