JUDGEMENT

FAREEHA PAUL, MEMBER (E): The service appeal in hand has been instituted under Section 4 of the Khyber Pakhtunkhwa Service

Tribunal Act, 1974 against the order dated 07.01.2020 whereby the appellant was removed from service, against which his departmental appeal was not decided within the statutory period of ninety days.

- 2. Brief facts of the case, as given in the memorandum of appeal, are that the appellant was serving as Assistant (BPS-16) in the respondent department. He was served with a show cause notice containing some allegations which were replied by the appellant by negating the same. An FIR was also registered against him and when he came to know about the same, he got bail from the court of competent jurisdiction. To his utter surprise, the appellant was removed from service without issuing any charge sheet and conducting regular inquiry or affording an opportunity to defend himself. Feeling aggrieved from the impugned order of removal from service dated 07.01.2020, the appellant filed a departmental appeal before the Secretary Information Department, Khyber Pakhtunkhwa (respondent No. 2) but despite the expiry of statutory period of ninety days, the appeal was not decided; hence the instant service appeal.
- 3. Respondents were put on notice who submitted written replies/comments on the appeal. We have heard the learned counsel for the appellant as well as the learned Additional Advocate General for the respondents and perused the case file with connected documents in detail.
- 4. Learned counsel for the appellant contended that the impugned order was against the law, rules and principle of natural justice. She further contended that a fact finding inquiry had been shown to be conducted

against the appellant but in fact no such inquiry had been conducted. She stated that no charge sheet/statement of allegations was issued to the appellant and no opportunity of defence was provided to him. She further stated that no statement of any witness was recorded nor any opportunity of cross examination was provided to him. She further contended that the competent authority, without waiting for outcome of the trial, issued the impugned order. Learned counsel further provided the judgment dated 20.02.2021 of Judicial Magistrate-VIII Peshawar through which the appellant had been acquitted of the charges framed against him in case FIR No. 412 dated 05.12.2018 u/s 419-420-468-471-109 PPC P.S Gulberg, Peshawar.

5. The learned Additional Advocate General, on the other hand, contended that since his appointment, the appellant never performed his official obligations with honesty and dedication. He stated that entire service of the appellant was full of his unruly conduct which include absence from duty, misbehavior, use of abusive language with media persons and office colleagues. He remained involved in impersonation as well as anti-state activities. The learned AAG presented the entire record of conduct of the appellant before the Bench which had also been annexed with the reply. As far as departmental appeal of the appellant was concerned, the learned AAG invited attention of the Tribunal to an order dated 03.07.2020 of appellate authority through which major penalty of removal from service had been confirmed upon the accused official.

After hearing the arguments and going through the record available 6. before us, it is clear that the appellant while appointed as Assistant in the Information Department indulged himself in activities that were not acceptable to his higher authorities. Record presented before us indicates various posts uploaded by him on social media on his account which was a breach of code of conduct for a civil servant. Record further provides reports of his higher authorities on his absence from duty on numerous days, explanations on account of low performance, rude behavior and abusive language and also an advice issued to him on his frequent absence from duty as well as treatment of his willful absence as leave without pay. Three inquiries conducted against him are available on record produced before us. One of the inquiries was on use of abusive language against some reporters, rude behavior with his incharge officer and frequent absence from duty on completion of which he was issued a censure. Another inquiry was conducted on the charges of aggrandizement as he was found claiming to be the PRO to Chief Minister Khyber Pakhtunkhwa, on social media. Record indicates that he was issued a show cause notice on indulging himself in political activities and delivering provoking public statements and posts against the state institutions on social media, for which he submitted an affidavit (Bayan-e-Halfi) that he would be respectful to the state institutions and would not indulge in political activities or anti-state activities in future. Third inquiry was conducted on charges of impersonation during competitive examination for the post of Tehsildar/Naib Tehsildar in Board of Revenue. It was as a result of the last

inquiry that the appellant was removed from service. Perusal of show cause notice dated 06.12.2019 reveals that competent authority of the appellant was satisfied that he had committed the acts/omissions which resulted in issuing of that specific show cause notice. It stated as follows:-

"I am satisfied that you have committed the following acts/omission specified in Rule 3 of the specified rules:-

That as per inquiry conducted by the Khyber Pakhtunkhwa Public Commission, you have rendered yourself guilty of misconduct by committing the illegal act of impersonation during the competitive examination conducted by the KPPSC for the post of Tehsildar/Naib Tehsildar from December 4-8, 2018 wherein you were found present in the Examination Centre at Government Higher Secondary School No. 3 Peshawar Cantt on the first day of the exam during the English paper appearing in place of Hazrat Noor S/O Jannat Noor Roll No. 1700 (the candidate) and an FIR No. 412 dated 04.12.2018 was registered against you and the co-accused by the Police Station Gulberg Peshawar."

- Removal order dated 07.01.2020 mentions about the charge sheet, evidence on record, reply of the accused official as well as previous record, which resulted in his removal from service. Although the appellant has submitted in his service appeal that his departmental appeal dated 23.01.2020 has not been responded but an appellate order dated 03.07.2020 is available with the reply which states as follows:-
- "3. AND WHEREAS, the appellate authority heard the ex-official in person and also perused the record on file. During the hearing, he did not put before any new defence rather requested to withhold the

proceedings on the plea that the case is subjudice in the court of law.

He further requested for yet another chance to mend his ways and would restrain from such illegal acts in future.

- 4. AND WHEREAS, the representative of Directorate General Information and PRs further produced fresh posts of the ex-official on the same lines which testifies that he is not mending his ways rather finding lame excuses.
- 5. AND WHEREAS, the stance of the ex-official that the matter is subjudice, is not tenable as the court is looking after the criminal aspect of the matter, whereas, the instant case is of disciplinary nature under Khyber Pakhtunkhwa Civil Servants (Efficiency & Discipline) Rules, 2011.
- 8. After going through the above mentioned process, the appellate authority confirmed the major penalty of removal from service on the appellant. An important point to be considered here is that there is difference in the show cause notice and the removal order. If the show cause notice is taken into consideration, one must look into the order of the judicial Magistrate-VIII Peshawar dated 20.02.2021 which has acquitted the appellant from charges in case FIR No. 412 dated 05.12.2018 u/s 419-420-468-471-109 PPC of P.S Gulberg Peshawar based on insufficient and trembling evidence. If the show cause notice is silent on the participation of the appellant in political activities and posting provocative statements on his social media account, how can the appellate authority awarded him any punishment on that account? It seems there is disjoint in the show cause notice and the appellate order. The charges on



- 2. That while serving in the same capacity, the appellant was served with show cause notice, containing some baseless allegations, which was replied by the appellant negating the same. (Copy of show-cause notice and reply are attached as annexure "A" & "B").

3. That a concocted and false FIR was also registered against the appellant and when the appellant came to know about the same the appellant got bail from the court of competent jurisdiction. (Copy of the FIR and court order are attached as annexure "C" & "D")

- 4. That the utter surprise of the appellant, the appellant was removed under the law of jungle, without issuing any charge sheet or conducting regular inquiry or affording an opportunity to defend himself. (Copy of the impugned order is attached as annexure "E").
- s. That feeling aggrieved from the impugned order, the appellant filed a departmental appeal before Respondent No.2 however, despite the expiry of statutory period of 90 days, the respondent No.2 failed to decide the departmental appeal of the appellant, hence filing the instant appeal on the following grounds inter-alia:- (Copy of the Departmental appeal is annexure "F")

GROUNDS:

A. That the impugned order is against the law, rules and principle of natural justice, void abinitio, hence liable to be set aside.

- B. That though a fact finding inquiry has been shown to be conducted against the appellant however no such inquiry has been conducted. It is worth mentioning that fact finding inquiry has no where mentioned in E & D rules 2011 or in any other laws.
- C. That no charge sheet alongwith statement of allegation was issued, nor did opportunity of defense has been provided to the appellant.
- D. That no regular inquiry has been conducted which is mandatory before awarding major penalty.
- E. That no statement of any witness was recorded nor opportunity of cross examination has been provided to the appellant.
- F. That though FIR was registered against the appellant however, the competent authority, without waiting for outcome of the trial,

issued the impugned order in a cursory manner.

- G. That the allegations leveled against the appellant are false, frivolous and based on malafide and there is no single piece of evidence against the appellant.
- H. That the frivolous allegations were required probe however no such probe was conducted nor did the appellant was confronted with anything.
- I. That right of fair trial has not been provided to the appellant as guaranteed by Article 10-A of the constitution of Islamic Republic of Pakistan, 1973.

J. That no opportunity of personal hearing has been provided which is evident from the impugned order.

- **K.** That since the impugned order, the appellant is jobless.





Prayer:

On acceptance of the instant departmental appeal, the appellant may kindly be reinstated into service with all back benefit by setting aside the impugned order dated 07/01/2020 Respected Sir,

The appellant submits as under;

- 1. That the appellant was serving as Assistant (BPS-16) in your departmental and since his appointment the appellant served the department with great zest, zeal and enthusiasm.
- 2. That while serving in the same capacity, the appellant was served with a show cause notice, containing some baseless allegations, which was replied by the appellant negating the same. (Copy of show cause notice and reply are attached as annexure "A" & "B").
- 3. That a concocted and false FIR was also registered against the appellant and when the appellant came to know about the same the appellant got bail him the court of competent

jurisdiction. (Copy of the FIR and court order are attached as annexure C & D)

- 4. That, the utter surprise of the appellant, the appellant was removed under the law of jungle, without issuing any charge sheet or conducting regular inquiry or affording an opportunity to defend himself. (Copy of the impugned order is attached as annexure E)
- 5. That the appellant, having no other adequate remedy, hence filling the instant appeal on the following grounds:

GROUNDS:

- A. That the impugned order is against the law, rules principles of Natural Justice, void ab-initio, hence liable to be set aside.
- B. That though fact finding inquiry has been shown to be conducted against the appellant however no such inquiry has been conducted. It is worth mentioning that fact finding inquiry has no where mentioned in E & D rules 2011 or in any other laws.
- C. That no charge sheet alongwith statement of allegation was issued, nor did opportunity of defence has been provided to the appellant.

- D. That no regular inquiry has been conducted which is mandatory before awarding major penalty.
- E. That no statement of any witness was recorded nor opportunity of cross has been provided to the appellant.
- F. That though FIR was registered against the appellant however the competent authority, without waiting for outcome of the trial, issued the impugned order in a cursory manner.
- G. That the allegations leveled against the appellant are false, frivolous and based on malafide and that is no single piece of evidence against the appellant.
- H. That the frivolous allegations were required probe however no such probe was conducted nor did the appellant was confronted with anything.
- I. That right of fair trial has not been provided to the appellant as guaranteed by Article 10-A of the constitution of Islamic Republic of Pakistan, 1973.
- J. That no opportunity of personal hearing has been provided which is evident from the impugned order.
- K. That since the impugned order the appellant is jobless.

- 4. **AND WHEREAS**, the representative of Directorate General Information & PRs further produced fresh posts of the ex-official on the same lines which testifies that he is not mending his ways rather finding lame excuses.
- 5. AND WHEREAS, the stance of the ex-official that the matter is subjudice, is not tenable as the court is looking after the criminal aspect of the matter, whereas, the instant case is of disciplinary nature under Khyber Pakhtunkhwa Civil Servants (Efficiency & Discipline) Rules, 2011.

WRITTEN REPLY ON BEHALF OF RESPONDENTS NO. 1 to 3

PRELIMINARY OBJECTIONS

- 1. That the appellant is estopped by his own conduct to file the present appeal.
- 2. That the appellant has not come to the tribunal with clean hands.
- 3. That the appellant's claim is based on misstatement to misguide the Tribunal, therefore, his appeal is liable to be dismissed.
- 4. That no legal right of the appellant has been infringed, therefore, the appeal is neither competent nor maintainable.

RESPECTFULLY SHEWETH:

REPLY ON FACTS

1. That Para 1 of the appeal is true to the extent that the appellant joined the Directorate General Information & PRs, Khyber Pakhtunkhwa as Assistant (BS-16) in December 2013 (Annexure-I). Rest of the Para is incorrect as since his appointment, he never performed his official obligations with honesty and dedication. Rather during his entire service career spanning over a period of more than six (06) years, he has proved himself as a constant source of nuisance for the Directorate as well as the Administrative Department by his unruly conduct. The appellant mostly remained absent from duty, fought with media person(s) and office colleagues, remained involved in impersonation as well as anti-state activities that earned a bad name for the department. The disciplinary actions initiated against him on numerous occasions speak volumes of his negligence and non-seriousness towards official responsibilities (Copies of the explanations called from him are enclosed as Annexure-II, without pay orders as Annexure-III, charge sheets and statement(s) of allegations as Annexure-IV, Inquiry reports as Annexure-V, Censures etc. as Annexure-VI, suspension order as Annexure-VII, and Show Cause Notices as Annexure-VIII).

- 2. That Para 2 of the appeal as drafted by the appellant is incorrect as the Show Cause Notice(s) (Annexure-VIII) served upon him are fully in consonance with the rules and based on undeniable facts. Every time he failed in defending the charges mentioned against him in the Show Cause Notice(s).
- 3. That the F.I.R No. 412 dated 04-12-2018 registered against the appellant u/s 419-420-468-471-109 at Police Station Gulberg Peshawar (Annexure-IX) is not false or concocted one as stated by the appellant in his appeal. The same was registered against him after he was caught red-handed by the invigilating staff in the Examination Centre at Government Higher Secondary School No. 3 Peshawar Cantt: while appearing in place of a candidate Mr. Hazrat Noor s/o Jannat Noor, Roll No. 1700 in the English Paper of the competitive examination conducted by the Khyber Pakhtunkhwa Public Service Commission for the post of Tehsildar/Nail Tehsildar.
- 4. That Para-4 of the appeal is incorrect as the appellant was removed from service under the Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011 (Annexure-X) after being found guilty of misconduct and following his failure to defend himself against the charges mentioned in the Show Cause Notice(s). Though a number of opportunities were provided to him to mend his ways but he failed to do so and ultimately the competent authority was having no other option but to impose upon him the major penalty of 'Removal from Service'.
- 5. That Para 5 of the appeal is also incorrect as the appellant in pursuance of his departmental appeal was heard in person by the Respondent No.2 i.e. the Secretary Information & PRs being the appellate authority and the major penalty of 'Removal from Service' imposed upon him by the appointing authority was confirmed vide Office Order Endst: No. SO.Estt: (INF)4-115/2018 dated 03-07-2020 (Annexure-XI).

ON GROUNDS:

- A. Ground A of the appeal as drafted by the appellant is incorrect as the office order with regard to his removal from service (Annexure-X) is in line with law, rules and principles of natural justice. It is the conduct of the appellant that cost him his service.
- B. Ground B of the appeal is also incorrect as an Inquiry against the appellant was conducted by a 2-member Inquiry Committee of the Khyber Pakhtunkhwa Public Service Commission wherein he

was found guilty of impersonation (Inquiry Report as Annexure-V).

(

- C. In reply to Ground C of the appeal, it is submitted that the appellant was served with a Show Cause Notice under Rule-7 of the Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011 wherein he was asked to show cause as to why the tentatively decided penalty of 'Removal from Service' should not be imposed upon him and also to intimate whether he desires to be heard in person. The appellant instead of coming for personal hearing preferred to send a written reply through his son on December 23, 2019 wherein he pleaded that the Show Cause Notice served upon him may graciously be recalled and no action be taken against him till the fate of the case through court. His son, who met the DG, was advised to tell his father to meet the competent authority and defend the charges as mentioned in the Show Cause Notice against him but he didn't turn up. He also never bothered to receive the repeated telephonic calls made on his Cell phone thus losing the opportunity to defend his case. Furthermore, despite being a Government servant he participated in political activities, delivered provoking public statements and made posts against the State institutions via social media platforms thereby rendering him guilty of misconduct (Annexure-XII).
- D. That the appellant has been proceeded under the Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules, 2011 by the competent authority and removed from service after he failed to defend the charges leveled against him in the Show Cause Notice(s), which were served upon him under Rule 7 of ibid Rules.
- E. As Ground B and C above.
- F. As Para-4 of the reply on Facts above.
- G. Ground G of the appeal is devoid of facts as the Inquiry Report of the KPPSC in the impersonation case and documentary proofs of his participation in the political activities, delivering provoking public statements and doing posts against the State Institution

via Social Media platforms as mentioned in the Show Cause Notice(s), is sufficient and irrefutable evidence against the appellant.

- I. As Ground C above.
- J. As Ground C and G above.
- K. Ground K of the appeal pertains to appellant's personal life.
- L. As Ground A above.
- M. As Para-5 of the reply on Facts and Ground C above.

It is, therefore, most humbly prayed before this Hon'ble Tribunal to dismiss the instant appeal of the appellant with costs.

Reference this office letter No.INF/5310-12 dated 20th November 2015, regarding the enquiry of Charge Sheet served to Syed Anwar Assistant, Directorate of Information, Khyber Pakhtunkhwa, Peshawar.

In order to probe the issues mentioned in the Charge Sheet para No.1, the undersigned visited the office of Daily Ausaf Peshawar, Bureau Office Khyber Supper Market, Bara Road, Peshawar Cantt. The matter of misbehavior and rudeness of Syed Anwar, Assistant with the Bureau Chief of Daily Ausaf and its staff members was discussed with Bureau Chief Daily Ausaf Mr. Faridullah Khan. The complainant. Mr. Faridullah Khan told the undersigned that the said Assistant rang up one of his staff members and got wanted to know the source of one of the news published in Daily Ausaf. He pressed and insisted repeatedly to get know about the source using dictating language. As the telephonic argument between them went longer, the bureau chief asked his staff members, let him talk to the Information staff who was on telephone from the other side. According to Mr. Faridullah Khan, he tried his best to calm down the Assistant online but the argument went warm instead to calm down. He admitted that when the Assistant did not try to listen the argument and kept try giving dictation, then exchange of harsh words started from both sides.

During discussion, the undersigned tried to get Mr. Faridullah Khan know that the official in question was an Assistant and deputed in the PI Section a few days back. He did not know most of the journalists and even journalistic ethics. Mr. Faridullah after detail discussion on the subject was convinced that the official was inexperienced and also tendered his apology. Mr. Ansarullah, Station Director Pakhtunkhwa Radio FM 92.2 MHz, Peshawar also played an important role to reconcile the issue.

Moreover, Syed Anwar, Assistant also admitted his mistake verbally and in writing. He also admitted that he had not only by-passed his immediate Incharge of the Section but also misused his power while dealing with a senior journalist about the issue which was not his mandate.

His rudeness and aggressive attitude with his seniors and staff members was also investigated and as alleged in the charge sheet vide para-II.

However, he also has given the explanation of said para in his written reply. The rudeness, aggressiveness and loose of temperament was found in his behavior. He also has admitted such bad aspect of his personality. He has counted a number of reasons behind such unwanted aspect of his life, such as domestic and family problems as well as minor mental disorder for purpose he has received treatment from renowned psychiatric physician of Peshawar.

Moreover, the other allegations such as leave without prior permission from competent authority and late coming could not be denied. However, on the other hand he has the potential as well as commitment to improve his performance and behavior.

However, Mr. Syed Anwar, Assistant has breached disciplinary rule and deserved to take minor disciplinary action under the Govt: of Khyber Pakhtunkhwa, Efficiency & Discipline Rule 2011.

- 2- Sayed Anwar explained his position before the undersigned and also submitted his reply in writing.
- 3- I am of the view that the official is highly qualified person and has been working as PRO to Chief Minister right from the day first.
- 4- Sayed Anwar earlier had been working as PRO to different provincial ministers.
- 5- There are examples of other officials who are not officers but are working as PROs to various ministers.
- 6- Though the undersigned did not find any reason to hold Sayed Anwar as guilty, however, he has apologized and pledged in his written reply that he will not repeat if it's a mistake.

Recommendations:

- 1- It is recommended that any charge leveled against him may be withdrawn.
- 2- The individual is performing his duties well so he may not be disturbed by transferring him.



INQUIRY REPORT

Subject:

IMPERSONATION IN THE COMPETITIVE EXAMINATION HELD FOR THE POST OF TEHSILDAR/NAIB TEHSILDAR

FROM 04 TO 08 DECEMBER 2018

The Competent Authority was pleased to constitute an Inquiry Committee comprising the following Members of Khyber Pakhtunkhwa Public Service Commission vide No.KP/PSC/Admn/FF-602/000184 dated 02-01-2019:-

i) Mr.Qudratullah Khan Member-VI Chairman

ii) Mr. Manzoor ul Haq Member-VII Member

2. TORs of the Inquiry Committee shall be as under:-

Jannat Noor Roll No.1700 (candidate) and Mr Arif Wazir S/O Ahmad Khan Wazir (impersonator) during Competitive Examination held from 04-12-2018 to 08-12-2018 for the post of Tehsildar/Naib Tehsildar in Board of Revenue advertised vide Khyber Pakhtunkhwa Public Service Commission Advertisement No.01/2018 & 02/2018.

3. BRIEF HISTORY

The PSC conducted competitive examination for the post of Tehsildar/Naib Tehsildar from 4 to 8 December 2018. During the English paper in the examination centre at Government Higher Secondary School No.3 Peshawar Cantt, on the first day, the Supervisory Staff noticed that the photograph furnished to the PSC by a candidate, Hazrat Noor S/O Jannat Noor, Roll No.1700, and affixed on the attendance sheet was not that of the candidate concerned (Annexure-I). This person taking the paper as Hazrat Noor, when questioned, identified himself as Arif Wazir. He gave a written statement admitting his appearing in the exam in place of Hazrat Noor. He was handed over to the Police where he identified himself as Syed Anwar. An FIR No. 412 dated 04-12-2018 u/s 419-420-468-471-109 was registered against him and his accomplice Mr Hazrat Noor at Police Station Gulberg Peshawar (Annexure-II). The case has been challaned to the Court.

4. PROCEEDINGS

The Inquiry Committee held its proceedings on 23 January, 04 and 12 February, 11 and 19 March and 18 April, 2019. The officials on duty in the examination centre and the accused persons were called to appear before

M

the Inquiry Committee. All except the candidate, Hazrat Noor, complied the instructions. Hazrat Noor was sent letters on his known address (Annexure-III) and was also called on telephone by Mr Kashif Adnan, Assistant of PSC (Annexure-IV). He managed to return the registered post undelivered and disowned the Cell No.0333-9333292 he had given in his application forms. He had applied to the PSC a number of times (Annexure-V). Later he managed to send a letter to the PSC/Committee through a lawyer conveying that the case was sub-judice and the Inquiry Committee should not proceed in it (Annexure-VI). The Committee consulted the Legal Advisor PSC who opined as under:

"In light of Establishment Department letter No.SOR(S&GAD) 5-(29)/86(kc) dated 08.01.1990, Departmental Inquiry and Judicial Proceeding can run parallel to each other against the accused/official".

Hence the Inquiry Committee proceeded with the inquiry accordingly.

5. Mr Rizwanullah, Deputy Director PSC

Appearing before the committee on 23-01-2019, Mr Rizwanullah, Deputy Director, said that he was deputed as inspection supervisor to three examination centres including GHSS No.3 Peshawar Cantt. While he was in the examination hall in GHS Salwan, Mr Rafiullah, Naib Qasid, informed him on phone about the incident. He rushed to the examination hall where Syed Anwar had been appearing in place of Hazrat Noor. When asked the accused did not produce his original CNIC. He instead produced the photocopy of an Identity Card bearing his photo and the particulars of Hazrat Noor. The accused recorded his statement and was handed over to the police. Statement of Inspection Supervisor is at **Annexure-VII**.

6. Mr Abdul Saeed, Principal GHSS No.3 Peshawar Cantt.

Mr Abdul Saeed, Supervisor, appeared before the Inquiry Committee on 04-02-2019. He stated that while inspecting the exam hall he checked the Identity Card of the person sitting for Roll No.1700. It looked different from the usual Identity Card (copy at Annexure-VIII). On checking he found the photograph of the Identity Card different from the photograph provided to the PSC with the application form. He took a photo of the accused so as to preserve the proof and handed him over to the Police. His statement is at Annexure-IX.

In his written statement Syed Anwar, the accused has recorded his name as Arif Wazir S/O Ahmad Khan Wazir. His statement reads as "I hereby confessed that I was deceived by my friend Hazrat Noor who requested me

to kindly appear for one of the paper of English of Tehsildar exam. He further told me that he has taken Mr Mumtaz of KPPSC into confidence. Hence I came into the examination hall. I am apologized for mistake and I will never repeat this mistake". The statement is at Annexure-X.

7. Mr Kausar Ali, Superintendent PSC

Mr Kausar Ali appeared before the Inquiry Committee on 12-02-2019. He stated that he was on duty as Deputy Supervisor at the examination centre at GHS No.3 Peshawar on 04 April 2019. When taking attendance he asked the person appearing as candidate in place of Hazrat Noor to show his Identity Card, who produced a duplicate NIC wherein the photo did not tally with that of the attendance sheet. This led him to suspect the person. He handed him over to the Principal of the School who was the Supervisor of the examination hall for further action. Statement of Deputy Supervisor at Annexure-XI.

Syed Anwar (Accused Impersonator)

Syed Anwar who is an employee of the Information Department Khyber Pakhtunkhwa, at first did not appear before the Committee. When a letter No. KP/PSC/Admn/GF-590/004967 dated 06-03-2019 was issued to the Director General Information Department (Annexure-XII) requesting him to direct Syed Anwar to attend the inquiry proceedings, then he appeared before the Inquiry Committee on 11-03-2019. He stated that he accompanied Hazrat Noor on his request to the examination hall to boost his morale. On the way to the hall Arif Wazir also got into their car. Hazrat Noor had however informed him two days earlier that he had spoken to Mumtaz Khan, an official of the PSC, who would help him in impersonation against a payment of Rs.1,50,000/- per paper. Thus he asked Syed Anwar to appear in the examination in his place who declined. Then Hazrat Noor asked Arif Wazir who agreed to do so. The three reached the examination hall. Arif wazir went inside the hall and the other two stayed outside. Arif Wazir came out after a short while and then Syed Anwar requested the staff on duty to give Hazrat Noor a chance. Arif Wazir disappeared from the scene in the mean time. The staff impounded Syed Anwar and asked him to produce Arif Wazir and Hazrat Noor otherwise they would not let him go. He called Hazrat Noor on phone but he chose not to come back. The staff handed him (Syed Anwar) over to the Police. The picture taken by the Superintendent in the examination hall confirmed Syed Anwar was taking paper in the hall (Annexure-XIII). Moreover, the Deputy Supervisor identified him before the Inquiry Committee. Syed Anwar, further stated that Mumtaz Khan came to him with the request not to mention his name to the Inquiry Committee. After two three days they met at Pishtakhara chowk and Mumtaz repeated the request. Mumtaz Khan came to him again and spoke to him on telephone the day he was appearing before the

Inquiry Committee. He asked him not to appear before the committee. Syed Anwar did not oblige Mumtaz Khan. He provided telephone No. 0331-4488388 on which Mumtaz had called him that day that is on 11th March, 2019. His statement is at **Annexure-XIV**.

9. Mumtaz Khan (Assistant PSC)

Mumtaz Khan appeared before the Inquiry committee on 23-01-2019. He said that he was on duty at GHS NO.2 Peshawar City. He learned that some individual appearing in the exam in another hall had accused him of having struck a deal with him to help him in impersonation. He denied the allegation of striking a deal with Hazrat Noor. He also denied having any contact with both the accused persons. His statement is at Annexure-XV. Mumtaz Khan appeared again when Syed Anwar appeared before the Committee on 11th March 2019. This time he said that he had gone to the Police station after learning from a colleague in the office that an arrested person had blamed him for allowing him to appear in place of a candidate namely Hazrat Noor for a payment of Rs.1,50,000/-. According to Mumtaz Khan-the accused mentioned his name so as to save their skin. He met both Mr Hazrat Noor and Syed Anwar and asked them as to why they had misused his name. He asked them to appear before the Inquiry Committee and tell the truth. He did not mention these facts in his first statement. He said he wanted to disclose this information on an appropriate time. He apologized for holding back the information. His statement is at Annexure-XVI.

10. Atlas Khan(Superintendent PSC)

Atlas Khan appeared before the Inquiry Committee on 24-04-2019. Syed Anwar had accused Mumtaz Khan of calling him on phone in an effort to refrain him from appearing before the Inquiry Committee. He furnished the phone No.0331-4488388 from where he received a call the same day. The number was located. It belongs to Mr Atlas Khan, Superintendent PSC. When inquired Mr Atlas Khan stated that the SIM was in use of his son, Muhammad Arif. His statement is at Annexure-XVII.

11. Muhammad Arif

Muhammad Arif, the son of Atlas Khan, appeared before the Committee on 26-04-2019. He denied having ever lent his phone to Mumtaz Khan. He claimed that he was away for Tableegh in Lahore on the said date. His statement is at **Annexure-XVIII**.

12. FINDINGS

Examining the statements of all those appeared before the Inquiry Committee, hearing and cross examinations, the Inquiry Committee reached the conclusion that the act of impersonation has taken place. The statements recorded by the staff supervising the examination hall are without any ambiguity. The Inquiry Committee's findings are given as under:

- a) Hazrat Noor did not appear before the Committee. Had the impersonation not aborted, he would have been the beneficiary in the case. He managed to return the letters sent to him undelivered, attended once a phone call made by Kashif Adnan, Assistant of PSC and despite promising to attend the inquiry proceedings, chose not to appear before the Committee. He did not attend the phone calls made by the Assistant afterwards. He also arranged a letter from a lawyer asking the Committee not to proceed in the matter as the case was sub-judice.
- b) Hazrat Noor applied for the post of Tehsildar/Naib Tehsildar and did not appear in the examination. If there was a genuine reason for his absence, he would not have refrained from appearing before the Inquiry Committee and telling the truth.
- Government of Khyber Pakhtunkhwa, was present in the examination half, as supported by the statements of Supervisory staff, including Hall Incharge Principal of GHSS No.3 Peshawar Cantt. He had posed himself as Arif Wazir. An FIR No.412 u/s 419-420-468-471-109 dated 04-12-2018 was registered in Police Station at Gulberg Peshawar against the accused persons.
- d) As far as the role of Mumtaz Khan is concerned, he has made two statements. He initially denied having any contacts with Hazrat Noor and Syed Anwar. But in his second statement he admitted having met them and once visited the Police Station to meet Syed Anwar who was then in Police custody. Syed Anwar has accused him of collusion with Hazrat Noor and has levelled allegations against Mumtaz Khan for accepting of Rs.1,50,000/- per paper as gratification from Hazrat Noor and trying to stop the two accused from appearing before the Committee. The accused, Hazrat Noor, who is said to have struck a deal with Mumtaz Khan did not appear before the Committee. Syed Anwar said he had received a call from Mumtaz Khan mobile No. 0331-4488388 at 10.36am on 4th April. The snapshot is at Annexure-IXX.

Mumtaz Khan denied having called him at that time. The Committee traced the owner of the mobile sim, namely Atlas Khan Superintendent, PSC. He appeared before the Committee on 24-04-2019 and admitted the ownership of the mobile sim. But he said that the sim was under the use of his son Muhammad Arif. His son Muhammad Arif appeared on 26-04-2019 before the Inquiry Committee and stated that he was away for Tableegh from 05-02-2019 to 17-03-2019 and no one else has used his mobile phone during this period.

Keeping in view the above proceedings, no evidence was produced against Mumtaz Khan except the statement of Syed Anwar which has created doubt about his role.

13. <u>RECOMMENDATIONS</u>

- i) Keeping in view the facts and statements of all concerned, the Inquiry Committee is of the view that both the persons, namely Hazrat Noor and Syed Anwar are held guilty of illegal act of impersonation. In this regard an FIR has been registered against them at Police Station, Gulberg Peshawar and criminal proceedings are under way. The Competent Authority may impose suitable penalty/punishments as provided in PSC Regulation 18 against Hazrat Noor and Syed Anwar.
- ii) Since Syed Anwar is an employee of the Information Department Government of Khyber Pakhtunkhwa, the Commission may inform his parent department for action as deemed appropriate.

iii) The Competent Authority may order departmental inquiry against Mumtaz Khan, Assistant PSC to ascertain his involvement in the case.

I, <u>Imdad Ullah</u>, Director General Information & PRs, Khyber Pakhtunkhwa as competent authority, under the Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules, 2011, do hereby serve you, **Syed Anwar**, Assistant, Directorate General Information & PRs, Khyber Pakhtunkhwa as follows:

I am satisfied that you have committed the following acts/omission specified in Rule-3 of the specified rules:-

"That as per inquiry conducted by the Khyber Pakhtunkhwa Public Commission, you have rendered yourself guilty of misconduct by committing the illegal act of impersonation during the competitive examination conducted by the KPPSC for the post of Tehsildar/Naib Tehsildar from December 4-8, 2018 wherein you were found present in the Examination Centre at Government Higher Secondary School No.3 Peshawar Cantt on the first day of the exam during the English paper appearing in place of Hazrat Noor S/O Jannat Noor Roll No. 1700 (the candidate) and an FIR No.412 dated 04-12-2018 was registered against you and the co-accused by the Police Station Gulberg Peshawar".

LIST OF MINOR & MAJOR PENALTIES REFLECTED IN RULES-4 OF KHYBER PAKHTUNKHWA GOVERNMENT SERVANTS (EFFICIENCY AND DISCIPLINE) RULES, 2011

PENALTIES: - (1) The following are the minor and major penalties, namely:-

(A) MINOR PENALTIES:-

- i. Censure;
- ii. Withholding, for a specific period, promotion or increment, subject to a maximum of three years, otherwise than for unfitness for promotion or financial advancement, in accordance with the rules or orders pertaining to the service or post;

Provided that the penalty of withholding increments shall not be imposed on a Government servant who has reached the maximum of his pay scale.

iii. Recovery from pay of the whole or any part of any pecuniary loss caused to Government by negligence or breach of order.

(B) MAJOR PENALTIES:-

 Reduction to a lower post or pay scale or to a lower stage in a time scale for a maximum period of five (05) years;

Provided that on restoration to original pay scale or post, the penalized Government servant will be placed below his erstwhile juniors promoted to higher posts during subsistence of the period of penalty;".

- ii. Compulsory retirement;
- iii. Removal from service; and
- iv. Dismissal from service.
- 2. Dismissal from service under the rules shall disqualify a Government servant from future employment under Government.
- 3. Any penalty under these rules shall not absolve a Government Servant from liability to any other punishment to which he may be liable for an offence, under any other law, committed by him while in service.




