KALIM ARSHAD KHAN CHAIRMAN: The appellant was removed from service on 02.11.2017 due to his absence from duty from 02.08.2017 till the date of his removal from service. Against the

removal from service dated 02.11.2017, he filed departmental appeal on 25.11.2017, which, according to him, was not responded within ninety (90) days and he filed this appeal on 30.10.2018. It is contended in the memo and grounds of appeal that after his appointment the appellant had been performing his duty to the entire satisfaction of his superior; that the impugned order was passed without taking into consideration the stance adopted by the appellant that the impugned order was illegal, arbitrary, without jurisdiction and without lawful authority; that the punishment awarded to the appellant was much harsh; that the appellant was not provided opportunity of hearing.

2. On receipt of the appeal and its admission to full hearing, the respondents were summoned, who on putting appearance contested the appeal by filing written reply raising therein numerous legal and factual objections. The defence setup was a total denial of the claim of the appellant.

3. We have heard the appellant in person and his counsel is not available and he had argued himself and learned Additional Advocate General for the respondents.

4. The appellant himself opted for arguing the appeal as he was unable to produce his counsel and reiterated the facts and grounds detailed in the memo and grounds of the appeal while the learned AAG controverted the same by supporting the impugned order(s). Service Appeal No.1353/2018 titled ⁶Aziz Ur Rehman..vs.Chief Conservator Wildlife, KPK Peshawar and others", decided on 13.07.2022 by Division Bench comprising Kalim Arshad Khan, Chairman, and Fareeha Paul, Member Executive, Khyber Pakhtunkhwa Service Tribunal Peshawar.

This appeal is barred by time. An application for condonation 5. of delay has been filed wherein it was contended that the appellant was engaged in looking after of his ailing wife, who was allegedly suffering from epilepsy and acute backache. The grounds taken in the condonation of delay application are per-se not valid grounds nor the delay of each day has been explained by the appellant. Moreover, even a single prescription regarding the alleged ailment of wife of the appellant could not be annexed with the application for condonation of delay. As against that, while following the procedure prescribed in Rule-9 of the Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011, the department had, in the first instance, sent a notice to the appellant on his home address i.e Sarat Khel Tehsil and District Karak through registered post. During the course of arguments, the appellant had urged that the notice was not sent on the accurate address as village Sarat Khel was a big village, and, he could not receive the notice. This contention of the appellant is not well founded because in his own memo of address, given in the heading of appeal, the appellant has given the same address as is mentioned in the impugned order. When the notice was received back un delivered, the department issued letter to the Director Information, Khyber Pakhtunkhwa for publication of notice in two leading newspapers, directing the appellant to resume duties within fifteen (15) days of the publication of the notice but despite that the appellant did not resume the duties. In accordance with Rule-9 above, the department has published notice in two leading newspapers i.e Daily Aaj, Peshawar

and Urdu Daily Mashriq, Peshawar, therefore, the department has proceeded against the appellant strictly in accordance with the provision of Rule-9 of the Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011, which the appellant could not rebut. Therefore, the appeal being barred by time as well as the bereft of any valid reason is dismissed. Cost shall follow the event. Consign.





JOINT PARAWISE COMMENTS ON BEHALF OF RESPONDENTS NO. 1 TO 4 FACTS: RESPECTFULLY SHEWETH:

Preliminary Objections:

- 1. That the appellant has got no cause of action.
- 2. That the appeal is barred by law.
- 3. That this Honorable Tribunal lack jurisdiction to adjudicate upon the matter.
- 4. That the appeal is bad for non-joinder and mis-joinder.

ON FACTS:

1. Correct to the extent of appointment but performance of appellant during service was not satisfactory as sufficient explanations for his willful absence from duty were called and also censured on the habitual absentee charges by the competent authority but he did not change his behavior and later on he was removed from service on the same repeated absentee charges after observing all the required codal formalities i.e. notice in the newspaper and charge sheet etc. as per E&D Rules, 2011. The detail of established absent period is as under:-

2. Incorrect. The respondent No.3 observed all the required codal formalities as per E&D Rules, 2011 and removed the appellant from service as explained in Para-I. The show cause notice (Annex-E) on his home address was sent and notice published in the newspapers (Annex-F & G) but not responded by the appellant. Complete detail given in the order No.03, dated 02/11/2017 regarding removal from service of the appellant.

- 3. The departmental appeal was not maintainable as the charges of willful absence from duty of the appellant has been proved and all the codal formalities in the case were completed, therefore, the action taken by the respondent No.3 against the appellant regarding removal from service is proper as per rule No.9 of E&D Rules, 2011.

- c) Incorrect. The requisite order is according to the law.
- d) Incorrect. The penalties imposed by the respondent No.3 is under rule-4 (b) major penalties and covered rule-9 (procedure in case of willful absence) of E&D Rules, 2011.
- e) Incorrect. Sufficient opportunities were given but the appellant did not change his habit as he was habitual in absentee and did not perform official duty. Proper record is available in office; therefore the removal from service of the appellant is justice with him as per rules.
- f) Incorrect. The removal from service of the appellant is justice with his own conduct as who have to think of his family member during service.

The notice was however received back as undelivered.

The notice published in daily news paper Aaj on 8-10-2017.

The official however neither joined / resumed his official duty nor any written response received from his side even after expiry of the stipulated period of fifteen days given in the notice so published in the news paper.
