


Execution Petition 131/2022 Gul Mena Vs. Police Department

## ORDER

Ex-Lady Constable Gul Meena No.5704/424-T was awarded major punishment of dismissal from service by the then SP HQrs vide OB No.3077 dated 17.08.2015 on the charges that she while undergoing course at PTC she captured her own objectionable pictures and videos and shared with her friends via internet which is highly objectionable and against the discipline of the force.

In this regard she was filed departmental appeal before W/CCPO against above punishment orders which was rejected/filed by the then CCPO, Peshawar vide order No.5222-29/PA dated 03.11.2015.

Now, Ex-Lady Constable No.5704/424-T has submitted an application along-with court Judgment, wherein the Hon'able Service Tribunal ordered that **"the impugned orders dated 13.8.2015 and 18.04.2019 are set aside and the appellant is re-instated in service with all back benefits."**

In light of the Tribunal Judgment, DSP Legal opinion & kind approval of W/CCPO, Ex-Lady Constable Gul Meena No.5704/424-T is hereby conditionally & provisionally re-instated in service with all back benefits subject to the decision of CPLA which is still subjudice in the Apex Court.


