





Respectfully Sheweth;

1. That appellant was appointed as PST BPS-12 on regular basis vide order dated 08-02-2011. (Copy as annex "A")
2. That since then appellant was/is performing his official duties to the entire satisfaction of the superiors wherever posted.
3. That in the seniority list for the year, 2019 circulated amongst the candidates by the department, name of appellant was placed at S. No. 62, seniority number 236 but was dropped for no legal reason. (Copy as annex "B")
4. That promotion to the next higher grade / post of B-14 took place but appellant was ignored for no legal reason and promoted the most junior candidates in order dated 25-05-2019. Appellant name should have been seniority number 236 of the order ibid but he was dropped for no legal reason. (Copy as annex "C")
5. That in subsequent Notification dated 19-01-2021, appellant being most senior was again ignored for no legal reason and most junior in the said seniority list were promoted to next higher grade / post of BPS-14 and were adjusted at various schools vide order dated 28-05-2021. For the first time appellant came to know about the said adjustment order. (Copies as annex "D" & "E")
6. That on 01-06-2021, appellant filed departmental appeal before R. No. 02 which met dead response till date. (Copy as annex "F")


Hence, this appeal, Inter alia on the following grounds:-

GROUND


- a. That ignoring and dropping appellant time and again was the malafide of the department and appellant was not treated at par with others.
- b. That no legal reason was attributed to appellant for not promoting him to the next higher grade/post.

- c. That appellant was discriminated inter-se with his colleagues by violating principle of seniority cum merit. Such act of the respondents is based on ulterior motive.
- d. That promotion is a continuous grievance and can be agitated at any time.
- e. That no heed was paid to the departmental appeal of appellant for no obvious reason.


It is, therefore, most humbly prayed that on acceptance of appeal, the impugned order dated 19-01-2021 be set aside and appellant be promoted to the post of Senior Primary School Teacher B-14 from the date when his juniors were promoted to the said post, with such other relief as may be deemed proper and just the circumstances of the case.




8. That appellant was discriminated inter-se with his colleagues by violating principal of seniority cum merit. Such act of the respondents is based on ulterior motive.


