The matter involved is removal of appellant from service in consequence of his absence read with registration of criminal case against him in his private capacity. The appellant filed departmental representation as stated in Para 11 of the memorandum of appeal, after his release from lock up vide diary No. 11240 dated 24.06.2020. The said appeal was decided by the department on 26.08.2020 and the present service appeal has been filed on 15.09.2020. The impugned order was passed on 12.04.2017. If the limitation for departmental appeal is reckoned from the said date, that is time barred. However, keeping the said issue of time-barrred departmental appeal intact for determination in the course of regular hearing of appeal, let the respondents come with their written reply/comments to justify the validity of their action against the appellant within the parameter of service laws in field, therefore, the appeal is admitted for regular hearing subject to all just and legal objections including of limitation. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents for submission of written reply/comments in office within 10 days after receipt of notices, positively. If the written reply/comments are not submitted within the stipulated time, or extension of time is not sought through written application with sufficient cause, the office shall submit the file with a report of non-compliance. File to come up for arguments on 18.11.2021 before the D.B.





