
Respectfully Sheweth:-

- 11) That respondent No.3 rejected his departmental appeal on 05.11.2020. (Annex "I")


- 12) That appellatant would be suffered if he didn't receive correction in dates i.e. 23.10.2004 instead of 27.10.2004.



4. He will also produce physical fitness certificate from Civil Surgeon, his appointment on probation period will also be subject to his character and antecedent being found satisfactory on verification.

5. His seniority will be determined in accordance with the relevant rules.




