PRAYER:- *Allowing this appeal, order dated be struck down as illegal and not sustainable, accordingly the deducted amount be refunded/imbursed alongwith the immediate release of the held back salaries for the months of Oct 2011 till Oct 2013.*

Respectfully Sheweth,

This service appeal, proceeds on the following main legal points and facts of the case;-

- I. That, appellant joined, her service as Primary Teacher in the year. Copy to **Annexure "A"**
- II. That, respondent/ office of the respondent #3 stopped salary of the appellant without any lawful justification.
- III. That, when the appellant raised voice and made stern and emphatic demand for the release of her salaries, she was robbed in a so

called inquiry and supplementing the earlier wrong, yet by another wrong instead of releasing salaries, deduction was started against her on monthly basis.

IV. That, appellant put up her case, before suspending No.2 but the same was heard back, like a "cry in the desert", hence this appeal.

GROUNDS:-

May it please your good self to put my case before this honourable forum on the following major legal points;

- a. That, the impugned order is patently illegal, against facts and material available on record, hence no tenable.
- b. That, what sense would the deduction would make, when the salaries have not been, paid, altogether.
- c. That, what happened is that, salaries of the appellant were withheld, through misuse of authority

and unlawful exercise of authority, against which, when appellant made strong protest, in order to give blanket cover to malafide acts, a fake drama inquiry was staged, whereby deduction was started to be make.

- d. That, being female, appellant was black-mailed specially when Amjad clerk, received salaries for 9 months with the help of the powerful on his back.
- e. That, work/duty without pay is legally prohibited and deduction is illegal, for and from the amounts which the appellant have not received at all. As such, the circumstance at which the appellant is placed against the principles of natural justice and equity as well.
- f. That, so far the appellant has served the department either without pay or through sub-payments on the device of DEDUCTION.

- g. That, appellant carve leave, to supplement, augment, amend, omitt and delete partial or a whole at the time of final argument or even before that.

It is therefore humbly prayed allowing this appeal, order dated be down as illegal and not sustainable, accordingly the deducted amount be refunded/imbursed alongwith the immediate release of the held back salaries for the months of Oct 2011 till Oct 2013.




