It was contended by the learned counsel representing appellant that appellant submitted an application in the year 2005 for extra-ordinary leave without pay which was sanctioned by the authority concerned, on the expiry of which appellant submitted another application for extension of his leave but it was not responded and appellant submitted his arrival report to the District Education Officer Malakand but in response thereof the concerned authority declined to receive for no obvious reasons. Later on a request for adjustment of appellant as Primary School Teacher was made but no heed was paid. Departmental appeal was moved which was followed by service appeal No. 351/2015 being decided by this Tribunal on 06.11.2019, directing the appellate authority to decide the departmental appeal of appellant by a well reasoned order, the attested copy of the judgment was forwarded to the respondents however, instead of implementing the judgment of this Tribunal respondent No. 3 issued impugned order dated 11.02.2020 on the basis of which appellant has been terminated from service. Departmental appeal was moved without any response within the statutory period hence, the present service appeal.

The point so agitated at the bar needs consideration. The appeal is admitted for regular hearing subject to all just legal objections. The appellant is directed to deposit security and process fee within 10 days, thereafter, notices be issued to the respondents for written reply/comments for 26.04.2021 before S.B.


