

ANY OTHER RELIEF WHICH THIS HONOURABLE TRIBUNAL DEEM APPROPRIATE IN THE CIRCUMSTANCES OF THE CASE MAY ALSO BE ALLOWED TO THE APPELLANT.

Respectfully Sheweth;-

That Facts forming the background of instant service appeal are arrayed as under;-

1. That the appellant was serving as Sweeper in Havelian Courts District Abbottabad. The appellant has rendered more than 17 years of service with zeal and zest.
2. That on 06/03/2021, spouse of the appellant telephonically told that his son Adil studying

in class 2nd is seriously ill. Therefore, the appellant rushed to his house from Havelian to Abbottabad to take him to hospital. The appellant took the passengers from Havelian to Abbottabad in his Carry Dabba just to manage small amount for the bread & butter of his poor family.

3. That on the said day, Senior Civil Judge (Admin) chased the vehicle of appellant and stopped him at general bus stop Abbottabad and thereafter initiated the disciplinary proceedings against the appellant and served with show cause notice reply of which has been submitted by the appellant.
4. That respondent No.2 vide impugned order dated 07/04/2021 removed the appellant from service. Copy of impugned order dated 07/04/2021 is annexed as Annexure "A".
5. That, thereafter the appellant filed Departmental appeal against the impugned order dated 07/04/2021. Reply of the same is

still awaited. Copy of Departmental appeal is annexed as Annexure "B".

6. That feeling aggrieved from the impugned order, the appellant seeks indulgence of this Honourable tribunal for setting aside impugned order dated 07/04/2021 by way of filing of instant appeal before the Honourable tribunal, inter-alia on the following grounds.

GROUND:

- a) That the impugned order is passed by respondent No.2 is illegal, unlawful, against the norms of justice, equity and fair play hence the same is liable to be set aside.
- b) That the impugned act the order of respondent No.2 is harsh in nature and against the fundamental rights of the appellant guaranteed by the constitution of Islamic republic of

Pakistan 1973, thus, is not maintainable and liable to be set-aside.

c) That the appellant has rendered more than 17 years of service with devotion and dedication for the satisfaction of his superiors authorities. The allegations leveled against the appellant did not warrant hash punishment of removal from service.

d) That the appellant has not been provided opportunity of personal hearing and cross-examining the complainant. Besides, prescribed Codel formalities have not been followed.

e) That the appellant has rendered more than 17 years regular service as sweeper. Now at this junctural of life, his dependants are facing starvation and the appellant can not cope with

the unavoidable house hold expenses
being a poor person.


- f) That there is no other prompt,

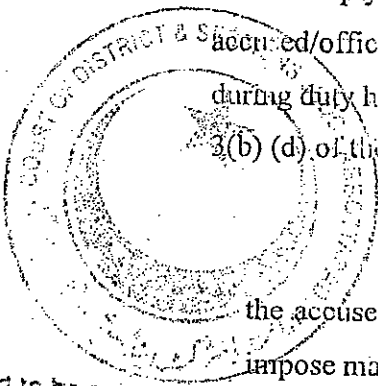
ORDER

Dated Abbottabad the 07th April, 2021

WHEREAS on 6.3.2021, the Senior Civil Judge (Admn) Abbottabad reported that, in the wake of complaints received against Mr. Saeed Akhtar, Sweeper, posted at Tehsil Courts, Havelian, he remained absent and often drive a Suzuki carry van for carrying passengers during duty hours and that on the relevant day he was spotted driving Suzuki carry van with passengers. He was followed up till Abbottabad and after alighting passengers, he along with Suzuki was brought to the Districts Courts, Abbottabad.

WHEREAS, the accused official was caught red handed, which was sufficient to dispense with the inquiry proceedings under Rule 5 (a) of the Khyber Pakhtunkhwa, Government Servants (Efficiency and Discipline) Rules, 2011, hence he was proceeded under Rule 7 of the said Rules and a show cause notice was served upon him. After submission of reply, he was personally heard however in his reply to the show cause notice and during personal hearing, the accused/official did not deny the charges of carrying passengers in his vehicle during duty hours, and therefore charges of misconduct within the meaning of Rule 3(b) (d) of the ibid Rules are proved against him.

NOW, THEREFORE, I being competent authority while finding the accused/official Mr. Saeed Akhtar, Sweeper, guilty of misconduct, hereby impose major penalty of removal from service under Rule 4(1)(b)(iii) of the said Rules.


