That appellant was appointed as Junior Clerk on 10-04-1988, while Muhammad Pervaz was appointed as such on 03-09-1988. And Salah ud Din of D.I. Khan was appointed as such on 20-04-1988.

That the aforesaid incumbents were promoted to the post of Senior Clerk in the year 2007, 2008 while appellant was ignored without assigning any reason and was promoted to the said post in the year 2013.

- 3. That as soon as appellant was cleared for promotion and promoted to the post of Senior Clerk vide order dated 22-07-2019, then the same should have been with effect from the year 2007-08 and not with immediate effect. (Copy as annex "A")
- 4. That department was making further promotion of Junior Clerks and for the purpose letter dated 01-07-2019 was circulated amongst all the authorities requiring them to remit ACRs of the incumbents in connection with their promotion to the rank of Assistant Grade Clerk B-16. This list / letter nowhere figures name of appellant. (Copy as annex "B")
- 5. That the said letter dated 01-07-2019 was assailed in Writ Petition No. 4055-P/2019 before Peshawar High Court Peshawar with Interim Relief and thereafter comments of the department was called for from respondent, who submitted the same along with incomplete seniority list dated 31-12-2018 circulated on 26-03-2019. (Copies as annex "C" & "D")
- 6. That during the pendency of the Writ Petition, appellant filled departmental appeal before the authority on 07-02-2020 to anti date his promotion which met dead response till date. (Copy as annex "E")
- 7. That the said Writ Petition came up for hearing on 11-03-2020 which was dismissed in default by the hon'ble Bench due to absence of the counsel, being ill. (Copy as annex "F")
- 8. That on 17-03-2020, appellant submitted CM before the hon'ble court for restoration of the Writ Petition which came up for hearing on 23-04-2020 and the said Writ Petition was restored with further direction to approach before the proper forum for the addressel of grievances against the seniority list. (Copy as annex "G" & "H")

Hence this appeals, inter alia, on the following grounds:

### GROUNDS:

- a. That junior most incumbents have become senior to appellant for no legal reason but due to the lapses of the department and appellant vested right was in-fringed for no legal reason.
- b. That in the year, 2007-08, post of Senior Clerk was lying vacant as is evident from the promotion of juniors.
- c. That the matter was not taken by the department as per the mandate of law but promoted blue eyed juniors ignoring appellant for no reason, being senior.
- d. That by dropping appellant from promotion in the year, 2007-08, no reason was assigned to drop him from promotion. Such act of the department is based on ulterior motive.
- e. That during the pendency of the writ petition, the impugned seniority list dated 26-03-2019 was circulated wherein the name of appellant was placed at wrong position instead of correct position over and above the name of his juniors.

It is, therefore, most humbly prayed that on acceptance of the appeal, order of promotion to the post of Senior Clerk of appellant in the year, 2013 may kindly be anti-dated to 2007-08 with all consequential benefits by correcting the seniority list dated 26-03-2019 to place appellant at proper place over the name of Muhammad Pervaz, etc, the juniors incumbents, with such other relief as may be deemed proper and just in circumstances of the case.







## WRIT PETITION UNDER ARTICLE 199 OF THE CONSTITUTION OF ISLAMIC REPUBLIC OF PAKISTAN, 1973:

### Respectfully Sheweth:

- 1. That petitioner was appointed as Junior Clerk on 10-04-1988 and was promoted to the post of Senior Clerk on 22-07-2013.
- 2. That further promotion to the post of Assistant Grade Clerk B-16 was required on the basis of seniority cum-fitness at Provincial level but the department did not circulate any seniority list for the purpose and used to promote Senior Clerks to the post of Assistant Grade Clerk B-16 of choices.
- 3. That the department was legally bound to circulate final seniority list of the incumbents at Provincial level but they failed to fulfill its obligations and for the reason, deserving candidates were ignored from promotion.





- 4. That on 01-07-2019, the department further initiated process of promotion to the rank of Assistant Grade Clerk B-16 but this letter does not contain the name of petitioner for promotion to the said grade despite the fact that he is much senior than others. (Copy as Annex "A")
- 5. That on 04-07-2019, petitioner submitted representation before respondent for promotion but in vain. While on the other hand, promotion process was initiated without including the name of petitioner for the purpose in the panel of promotees. (Copy as Annex "B")

Hence this Writ Petition, inter alia, on the following grounds:

### **GROUNDS**

- a. That as stated earlier, no final seniority list was ever issued by the department at Provincial level while on the other hand, the department is going to promote employee of the choices from time to time.
- b. That petitioner was due for promotion to the post of Assistant Grade Clerk B-16 in the year 2007-2008 but could not ascertained his position at proper place due to none availability of the seniority list.
- c. That the department is legally bound to circulate final seniority list amongst the employees to ascertain positions assigned to everyone but for ulterior motive, such obligation was not fulfilled by the department.
- d. That in letter dated 01-07-2019, petitioner was neither assigned proper place nor his name was included in the list, while on the other hand, the process of promotion was not only initiated but is going to finalize the same in short span of time.

It is, therefore, most humbly prayed that on acceptance of the Writ Petition, in exercise of the extraordinary constitutional jurisdiction, this hon'ble Court may graciously be pleased to:





- a. Direct respondent to first issue final seniority list of the incumbents at Provincial level before finalization of process of promotion.
- b. Direct further the authority to include the name petitioner at proper place in the panel of promotes to be made to the rank of Assistant Grade Clerk B-16;

### AND /OR

c. Any other writ/order/direction deemed proper and just in the circumstances of the case, be also issued/ordered/given.

### Interim Relief:

By keeping in view the aforesaid facts and circumstances of the case, respondents be restrained from making promotion on the basis of letter dated 01-07-2019 till the decision of the case.




