



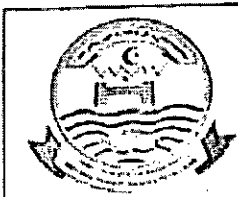
Kabir Ullah Khattak, learned Additional Advocate General
