Counsel for the appellant Abdul Hameed present. Preliminary arguments heard. It was contended by learned counsel for the appellant that the appellant was appointed as Theology Teacher in Education Department by the competent authority vide order dated 14.06.2012 and was posted at Government Middle School Dam Nullah. It was further contended that vide order dated 04.12.2014 the appellant was transferred from Government Middle School Dam Nullah to Government Middle School Neel Batla. It was further contended that the respondent-department was not paying the salary to the appellant from the date of his appointment therefore, the appellant filed Writ Petition in the worthy High Court, the Writ Petition of the appellant was accepted and the respondent-department was directed to release the salary of the appellant vide order dated 01.07.2015, on the basis of judgment/order of the worthy High Court, the respondent-department release the salary of the appellant vide order dated 19.10.2015. It was further contended that later on the respondent department again issued order/letter dated 29.06.2017 wherein it was mentioned that the appointment order of the appellant was illegal therefore, the same was withdrawn vide order dated 15.12.2015 with immediate effect. However, the withdrawal order was not communicated/issued to the appellant. It was further contended that in the said letter, the appellant was also directed to deposit salary already drawn by him amounting to Rs. 225031/-. The appellant filed departmental appeal against the said order/letter on 05.11.2018 which was rejected on 01.02.2019 and communicated to the appellant on 10.02.2019 hence, the present service appeal on 07.03.2019. It was further contended that neither proper inquiry was conducted against the appellant before passing the impugned order nor opportunity of personal hearing and defence was provided to the appellant. It was further contended that if the appointment order of the appellant was illegal the competent authority present before the worthy High Court would have disclosed the same but he remained mum in the worthy High Court and the worthy High Court also ordered for release of his salary therefore, the impugned order is illegal and liable to be set-aside.

The contention raised by the learned counsel for the appellant need consideration. The appeal is admitted for regular hearing subject to all legal objections. The appellant is directed to deposit security and process fee within 10 days thereafter, notice be issued to the respondents for written reply/comments for 10.07.2019 before S.B at Camp Court Abbottabad.





**PRAYER: -**

On acceptance of instant appeal, the impugned order dated 15.12.2015 and 01.02.2019 may graciously be set-aside and appellant may kindly be re-instated into service with all back and consequential benefit, any other remedy which this August Tribunal deem fit and proper, that may also be awarded in favour of appellant.

**Respectfully sheweth!**

- 1) That, the appellant is resident of Village Kanshian (Balakot) Mansehra and the appellant is fully qualified and having the required for the post of T.T.

**(Copies of educational testimonial record is annexed as Annexure "A").**

- 2) That, the DEO (Male) Mansehra/ respondent No. 3 advertised some vacant posts of T.T in daily Mashraq, whereupon appellant applied for the post of T.T, after passing test the then EDO conducted interview and scrutinize the documents of the candidates and merit list of candidates was displayed for receiving objections. After the official process the meeting of DSC was held and approved the case of T.T candidates for appointment against the vacant post of T.T (Theology Teacher) and on acceptance of

appeal by competent authority the appointment order of appellant was issued vide Endst. No. 710-752 dated 14.06.2012 and appellant was posted at GMS Dam Nalla (Mansehra) and took-over the charge in said School.

**(Copies of charge report, appointment order are annexed as Annexure "B", "C" & "D" respectively).**

- 3) That, the appellant performed duties honestly, regularly and fairly since the time of appointment, therefore, appellant was transferred for GMS Dam Nullah to GMS Neel Batla against the vacant post of T.T vide transfer order dated 04.12.2014.

**(Copy of transfer order is annexed as Annexure "E").**

- 4) That, appellant time and again requested the respondent No. 3 for release of his monthly salaries, but of no avail, ultimately an appellant filed Writ Petition before Honourable Peshawar High Court Abbottabad Bench for release of monthly salary etc whereby the Honourable Court passed an order vide dated 01.07.2015 and directed the department monthly salary be released without delay, whereby the monthly salary has been released

after fulfilled all codel formalities vide order dated 29.10.2015.

**(Copies of order of Honourable High Court dated 01.07.2015 and release order dated 29.10.2015 are annexed as Annexure "F" & "G").**

- 5) That, the appellant was continuously performing his duties without any break 03.06.2017 and regularly salary was received upto till 31.10.2016.

**(Copy of attendance register, salary slip and statement of Headmaster are annexed as Annexure "H", "I" and "J").**

- 6) That, appellant has performing regularly his duties without any break w.e.f. the date of appointment uptill 03.06.2017 and monthly salaries of appellant also released uptill 31.10.2016, appellant has never found guilty of any kind of absenteeism, truancy misconduct, misfeasance, non feasance nor been found guilty of dereliction of duty without taking thing into consideration, the respondent No. 3 issued the impugned letter to appellant vide Endst. No. 10226 dated 29.06.2017, wherein stated that your appointment order was withdrawn vide Endst. No. 18868-75 dated 15.02.2015 and requiry has been made w.e.f 16.12.2015 to

31.10.2016 on the baseless allegation leveled against the appellant, whereas the Headmaster also andussed the appellant has performing his duty regularly w.e.f the date of appointment upto 03.06.2017.

(Copy of letter dated 29.06.2017, certificate of Headmaster dated 03.06.2017 and duty certificate are annexed as Annexure "K", "L" & "M" respectively).

- 7) That, the appellant filed a departmental appeal against impugned order dated 29.06.2017 and 15.12.2015, which was rejected by respondent No. 2 vide order dated 01.02.2019 and received the appellant on 10.02.2019.

(Copy of rejection order is annexed as Annexure "O").

That, the appellant seeks the indulgence of this Honourable Tribunal inter-alia on the following amongst other grounds: -

**GROUND:** -

- A) That, the impugned order dated 15.12.2015 and impugned rejection of appeal dated 01.02.2019 are against the law, facts, norms of justice, arbitrary, fanciful, perverse, without lawful authority, based on malafide, unconstitutional and against the relevant rules and

regulation, hence, not maintainable and liable to be set-aside.

- B)** That, no procedure has been followed before awarding appellant order of appointment has withdrawn, no proper inquiry has been conducted.
- C)** That, as per law respondents/ department was support to be issue statement of allegation, show cause notice as well as proper inquiry as per law was to be conduct without resorting to mandating legal requests, respondent No. 3 issued withdrawn appointment order of appellant for service at his own whims and wishes.
- D)** That, appellant has not been afforded opportunity of personal hearing to defend case which sine qua-non prayer to be withdrawn of appellant order for service. Hence, impugned withdrawn of appointment order dated 15.12.2015 is liable to be cancelled.
- E)** That, when law prescribed something which is to be done in a particular manner that must be done in that manner.



- F)** That, this fact may not left to fade in oblivion that the appellant served the department regularly from the date of appointment and getting regular salaries upto 31.10.2016 and performing duty upto 03.06.2017, therefore impugned letter vide dated 29.06.2017 issued by respondent No. 3 with regard to withdrawn of appointment order which is against the law, rules, therefore, as per service law appellant is entitled for re-instatement into Government service.
- G)** That, in light of authoritative decision/views of superior judiciary including Supreme Court of Pakistan the services of the appellant could not have been withdrawn and the impugned withdrawn order could not have been issued because, where the authority is guilty or irregularities, illegalities and procedural. The service of an employee cannot be withdrawn.
- H)** That, on the acceptance of the appeal by the competent authority the appellant order of appointment was issued vide Endst. No. 710-752 dated 14.06.2012 and appellant was

posted at GMS Dam Nalla, therefore transfer order vide dated 14.12.2014 was issued from GMS Dam Nalla to GMS Neel Batla, wherein appellant has serving 14.06.2012 for date of appointment upto 03.06.2017 in respondents department, wherein appellant was unaware all the proceeding pending with regard to his service. The respondents are trying to deprive the appellant from his legal and fundamental rights as contemplated by the constitution of Pakistan, 1973. The respondent before issuing of withdrawal of appointment order was duty bound to hear the appellant personally, but they have failed to do so, this they violated the principle of natural justice i.e. "AUDI ALTRAM PARTAM" which means no one should be condemned unheard.

- I) That, there is no other speedy, efficacious remedy available to appellant except the present appeal.
- J) That, other legal and factual points shall be raised at the time of arguments.

It is, therefore, humbly prayed that on acceptance of the instant service appeal, impugned withdrawn of appointment

order may graciously be declared null and void and respondent No. 3 may be directed to re-instate the service of appellant w.e.f. the date of withdrawal of appointment order with all back benefits.

7. The appellant was working at different schools with outmost and endures devotion and honestly, the order of withdrawal of appointment was issued without show cause, personal hearing and other cordial formalities which is against the law rule and policy, in this contest the appellant authority is bound to re instate the appellant in his post as per rules.
8. That the order of withdrawal vide dated 15-12-2015 was issued without intimation and information to the appellant which is stated in above paras.
9. That the appellant was working from the date of appointment up to 03-05-2017 without any break, whereas the order of withdrawal was issued on 15-12-2015 which is against the norm of justice.
10. That there is not illegality committed by appellant, where as the appellant is unaware of order of withdrawal 15-12-2015 and working up to 30-06-2017

It is therefore most humbly prayer that the order of withdrawal dated 15-12-2015 and order of recovery vide dated 29-06-2017 are set aside/cancelled and the appellant my kindly be reinstated as the post of (TT).
