It was contended by learned counsel for the appellant that the appellant was appointed as Forest Guard through proper recommendation of the Departmental Selection Committee vide order dated 17.09.1991 and had performed his duty up to 30.06.2000. It was further contended that after performing duty of more than five years the said project Sern Kaghan Forestry Project became completed and the appellant was terminated from service. It was further contended that the appellant was declared as surplus and later on he was adjusted on 09.01.2003. It was further contended that the respondents were required to regularize the intervening period of the appellant as regular with effect from July 2001 to 09.01.2003 but the appellant was not regularized. It was further contended that this Service Tribunal has also accepted Service Appeal No. 318/2009 titled Mian Siraj Versus Government of N.W.F.P and the same was implemented therefore, the appellant is also entitled for regularization of the aforesaid period.

The contentions raised by learned counsel for the appellant need consideration. The appeal is admitted for regular hearing subject to deposit of security and process fee within 10 days, thereafter notice be issued to the respondents for written reply/comments for 26.02.2018 before S.B.
