WHEREIN, IMPUGNED ORDER DATED 27.10.2011 WAS SET ASIDE **AND** RESPONDENTS WERE DIRECTED TO CONDUCT FRESH FULL FLEDGED INQUIRY BUT RESPONDENTS' DEPARTMENT WITHOUT RE-INSTATING THE APPELLANT CONDUCTED INQUIRY WHICH AGAINST THE LAW AND WITHOUT **ISSUING STATEMENT OF ALLEGATIONS** AND PROPER INQUIRY; THE APPELLANT WAS AGAIN NOT RE-INSTATED VIDE IMPUGNED ORDER NO.11660-64 DATED 12.07.2019 WHICH IS PERVERSE, AGAINST THE LAW, DISCRIMINATORY, WITHOUT LAWFUL JUSTIFICATION HENCE, THE IMPUGNED ORDER DATED 12.07.2019 IS LIABLE TO BE SET ASIDE.

#### PRAYER: -

On acceptance of the instant appeal, the impugned notification/order bearing No.11660-64 dated 12.07.2019 alongwith the order bearing No.2543-50 dated 27.10.2011 may graciously be set aside and the appellant may graciously be re-instated in service w.e.f. 28.03.2009 and all back benefits w.e.f 01.12.2008 may also be

granted/ awarded to the appellant. OR any other relief which this Honourable Tribunal deems appropriate in the circumstances of the case, may also be granted.

#### Respectfully Sheweth!

1. That, the appellant was serving in the respondents' department as PST and got appointment on 13.11.1994.

Copy of the appointment order is annexed as annexure "A".

2. That, the appellant got sanctioned extra ordinary leave, leave without pay w.e.f. 16.12.2006 to 01.12.2007 and then 02.12.2007 to 01.12.2008 but respondents' department with malafide intention ceased the service of the appellant w.e.f 28.03.2009 vide order dated 27.10.2011.

Copy of the documents showing sanction of extra ordinary leave and initial ceasing of service order dated 27.10.2011 are annexed as annexure "B".

3. That, the appellant filed service appeal bearing No.297/2012 which was decided on 29.06.2012. As per

judgment of this Honourable Tribunal impugned order dated 27.10.2011 was set aside and this Honourable Tribunal directed the respondents to conduct full fledged inquiry.

Copies of service appeal No.297/2012 alongwith judgment are annexed as annexure "C".

That, the respondents' department conducted inquiry against the No.12888-90 appellant vide letter dated 10.09.2018 without re-instating the appellant in service and without following prescribed the formalities passed the impugned notification/order bearing No.11660-64 dated 12.07.2019.

Copies of the letter dated 10.09.2018, impugned order No.11660-64 dated 12.07.2019, inquiry report dated 20.03.2019 are annexed as annexure "D", "E" & "F".

5. That, the appellant to be on the safe side, filed a departmental appeal against the impugned order dated 12.07.2019.

(Copy of the departmental appeal is annexed as annexure "G").

from the impugned notification/order dated 12.07.2019 seeks the gracious indulgence of this Honourable Tribunal by way of instant service appeal, inter alia, on the following grounds: -

#### **GROUNDS**

- That, initially, the services of the a. appellant were ceased and the this Honourable Tribunal in the judgment dated 29.06.2018 held that there is no law which provide ceasing of service. The respondents' department again maintained previous order dated 28.03.2009 and stated impugned order dated 12.07.2019 that the appellant cannot be re-instated.
- b. That, terms ceasing of the services of the appellant on the basis of so-called absence is absolutely alien to Khyber Pakhtunkhwa Efficiency and Discipline Rules, 2011 hence, impugned order dated 12.07.2019 is liable to be set aside.

c. That, the copy of inquiry and other relevant record was not provided by the respondent No.3 with the show cause notice to the appellant and in this regard, the appellant submitted the application to the department for provision of inquiry report and other relevant record but department did not provide copy of inquiry report. Besides, statement of allegation has also not been provided which is against the law.

Copy of show cause notice dated 06.05.2019 and reply dated 17.05.2019 thereof regarding provision of inquiry report are attached as annexure "H&I".

d. That, the appellant submitted numerous applications to Inquiry Officer i.e. D.E.O, Mansehra, Deputy Commissioner, Mansehra, R.T.I KPK Peshawar for issuance of inquiry report alongwith other relevant material but no heed was paid by the department despite of clear cut directions from the concerned quarter.

Copies of the applications are annexed as annexure "J".

- That, at the time of personal hearing dated 06.03.2019 one member Muhammad Aslam was not present but even then the said officer signed inquiry report and in this regard, attendance certificate of the appellant are attached as annexure "L" but respondents' department has led the appellant to the place which is utterly unknown to the principle of jurisprudence and natural justice. It is further submitted that the impugned order dated 12.07.2019 is stereo typed which is not maintainable in the eyes of law.
- f. That, as per law, the inquiry committee stated in their inquiry report that original service book and other necessary documents are missing in the District Education Office, Mansehra. Original line of the inquiry report is reproduced:

# "Original service book or it's photocopy is not available in the file of D.E.O (Male) Mansehra due to unknown reason"

A question arises that how did the inquiry officer confirmed the so-called allegations of absence without original service documents. Hence, impugned

order dated 12.07.2019 is liable to be set aside.

- That, from the bare perusal of the g. inquiry report, the exhibits of the socalled documents by the respondents' department is also highly doubtful as no proper procedure, legal and codal formalities have been adopted by the inquiry officers for the ibid purpose. From such conduct/behaviour of the inquiry officers clearly shows that they being in league with the respondents' department have carried out all the proceedings which is a · blatant violation of the relevant law, rules and regulations as well as procedure for the inquiry.
- h. That, the inquiry committee admitted that "on expiry of his leave without pay arrival report on 02.12.2008 at GPS Makarha

  Bala signed by the Head Teacher is also available on record but at the same time, the then dealing Assistant has reported him as "Absent" on the page showing leave calculation" which shows malafide on the part of department as well as the inquiry committee. It is worthy to note here that the dealing Assistant is part and parcel of respondents' department

and when inquiry report clearly admitted the negligence on the part of the dealing Assistant then why has the appellant not been re-instated in service and such act of the department speaks volume of their malafide.

- That, another glaring aspect of the case is that the respondents' department in their impugned notification as well as in previous order have shown to cease the service of the appellant w.e.f. 28.03.2009 whereas the alleged absence of the appellant been shown has by them 01.12.2008 and such acts clearly speaks that the appellant duly made his arriveal on the date fixed and remained in service w.e.f. 02.12.2008 to 28.03.2009 as per the record of the department.
- j. That, the inquiry proceedings and the inquiry committee also itself completely silent in its findings and recommendations regarding the willful absence of the appellant. Hence all the proceedings so conducted by the respondents' department as well as issuance of impugned letter No.2453-50 dated 27.10.2011 are nullity in the eyes of

law as the basic ingredients for socalled willful absence are completely missing in the instant Furthermore. the respondents' department well as as inquiry committee based all the findings on the above said letter for issuance impugned notification dated 12.07.2019 is also against the law, rules and regulations which have no sanctity in the eyes of law.

conditions of the service, therefore, this tribunal has jurisdiction to entertain the instant service appeal.





Sated here the short facts making the background of the present appeal are, that the appellant joined the Education Department as PTC Teacher in the year 1994, however, during this period, he remained absent from duty w.e.f. 28.03.2009 to 23.08.2011. According to rules, he was entitled only for five years leave without pay whereas he availed six years and nine month. So he was called for personal hearing on 23.08.2011 and as per contents of the impugned order, he admitted his absence and so on 27.10.2011, the then Executive District Officer (E&SE) Mansehra notified his service as ceased w.e.f. 28.03.2009 under Para-12 of the Revised Leave Rules, 1981. The appellant aggrieved from the impugned order preferred departmental appeal before the

the Ewiense

appellate authority on 03.11.2011 but it was not responded so far, hence he preferred the present appeal before this Tribunal.

- 2. Arguments heard and record perused.
- 3. Mr. Shad Muhammad Khan, Advocate, learned counsel for the appellant contended that the very impugned order dated 27.10.2011 is defective in the eyes of law as the word "ceased" figures nowhere a punishment in the service law. Further that the appellant has been punished with retrospective date i.e 28.03.2009. Further he contended that under the law, the respondents were bound to conduct a full-fledged enquiry before imposing the major punishment of ceasing his services. At the end, he requested the Tribunal to accept this appeal and set aside the impugned order dated 27.10.2011.
- 4. Mr. Ziaullah, DDA though opposed the contentions of the learned counsel for the appellant but above mentioned pleas which were established from the office record/comments but could not explain properly the anomaly committed by the respondents while passing the impugned order.
- 5. With the assistance of the learned counsel for the parties, this Tribunal consulted the record and found that from the bare reading of the impugned order dated 27.10.2011, this Tribunal noticed serious legal omissions in the said order as is evident from the discussion given below.
- 6. The service of the appellant has been ceased w.e.f 28.03.2009 whereas order has been passed on 27.10.2011 and so this very order itself is defective in the eyes of law.

  Apart from this, this Tribunal did not find any enquiry, charge sheet or show cause notice given by the respondents to the appellant but even then imposed major penalty of ceasing his service and in this way, the respondents committed serious blunder by not following the legal procedure prescribed under the law.



The crux of the above discussion is that after taking into consideration the above mentioned factual and legal position of the case, this Tribunal reached the conclusion that it is a fit case to be interfered by this Tribunal under its appellate jurisdiction. As such, on acceptance of the appeal, the impugned order dated 27.10.2011 stands set aside and the respondents are directed to conduct fresh full-fledged enquiry and also give opportunity of hearing to the appellant. With the above observations, the appeal stands disposed off. Parties are left to bear their own costs. File be consigned to the record room.

#### **CONCLUSION:**

He tried to conceal his services which he rendered in SRSP District Mansehra which is a great blunder on his part. So he is guilty of corruption & misconduct. He has wasted a lot of time of the little kids.

## **RECOMMENDATIONS:**

The enquiry Committee proposes the following recommendations.

1. The competent authority shall issue charge sheet and Show Cause accused mentioning the major penalty dismissal/Removal from Service as per E&D rules 2011. Further his "Personal Hearing" shall also be conducted after the reply of Charge Sheet/Show Cause Notice.

His original Service Book, be traced and if not updated, Should be completed which is a major official record.

With due respect it is submitted:

- 1. That, the appellant was inducted in the Education Department as PTC Teacher on 13.11.1994 and served the department with great zeal and zest.
- 2. That, later on, leave was needed to the appellant, therefore, the appellant submitted an application upon which leave w.e.f. 07.03.2006 to 01.12.2008 was sanctioned to the applicant by the Department while fulfilling all the legal and codal formalities. After the expiry of leave period, the appellant duly submitted his written arrival report on 02.12.2008 to Head Teacher Government Primary School Makarha Bala, Tehsil and District Mansehra and the Head Teacher informed the appellant that the post of the appellant has been filled and one Mr. Javed Iqbal has been appointed on the said post, therefore, the appellant was directed to approach the Education office for further necessary action. In this regard, a letter in writing was issued to the appellant with the seal and signature the Head Teacher

mentioned above which is available on the inquiry file as well as also mentioned in the previous record.

- That, the appellant took the above said letter and 3. approach Mr. Shad Muhammad Khan, Assistant Sub District Education Officer (Male), Circle Dhodial and submitted his arrival report to him and requested him to proceed with the said arrival alongwith service book to Education Officer (Male), Mansehra who assured and satisfied the appellant that his arrival report would be processed to District Education Officer (Male) Mansehra and the appellant will intimated through proper channel as per law.
- That, later on, the appellant time and again visited the office of A.S.D.E.O Circle Dhodial as well as District Education Officer (male) Mansehra but they all the time satisfied the appellant orally that they will adjust him but in the meanwhile no written correspondence was made by the above said offices willfully. As per law, rules and regulations when the appellant is serving under a circle officer, the duty of the appellant is to present/submit his arrival before the circle officer and it is the circle officer who is responsible to proceed the same to District Education Officer (Male), Mansehra.
- That, the Education Department was duty 5. to inform the appellant regarding his adjustment but instead of adjusting the appellant, they issued letter No.2543-50 dated 27.10.2011 whereby the service of the appellant were ordered to be ceased

person namely Mr. Muhammad Aslam, the so-called inquiry officer who was made the part and parcel of the inquiry committee by the appointing authority vide letter No.12888-90/Lit(M)/Inquiry/PST dated 10.09.2018 but he was never present during the inquiry proceedings in the inquiry room 06.03.2019, therefore, the inquiry so conducted under the signatures of three persons have no legal sanctity in the eyes of law. Similarly, the Chairman of the inquiry committee have only got the signatures of the third person namely Mr. Muhammad Aslam on the inquiry report which his inclusion in the inquiry, which is a great blunder on the part of the education department.

- 7. That, the appellant is totally unaware regarding the letter No.12888 dated 10.09.2018 as the same was kept in dark willfully by the Department as well as inquiry committee from the appellant. The appellant time and again sent different letters to D.E.O (M), Mansehra after the order of Honourable Service Tribunal which are available on the file but no answer was given to the appellant in this regard.
- 8. That, as far as the detailed record examined by the inquiry committee is concerned; the appellant was never intimated that what type of record was examined by the inquiry committee. Furthermore, the appellant submitted detailed and comprehensive stance/version before the inquiry committee dated 06.03.2019 which was duly received by Chairperson of Inquiry committee namely Mr. Luqman Ali Khan but the same was never taken into consideration by the inquiry committee. The receiving of the said stance/version is already available on the inquiry file.
- 9. That, it was bounden duty of the inquiry committee to probe into the matter as per the version/stance of the

appellant raised before Honourable Service Tribunal. Deputy Commissioner Office as well as during personal hearing dated 06.03.2019 but they badly failed to probe into the same in its true letter and spirit. Furthermore, neither any statement of Head Teacher Government Primary School Makarha Bala was recorded for Mr. Shad Muhammad Khan, A.D.E.O Circle was examined in this regard. Although the inquiry committee has vast powers to probe into the matter and to record the statements of all the concerned in the matter but the inquiry committee failed to fulfill its legal obligation in this regard. Similarly, the statements of the above-mentioned persons were also not recorded in presence of the appellant nor they were summoned by the inquiry committee. It is also pertinent to mention here that the inquiry committee kept mum attendance/arrival report of the appellant despite of the fact that the same is available on the inquiry file and no findings whatsoever were given on the same. Similarly, the inquiry committee did not bother to investigate regarding the arrival report of the appellant from the Education Department.

10: That, as far as the joining of Sarhad Rural Support Programme (SRSP) is concerned, it is submitted that the appellant was on personal leave during those days, therefore, there was no need to obtain any NOC from the Education Department during the leave period because the education department has not bounded the appellant through any written document affidavit that the appellant will not work anywhere within leave period i.e. without pay. If had so, then the appellant would not work anywhere. It is also very much important to note that that the appellant only

served with SRSP as a volunteer keeping in view the difficulties faced by the earthquake affected people as there are hundred of thousands of peoples who became homeless due to earthquake. The volunteer services rendered for the SRSP are purely on humanitarian basis which cannot be termed as illegal. The appellant never wasted any time of innocent kids rather the appellant during his service tenure, tried his best to facilitate the students in all manners. The leave period was the basic right of the appellant which was availed by the appellant as per law, rules and regulations as well as per the legal permission of the Department, which does not amount to wastage of time of kids. The appellant never received any benefit from the Education Department regarding the leave period nor any loss was suffered to public exchequer by any conduct of the appellant.

That, the appellant was never given the opportunity of 11. personal hearing on 16.08.2011 nor the appellant ever received any such letter vide office No.1767 nor appeared before any authority nor admitted any willful absence. All the allegations in this regard are totally false, frivolous, baseless and without any documentary evidence/substance hence the said socalled personal hearing has no bindings effects on the appellant. This point was raised before the Honourable KPK Service Tribunal but no evidence was annexed by the department in this regard rather only a single paper was introduced and that too with any legal procedure. Similarly, the inquiry committee also not bother to obtain any proof in this regard from the Education Department rather only a single paper and. that too without any evidence/substance has been used against the appellant and such conduct of the

inquiry committee shows that all the proceedings were carried out mere on the basis of previous proceedings. It is worthy to note that the said letter was based for the ceasing of the service of the appellant which was challenged by the appellant before the Honourable KPK Service Tribunal which was set at naught by the Honourable Service Tribunal while ordering for fresh full fledge inquiry and the Service Tribunal also held that the education department has committed serious blunders by not following the legal procedure prescribed under the law and the same practice was committed by the inquiry committee in the matter in hand which is not permissible under the law as statement of relevant persons have not been recorded by the inquiry committee which were mandatory/ necessary for reaching at just and proper conclusion.

- 12. That, as the inquiry committee has not conducted the proceedings of inquiry in accordance with law, therefore, the proceedings well recommendations by them is a nullity in the eyes of law. The recommendations of the inquiry committee are neither satisfactory nor justified nor can be acted upon as the basic roots of the inquiry are missing in the inquiry report rather all the proceedings were carried out mere on presumption; conjectures and keeping in view the surmises while position/case. No fresh improvement or proceedings have been carried but by the inquiry committee in this regard keeping view the directions of Honourable service Tribunal rather willfully the strong, cogent and confidence inspiring stance of the appellant has been treated as trash.
- 13. That, another astonishing aspect of the case that the appellant was never intimated nor handed over the

findings of the inquiry till issuance of impugned notification dated 12.07.2019 despite of the fact that the appellant time and again submitted different applications to Education Department and other highups but the grievances of the appellant were never redressed and non-handing of inquiry report also shows that there is something wrong in the bottom. Similarly, under the law it was the bounden duty of the inquiry committee to hand over the inquiry report alongwith all the relevant material to the appellant after its completion but the said law has been blatantly violated by the Education Department while not issuing the inquiry committee alongwith other material to the appellant. Had the department or inquiry committee would issue the findings of committee to the appellant then the appellant would betterly assist the department on the right angle and would also point out material aspect of the case for reaching at just and proper decision.

14. That, the inquiry committee never tried to bring the real facts on the surface of the record rather the inquiry committee conducted the inquiry proceedings under the pressure of Education Department just to save their employments/service. Had the inquiry committee would record the statements of the above said persons and to dig the real facts then the innocence of the appellant would be proved/established. But the inquiry committee instead of inquiring the matter on the correct direction in the light of the directions contained in order of Honourable Service Tribunal relied on the previous record only which was already available on the file and the same has been set at naught/rejected by the Honourable Service Tribunal. Ās the induiry'

committee has proceeded in the light of previous record, therefore, all the proceedings so conducted by them is a nullity in the eyes of law.

- 15. That, from whatever angle it is to be seen, the appellant never remained willful absent rather all the record as well as the detailed version/stances of the appellant clearly depicts that the appellant made his arrival within time but due to the negligence of the Education Department, the appellant was never adjusted nor considered for adjustment and the Education Department is blaining the appellant and the appellant has been made escape goat for the negligence committed by the Education Department.
- That, bare perusal of the findings of inquiry committee. 16. would reveal that the inquiry committee discussed the irrelevant facts i.e. previous leave period of the appellant which never remained disputed one in the past or at present rather the inquiry officers just to mix up the case and to remove the attention from the real picture of the case have discussed the irrelevant aspect. The leave period mentioned at serial No.(a) to (l) is firstly never a dispute one nor the same has ever been made part of the case nor any show cause notice in this regard was issued to the appellant nor any departmental inquiry was made in this respect previously or presently. The inquiry officers have categorically admitted in their findings at page No.3 that "Original Service Book or its photocopy is not available in the file of D.E.O (M) Mansehra due to unknown reason" and also admitted at last page in para No.2 of recommendation that "His original service book, be traced and if not updated, should be

X

completed which is a major official record". Keeping view such clear admission, how the inquiry committee can calculate the leave period of the appellant without original service book. The leave period mentioned at serial No.(a) to (l) in findings of inquiry are legal one and if there were no leaves left with the appellant then why the Education department sanctioned the last leave w.e.f. 02.12.2007 to 01.12.2008 and sanctioning the said leave clearly shows that the appellant had the requisite leaves in his favour which were duly availed by the appellant as per the permission of the Education Department as well as in the light of relevant law, rules and regulations. Furthermore non availability of original service book with the Education Department also shows malafide that they are concealing the real facts willfully.

17. That, the whole leave period so calculated by the inquiry officers is also illegal and void as they are calculating the later period i.e. after 02.12.2008 which is highly injustice with the appellant as the appellant has made his arrival on 02.12.2008 well within time and due to negligence of the Education Department, the said arrival report was never considered by them despite of the fact that the said arrival report is also made part and parcel of the inquiry which is evident from the findings of inquiry committee at page No. 5 which is reproduced as under:

"On expiry of his leave without pay any arrival record on 02.12.2008 at GPS Makarha Bala signed by the Head Teacher is also available on record but at the same time, the then dealing assistant has reported him as "Absent" on the part showing leave calculation annexure "O""

Keeping in view such situation; the inquiry officers were duty bound to summon the said Assistant, Mr. Shad Mühammad Khan AD.E.O Circle Shinkiari alongwith Head Teacher Government Primary School Makarha Bala, District Mansehra but the said crucial and important evidence has been withheld by the inquiry officers. Neither the statements of the said witnesses were recorded nor any opportunity of cross examination on the said witnesses was afforded to the appellant nor any proceedings in this regard were conducted by the inquiry officer. Furthermore, the appellant submitted detailed reply to show cause notice but the Education Department also did not bother themselves to summon/call the above said witnesses which was well in the authority/domain of the Education Department.

18. That, bare perusal of the record would reveals that the appellant's services were shown to be ceased with effect from 28.03.2009 whereas the leave period of the appellant was going to be expired on 02.12.2008 and after expiry of leave period, arrival report was duly submitted on 02.12.2008 to concerned authorities i.e. Circle Office. Now calculating the period between the ceasing of service and arrival report, it shows that the appellant's services were ceased after more than 03 months and such act of the education Department is a clear cut proof that the appellant was in service w.e.f. 02.12.2008 to 28.03.2009 hence the arrival report is also an admitted document by the Education Department as well as inquiry committee, therefore, this point is very much vital for the reinstatement of the service of appellant but the same has been overlooked by the Education Department as well as inquiry officers. Similarly, the leave period of the appellant is also admitted by the Inquiry Officers as well Education Department.

19. That, no evidence of so-called willful absence has ever been produced by the inquiry Officers or Education Department nor the same has been discussed in inquiry findings nor

the same was ever proved against the appellant rather all the record including arrival report speaks volume about the fact that the appellant has made his arrival well within time and never remained negligent in performance of his duties. The Education Department has staged the drama of so-called willful absence as well as so-called personal hearing dated 23.08:2011 of the appellant, malafidely and bogus letter No.1767 dated 16.08.2011 was introduced malafidely but badly failed to prove the same before the inquiry committee.

- 20. That, no official of the Education Department has come forward to annex any documentary proof against the appellant nor the name of any such official, nominated by the appointing authority from the department; is mentioned in the findings of inquiry committee nor the statement of any such official was recorded by the inquiry officers nor the appellant has been given a chance of cross examination on any such person. Similarly, as it was fresh full fledge inquiry under the law, therefore, fresh and original documents were to be presented and exhibited before the committee but not process under the law was adopted by the inquiry officers which was mandatory. The inquiry officers never pay heed to fulfill the legal requirement of law in the matter in hand.
- 21. That, the inquiry officers have made reliance on the photocopies of the previous record nor fresh or original documents were brought on the record nor exhibited as per law. Similarly, the inquiry committee itself admitted that the original service book of the appellant is not available hence after such clear, admission; reliance made by the inquiry committee on the photocopy record, admitting and annexing the same in the tablence

- 22. That, the appellant never committed any corruption or misconduct nor any such allegations have been proved during the course of inquiry by the Inquiry Committee and leveling such allegations against the appellant also speaks volume of malafide on the part of the Inquiry committee and Education Department.
- 23. the appellant was called for personal That; hearing on 27.05.2019 which was received on the same date by hand which was mandatory to be sent to the appellant by registered post at his postal address. Furthermore, the appellant personally appeared before the Dy: District Education Officer (Male), Mansehra upon the direction of District Education Officer (Male), Mansehra. During the personal hearing the Deputy District Education Officer Mansehra discussed all the issues as well as reply given by the appellant in his show cause notice one by one and the appellant duly justified all the allegations levelled against him and real facts were brought into the notice of the Deputy District Education Officer (Male), Mansehra but despite that fact neither the real facts were probed into nor any effort was made to dug the real fact
- 24. That, during the inquiry proceedings as well during the proceedings of show cause notice, the appellant never found guilty of Efficiency and Discipline Rules, 2011 rather the appellant has

served the department with great zeal and zest and never remained negligent in performance of his duties.

- 25. That, no legal, valid or justified reasons have been recorded by the Dy: District Education Officer (Male) in support of its impugned notification bearing No.11660-64 dated 12.07.2019.
- 26. That, the Dy: District Education Officer (Male) Mansehra have committed illegality and material irregularity while issuing the impugned notification which have no legal sanctity in the eyes of law.

It is, therefore, most humbly requested

that on acceptance of the instant departmental appeal, the impugned notification/order bearing No.11660-64 dated 12.07.2019 alongwith the order bearing No.2543-50 dated 27.10.2011 may graciously be set aside and the appellant may graciously be reinstated in service w.e.f. 28.03.2009 and all back benefits w.e.f 01.12.2008 may also be granted/awarded to the appellant. OR any other relief which your honour deems appropriate in the circumstances of the case, may also be granted.

- That, the applicant took the above said letter and approach Mr. Shad Muhammad Khan, Assistant District Education Officer (Male), Circle Dhodial and submitted his arrival report to him and requested him to proceed the said arrival report alongwith service book to District Officer (Male), Mansehra who assured and satisfied the applicant that his arrival report would be proceeded to District Education Officer (Male) Mansehra and the applicant will be intimated through proper channel.
- 4. That, later on, the applicant time and again visited the office of A.D.E.O Circle Dhodial as well as District Education Officer (male) Mansehra but they all the time satisfied the applicant orally that they will adjust the applicant but in the meanwhile no written correspondence was made by the above said offices willfully.
- 5. That, the Education Department was duty bound to inform the applicant regarding his adjustment but instead of adjusting the applicant, they issued letter No.2543-50 dated 27.10.2011 whereby the service of the applicant was ordered to be ceased without any show cause notice or personal hearing. Against which the applicant filed a service appeal before the Honourable Service Tribunal which was accepted and the order of full fledged inquiry was passed.
- 6. That, although the inquiry committee was constituted little light of order of Honourable KPK Service Tribunal before applicant was never intimated nor any correspondence was made to the applicant for joining the proceedings of the inquiry. The applicant himself appeared before the inquiry committee in Government Higher Secondary School No.1, Mansehra on 06.03.2019 at 10:00 PM where only two persons namely Mr. Luqman Ali Khan and Mr. Nazir Sahib were present, in this respect an entry was also made by the

applicant in his attendance certificate duly signed by the applicant, which is available on the inquiry file as well as with the applicant. The applicant is ready to take oath that no third person joined the inquiry proceedings on 06.03.2019. In this regard, the applicant also offers oath to Mr. Luqinan Ali Khan and Mr. Nazir Sahib that no third person was available at the time of inquiry nor introduced to the applicant nor the applicant seen the third person nor meet with him. The applicant was initially never came to know that three persons were constituted as inquiry committee rather the applicant later from the show cause notice came to know that three persons were constituted as inquiry committee for the inquiry pulpose from the department but still the name of third person has not been disclosed on the applicant. It is also important to note that if there was any third person in the inquiry committee but he was never present during the inquiry proceedings in the inquiry room on 06.03.2019, therefore, the inquiry so conducted under the signatures of three persons have no legal sanctity in the eyes of law.

7. That, the applicant is totally unaware regarding the letter No.12888 dated 10.09.2018 as the same was kept in dark willfully by the department as well as inquiry committee from the applicant. The applicant time and again sent different letters to D.E.O, Mansehra after the order of Honourable Service Tribunal which would be available on the file but no answer was given to the applicant.

8. That, as far as the detailed record examined by the inquiry committee is concerned; the applicant was never intimated that what type of record was examined by the inquiry committee. Furthermore, the applicant submitted detailed and comprehensive stance/version before the inquiry committee which was duly received by Chairperson of Inquiry committee namely Luqman Ali Khan but the same was never taken into consideration by the inquiry committee. The receiving of the said stance/version is already available on

X



the inquiry file as well as the file of Honourable Service Tribunal, KPK Peshawar.

- That, it was bounden duty of the inquiry committee to probe 9. into the matter as per the version/stance of the applicant raised before Honourable Service Tribunal, Commissioner Office as well as during personal hearing dated 06.03.2019 but they badly failed to probe into the same in its true letter and spirit. Furthermore, neither any statement of Head Teacher Government Primary School Makarha Bala was recorded nor Mr. Shad Muhammad Khan, A.D.E.O Circle was examined in this regard. Although the committee has vast powers to probe into the matter and to record the statements of all the concerned in the matter but the inquiry committee failed to fulfill its legal obligation in this regard. Similarly, the statements of the above-mentioned persons were also not recorded in presence of the applicant nor they were summoned by the inquiry committee. It is also pertinent to mention here that the inquiry committee kept mum upon the attendance/arrival report of the applicant and no findings whatsoever were given on the same. Similarly, the inquiry committee did not bother to investigate regarding the arrival report of the applicant from the Education Department.
- Programme (SRSP) is concerned, it is submitted that the applicant was on personal leave during those days, therefore, there was no need to obtain any NOC from the Education Department. The applicant only service with SRSP as a volunteer keeping in view the difficulties faced by the earthquake affectees. The volunteer services rendered for the SRSP are purely on humanitarian basis which cannot be termed as illegal. The applicant never wasted any time of innocent kids rather the applicant during his service tenure;

tried his best to facilitäte the students in all manners. The leave period was the basic right of the applicant which was availed by the applicant as per law, rules and regulations which does not amount to wastage of time of kids. The applicant never received any benefit regarding the leave period nor any loss was suffered to public exchequer by any conduct of the applicant.

That, the applicant was never given the opportunity of 11. personal hearing on 16.08.2011 nor the applicant ever received any such letter vide office No.1767 nor appeared before any authority nor admitted any willful absence. All the allegations in this regard are totally false, frivolous, baseless and without any documentary evidence/substance hence the said so-called personal hearing has no bindings effects on the applicant. This point was raised before the Honourable KPK Service Tribunal but no evidence was annexed by the department in this regard rather only a single paper was introduced and that too with any legal procedure. Similarly, the inquiry committee also do not bother to obtain any proof in this regard from the Education Department rather only a single paper and that too without any evidence/substance has been used against the applicant and such conduct of the inquiry committee shows that all the proceedings were carried out mere on the basis of previous proceedings. It is worthy to note that the said letter was based for the ceasing of the service of the applicant which was challenged by the applicant before the Honourable KPK Service Tribunal which was set at naught by the Honourable Service Tribunal while ordering for full fledge inquiry and the Service Tribunal also hold that the department has committed serious blunders by not following the legal procedure prescribed under the law and the same practice was committed by the inquiry committee in the matter in

hand which is not permissible under the law as statement of relevant persons have not been recorded by the inquiry committee.

- 12. That, as the inquiry committee has not conducted the proceedings of inquiry in accordance with law, therefore, all the proceedings as well as recommendations by them is a multity in the eyes of law. The recommendations of the inquiry committee are neither satisfactory nor can be acted upon as the basic roots of the inquiry are missing in the inquiry report rather all the proceedings were carried out mere on presumption, conjectures and surmises while keeping in view the previous position/case. No fresh improvement or proceedings have been carried out by the inquiry committee in this regard.
- 13. That, another astonishing aspect of the case is that the applicant was never intimated nor handed over the findings of the inquiry till date despite of the fact that the applicant time and again submitted different applications to Education Department and other high-ups but the grievances of the applicant were never redressed and non-handing of inquiry report also shows that there is something wrong in the bottom and such conduct of the inquiry committee as well as department shows that they are bent upon their wrong and illegal acts.
- on the surface of the record rather the inquiry committee conducted the inquiry proceedings under the pressure of Education Department just to save their employments/service. Had the inquiry committee would record the statements of the above said persons and to dug the real facts then the innocence of the applicant would be proved/established. But the inquiry committee instead of

inquiring the matter on the correct direction in the light of the directions contained in order of Honourable Service Tribunal relied on the previous record only which was already available on the file and the same has been set at naught/rejected by the Honourable Service Tribunal.

- 15. That, from whatever angle it is to be seen, the applicant never remained willful absent rather all the record as well as the detailed version/stances of the applicant clearly depicts that the applicant inade his arrival within time but due to the negligence of the Education Department, the applicant was never adjusted nor considered for adjustment and the Education Department is blaming the applicant and the applicant has been made escape goat for the negligence committed by themselves.
- 16. That, from the above said discussion, the major penalty cannot be imposed upon the applicant rather the applicant has fulfilled his duties and legal obligations in all respects within time, therefore, the services of the applicant are liable to be restored with all back benefits.

It is, therefore, most humbly requested that keeping in view of the above, the said inquiry may be dropped and the applicant may please be restored in service with all back benefits.

- 3. That, the applicant submitted an application on 29.03.2019: to D.E.O (Male) Manselira for the subjected titled above but no action was taken thereupon. Another reminder was sent by the applicant to D.E.O (Male) Manselira on 08.04.2019 but the same was turned with deaf ear. The reminder as well as application was sent to D.E.O (Male) Manselira through registered post as well as by hand which was duly received by P.A to D.E.O (Male), Manselira (Copies are annexed herewith).
- 4. That, in the meanwhile, the applicant time and again visited the office of D.E.O (Male), Mansehra but no response was given to the applicant rather they made lame excuses.
- That, after sufficient time when the grievances of the applicant were not redressed by the E.D.O (Male), Mansehra, therefore, the applicant was constrained to submit an application to Deputy Commissioner, Mansehra with titled mentioned above by hand. After receipt of the said application, the Deputy Commissioner, Mansehra wrote a letter bearing No.6746/Edu/AE/DC(M) dated 16.04.2019 for lawful action at the earliest under intimation to office and the copy of the said letter was also sent to the applicant by registered post. (Copies are annexed herewith).

- That, when no action was taken by the D.E.O on the 6. said application/letter then the application submitted a reminder on 29.04.2019 to Deputy Commissioner, Mansehra personally by hand who again wrote a letter No.8213/Edu/AE/DC(M) dated 30.04.2019 on the subject titled above but till date no legal action has been taken thereupon nor the applicant was issued the copies of the relevant record along with report. (Copies of the same are annexed herewith)
- That, as per the relevant law i.e. Right to Information 7. Act, such like applications must be responded or disposed off within 10 days or as soon as possible under section 7 of the ibid Act but despite lapse of considerable long time, no response has been given to the undersigned nor the copies were issued to the applicant by any means.
- That, needless to mention here that the inquiry file 8. along with all the relevant record is already lying with the District Education Officer (Male), Mansehra and by not issuing the copies of the said record, they are violating the fundamental rights of the applicant.

That, the conduct of the E.D.O Office is dubious, doubtful and smacks malafide on their part as the applicant has every apprehension for the sabotaging of his crucial rights by the hands of the E.D.O Office. The funduct of the E.D.O Office is not above board that they even not responded to the request of Deputy Conninssioner, Mansehra.

lt/s, therefore, most humbly requested that on acceptance of the instant application, the Education Department (Male), Mansehra may strictly be ordered to issue the copies of the inquiry report along with all the relevant documents to the applicant forthwith.
