Learned counsel for the appellant argued the case at some 3. length. There are certain documents/notifications etc which are not on the file enabling the Tribunal to reach a proper conclusion of the matter. The defense of the respondents has already been struck off because of their disinterest in this matter. It has been brought into the notice of the Tribunal that last seniority list of 30.04.2020 impugned before the Tribunal was represented against but the official respondents have not yet decided the same. This contention appears to be correct because there is no reply on behalf of the respondents despite giving them a number of opportunities. Therefore, the Tribunal, in the interest of justice, directs the official respondents that the representation of all the appellants i.e of this appeal as well as the connected appeals shall be deemed as pending and decided in accordance with law and rules within a period of sixty days from the receipt of this order under intimation to this Tribunal
