Learned counsel for the appellant argued that the appellant was serving as H.C and after putting in almost 12 years service he was malafidely involved in a criminal case registered vide FIR No. 97 dated 10.2.2014 registered under section 9-C CNSA at PS Swabi in which case he was confined and finally acquitted on 6.6.2015 by the Court of Learned Sessions Judge Swabi. That after release the appellant submitted departmental appeal on 12.6.2015 against the impugned order dated 10.4.2014 vide which the appellant was dismissed from service which appeal was also rejected on 10.8.2015 and hence the instant service appeal on 20.8.2015.

That the said criminal case was based on malafide and appellant was acquitted by the Court competent jurisdiction from the charges levelled against him in the FIR and, moreover, no opportunity of hearing was given to the appellant during the inquiry nor the same was conducted in the prescribed manners.


