Appellant alongwith his counsel Mr. Fazal Shah Mohmand, Advocate, present. Preliminary arguments heard.

Learned counsel for the appellant has contended that the appellant was appointed as Assistant Programmer/Assistant LAN Administrator (BPS-16) vide notification dated 10.05.2018. He next contended that as per seniority list dated 12.08.2020, the appellant is placed at the top of the seniority list in his own cadre, however vide impugned notification dated 28.04.2021, amendments were made in Appendix against serial No. 02 in column 5 clause (a) and "Note" was also added whereby the Khyber Pakhtunkhwa Police Department (Information and Technology Wing) Service Rules, 2014 were amended thereby maintaining joint seniority list of the Assistant Programmers, Assistant LAN Administrators and Computer Operators (BPS-16), which has adversely affected the right of promotion of the appellant because maintaining of joint seniority list would adversely affect the seniority of the appellant and his legitimate prospects of promotion., He further contended that both the posts are distinct posts of different cadres, therefore, the impugned amendments being wrong and illegal are liable to be strucked down.

Points raised need consideration, hence the appeal is admitted to regular hearing subject to all legal and valid objections. The appellant is directed to deposit security and process fee within 10 days, whereafter notices be issued to the respondents for submission of written Security rocess FC3 reply/comments in office within 10 days after receipt of notices, positively. If the written reply/comments are not submitted within the stipulated time, the office shall submit the file with a report of noncompliance. File to come up for arguments before the D.B on 25.10.2021.

> The appeal is also accompanied by an application for restraining respondents from issuing joint seniority list of Assistant Programmers, Assistant LAN Administrator and Computer Operators till the final disposal of the instant appeal. Notice of the application be issued to the respondents and in the meanwhile status-quo be maintained till the date fixed subject to notice.
