SERVICE APPEAL UNDER SECTION 4 OF KPK SERVICE TRIBUNAL ACT OF 1974 AGAINST THE PROMOTION ORDER DATED 24.07.2013 PASSED BY THE DIRECTOR GENERAL HEALTH SERVICES WHEREBY THE APPELLANT HAS BEEN DEFERRED FROM THE PROMOTION OF BPS-16 AS CHIEF CLINICAL TECHNICIAN WHILE HIS JUNIORS RESPONDENTS NO.5 TO 15 PROMOTED WITHOUT REASON AND RHYME AGAINST THE SERICES RULES AND REGULATION.

PRAYER:- On acceptance of the instant appeal, the promotion order dated 24.07.2013 passed by Respondent No.2 may please be set aside and appellant may please be promoted from X-Ray Technician (BPS-9) to Chief Clinical Technician Radiology (BPS-16) with all back benefits from the date his juniors Respondents No. 5 to 15 were promoted as Chief Clinical Technician Radiology.

The brief facts arise in the instant service appeal are following:-

- 1. That the appellant got employment in Respondent Department as Radiographer in BPS-6 on 31.08.1989. Copy of appointment order is attached as **Annexure "A"**
- 2. That after rendering 16 years continuous spotless service, the appellant was appointment as X-Ray Technician in BPS-9 vide order No. 1996-2001 dated 02.05.2006. Copy of order dated 02.05.2006 is annexed as **Annexure "B"**.
- 3. That respondents/department circulated Seniority list of X-Ray Technician of BPS-9 in which my date of appointment as X-Ray Technician was wrongly mentioned as 22.05.2006 instead of 02.05.2006. Copy of seniority list is annexed as **Annexure "C"**.
- 4. That incorrect seniority list was challenged by the appellant for correction on the basis of appointment order dated

02.05.2006 entries in Service Book at Page-15. Copy of service book is annexed as **Annexure "D"**.

- 5. That the appellant took charge as X-Ray Technician on 03.05.2006 which was duly accepted by MS DHQ Hospital Haripur. Copy of arrival/charge report dated 03.05.2006 is annexed as **Annexure "E"**.
- 6. That the department after thorough investigation and conducting several inquiries correct the date of appointment as X-Ray Technician (BPS-9) on 02.05.2006 instead of 22.05.2006 vide Director General Health Services KPK through letter No. 3887-AE-VII dated 13.05.2014. Copy of letter dated 13.05.2014 is annexed as **Annexure "F"**.
- 7. That the above mentioned letter, correct the seniority list was issued on 07.11.2013. Copy of correct seniority list is annexed as **Annexure "G"**.
- 8. That on the basis of correct seniority list, the appellant approached the department for promotion as Chief Radiology Technician (BPS-16) in response the DG Health KPK intimated that the case of promotion of the appellant would be dealt with under the relevant rules vide letter No. 4659-AE-VII dated 24.07.2014. Copy of letter dated 24.07.2014 of DG Health is annexed as **Annexure "H"**.
- That all the efforts of appellant are fruitless and the appellant is still running between the pillar and poll for his lawful promotion.
- 10. That on the basis of baseless application in which the Department without having approach through appellant immediate superior have put another inquiry. In which the matter was referred to DHO Haripur vide DG Health

Services KPK letter No. 4919-AE-VII dated 29.04.2015 and 8662-AE-VII dated 06.07.2015 are as **Annexure "I"**.

- 11. That after conducting inquiry by the DHO Haripur submitted his reply to the DG Health Services regarding the factual position vide letter No. 8272 dated 06.08.2015 which was delivered to the appellant on 10.08.2015. Copy of letter of DHO Haripur dated 06.08.2015 is annexed as **Annexure "J"**.
- 12. That on receipt of factual position/clarification of appellant's appointment there was no need to delayed the appellant legitimate, legal and due promotion by Departmental authority but they are bent upon to deffer or avoid promotion as Chief Clinical Technician Radiology on the basis of one or the other lame pretext.
- 13. That feeling aggrieved, the appellant filed departmental appeal to the respondent No.2 on 08.09.2015 for promotion of the appellant from BPS-9 to BPS-16 as Respondents 5 to 15 are Juniors to appellant. Copy of departmental appeal dated 8.9.2015 is attached as **Annexure "K"** but respondents/department kept the appellant assured on one or the other pretext that he would be given his due right of promotion but without any result till today, hence the instant appeal is filed inter-alia on the following grounds:-

GROUNDS

(a) That the impugned order dated 07.11.2013 is illegal, unlawful, without lawful authority, passed in slipshod and cursory manner without adhering to the departmental rules and regulation, set forth for the promotion of appellant.

- (b) That the appellant is entitled to be promoted from Junior Clinical Technician (Radiology) BPS-9 to Chief Clinical Technician Radiology BPS-16 w.e.f 24.07.2013 as the appellant is senior to Respondents No.5 to 15.
- (c) That as per Article 25 of Constitution of Islamic the public of Pakistan 1973 as well as service laws and principal of equality, if juniors to the appellant are promoted in BPS-16 then the appellant is entitled to be promoted from BPS-9 to BPS-16 that respondents/ department suppose to promote the appellant after rectification of date of appointment in BPS-9 i.e. 02.05.2006 instead of 22.05.2006 and issuance of revised/ final seniority list of Junior Clinical Technician in 2014 in BPS-16, hence the appellant has been seriously discriminated.
- (d) That when law prescribe something which is to be done in a particular manner that must be decree in that manner and not other-wise, it is settled principal of law that the appellant being senior from Respondents No. 5 to 15 is eligible to be promoted in BPS-16 on 24.07.2013.
- (e) That there is no other remedy available to appellant except the invocation of jurisdiction of Honourable Service Tribunal and this Honourable Service Tribunal has got every jurisdiction to entertain and adjudicate upon this matter.
- (f) That the appeal of the appellant is within the period of limitation.

It is therefore most humbly prayed that on acceptance of the instant appeal:-

- (i) That the promotion order dated 24.07.2013 may please be set aside and respondents/department be directed to promote the appellant from X-Ray Technician (BPS-9) to Chief Clinical Technician Radiology (BPS-16) with effect from the date of 24.07.2013 while Respondents No. 5 to 15 are junior to the appellant with all service back benefits.
- (ii) Any other relief which the court may think fit and proper may also be granted to the appellant.




