Respectfully Sheweth;-

- 1. That the appearant serving in services unit Nawanshehr for last 35 years.
- 2. That initial appointment of appellant is of clerical cadre and have been awarded BPS-11 on 25/03/2015 through order No.598/PC(Atd).
- 3. That appellant applied to the TMO Abbottabad for upgradation from BPS-11 to BPS-14 as appellant is most senior in service from all employees.
- 4. That TMO Abbottabad through order No.35/TMA dated 14/02/2018 and of ice order No.36/TMA dated 15/02/2018 M. Ijaz Junior Clerk and Mr. Shakeel Abdul Aziz were promoted to BPS-14.
- 5. That the appellant applied for review of the order but TMO through order 4145/TMA on 05/04/2018 on very flimsy grounds dis-entitled the appellant for seniority.
- 6. That the order No.4145/TMA dated 05/04/2018 is illegal and liable to be set aside on following amongst others grounds;-

GROUNDS;-

a. That the appellant is a senior employ of the services unit Nawansher.

- b. That appellant from very first day of his appointment was inducted as clerical cadre whereas appellant through order 36 dated 15/02/2018 upgraded the Mr. Shakeel Abdul Aziz who is pump operator by his original cadre. Moreover up-gradation made through order 35 dated 14/02/2018 in favour of M. Ijaz is also unjustified because of the reason that he is most junior to the appellant.
- c. That TMO Abbottabad in impugned order wrongly interpreted the adjustment policy and appellant was shown as remained or transferred to other institution, whereas appellant throughout served in services unit Nawansher.
- d. That TMO has not properly inquired the matter and hastily decided the review.
- e. That appellant is a prior servant who spent precious moment of life in the services and worked honestly but TMO Abbottabad illegally refused to up-graded, hence present appeal is being file.

f. That appeal is within time.

So, it is humbly prayed that up-gradation of the appellant be made while rejecting the TMO order.


