COLLEGE HANGU VIDE NOTIFICATION NO. 679/S/RESULT DATED: 07.04.2016 AND AS PER LAW, RULES AND REGULATIONS.

Respected Sir,

The brief facts leading to the instant appeal are arrayed as follows:-

1. That, the appellant is serving in police department and was promoted as Head Constable in the year 2012 and thereafter qualified intermediate college course at Hangu and was declared successful by police training college Hangu, the name of appellant was included in "D" list. The police training college Hangu also issued performance report to appellant and notification No. 679 on 07.04.2016. Appellant was shown at serial No. 28 and was placed on merit No. 27, respondent No. 2 was shown at serial No. 33 and was placed on merit No. 32, and Alamzeb was shown at serial No. 152 and was placed on merit at No. 148 in the said notification respectively. **(Notification Dated: 07.04.2016 is annexed as annexure A and performance report of the appellant is annexed as annexure B respectively).**
2. That, respondent No.3 passed intermediate college course from police training college Hangu on 31st May 2016.
3. That, office of the commandant, police training college Hangu, circulated the said notification dated: 07.04.2016 to respondent No.1 for the purpose of assigning seniorities

to appellant and respondent No. 2 to 4 and others as per law. The respondent No.1 did not fix the seniority of the appellant and respondent as per service law, as per notification and merit rather disturbed the seniority list by placing respondent No. 2 to 4 on top at serial No. 368, 369, 390 while appellant was placed at serial No. 400. **(The Seniority list is annexed as annexure C).**

4. That, appellant feeling aggrieved from the said seniority list passed by respondent No.1 filed departmental representation / appeal, but respondent No.1 dismissed the appellant departmental representation vide order dated: 05.10.2017. **(The Copy of departmental representation is annexed as annexure D and order Dated: 05.10.2017 is annexed as annexure E.**
5. That, appellant seeks the indulgence of this Honourable service tribunal / Court against the impugned order No. 22981 Dated: 05.10.2017 on the following amongst other grounds.

GROUNDS

- a. That, the impugned order passed by respondent No. 1 is against the law, fact, precedents of the superior courts, hence not maintainable under the law.
- b. That, the impugned order passed by respondent No.1, is arbitrary, fanciful,

perverse without any reasons, hence liable to be struck down.

- c. That, respondents No. 2 to 4 had volunteered themselves to be posted in new District Torghar. So as per bottom seniority rules the said respondent No.1 was bound to follow the same principal and respondents No. 2 to 4 had to respect this principal. **(Copy enclosed herewith).**
- d. That, respondent No.1 while issuing impugned order had not assigned any cogent reason for dismissing appellant departmental representation / appeal and had ignored the service law, rules and regulations.
- e. That, though respondent No. 2 & 3 did qualified intermediate college course alongwith appellant term-ending on 31.01.2016, and appellant was assigned merit No. 27 while said respondents were assigned merit No. 32 and 148. Similarly, respondent No.4 did qualify intermediate college course on 31.05.2016 was much junior to appellant, therefore, respondent No.1 while making seniority list was bound to consider merit Nos. issued by Hangu College to respondent and appellant, but respondent No.1 as all together ignored the said factors.
- f. That, the impugned order of the respondent No.1 is based on malafide,

against the mandate of police service laws and other laws.

- g.** That, it is the mandate of the rule of law that, merit should be followed in true letter and spirit and respondent No.1 has violated this golden rule of law.
- h.** That, respondent No.1 while promoting respondent No. 2 to 4 without any justification / reasons has discriminated appellant and aroused the spirit of constitution.
- i.** That, the impugned order does not fall within the ambit of speaking order.
- j.** That, the constitution of the Islamic republic of Pakistan has guaranteed fundamental right and discouraged the discrimination. Respondent No.1 has not followed this principal in its true spirit. (Copy of order dated: 31.08.2017 is annexed).
- k.** That, by not following the mandate of Constitution, Police service laws, rules and regulations respondent No.1 has denied the promotion rights, pension benefits and other benefits.
- l.** That, while promoting ASIs and bringing their names on list "D", there should have been a uniform policy and order, but in the above cited order altogether a

different order was made which is quite alien to law.

m. That, by brining the names of the official mentioned therein from previous dates, the seniority of the appellant has been badly affected which requires to be rectified in the light of police rule.

n. That, the impugned order is void abinitio, without any justification reasons, therefore, no limitation runs against the appellant.

o. That, the impugned order was never communicated or sent to appellant. Therefore, appellant was constrained to personally approach respondent No.1 office on 05.11.2017, the said respondent No.1 issued the photocopy of impugned order to appellant.

p. That, the impugned revised seniority list was also never sent or communicated to appellant and appellant was constrained to visit the respondent No.1, which issued impugned seniority list in May 2017.

q. That, Other relevant points will be raised and agitated at the time of arguments.

it is, therefore, most humbly prayed that on acceptance of the instant appeal, the impugned order dated: 05.10.2017, passed by respondent no.1



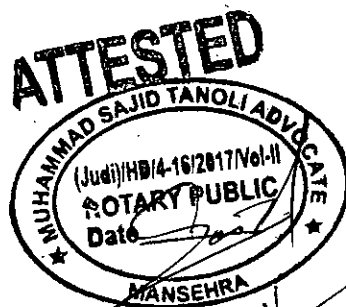



2. That, the impugned order was never communicated or sent to appellant and on the face of its is void ab-initio. The impugned order is void ab-initio; therefore, there is no fault on the part of appellant.
3. That, infect the order relating to his dismissal of application is void ab-initio and whenever any such order is being passed, limitation does not run in respect of such order.

It is therefore, requested that in the light of above,
the delay if any may kindly be condoned.

Kindly Refer to your office memo No. 16749/E dated 26.07.2016, on the subject noted above along with report of the committee on the issue of seniority among LHCs of district Torghar. The report was scrutinize with by the assistance by legal branch and the outcome is as under:-

The concluding Para (i) of the committee report is correct to the extent that generally the seniority of Police officer is fixed according to the merit of the qualifying promotion course with their badge-mates in their parent district but the matter under review is with regard to transfer from one district to other district on willingness basis with sole aim of gaining seniority. In case this practice is encouraged then it will open a flood gate for transfer of men from one district to another.

CPO has already conveyed its decision vide letter No. 25349/E-I dated 09.10.2013 followed by order No. 3781-84/Legal dated 25.08.2016, as pointed out in the recommendation of the committee received vide your office above quoted reference that LHCs transferred on willingness basis to District Torghar will accept bottom seniority. The above directions of CPO are specific with regard to fixation of seniority of LHCs transferred to District Torghar on willingness basis, therefore, the proposal of the committee to make the orders effective from 09.10.2013 is not maintainable.

In view of the position explained above the seniority of LHCs transferred on willingness basis shall be fixed according to principle of bottom seniority. Thus the issue of seniority must be disposed off accordingly.
