Brief facts giving rise to the instant appeal are as under;

1. That the Appellant challenged the impugned withdrawal order dated: 06-05-2019 in Writ Petition No. 601 before the Hon'ble Peshawar High Court, Abbottabad Bench. *(Copy of the Writ Petition is annexed as Annexure "A")*.
2. That the Writ Petition No. 601-A of 2019 was disposed off on 01-12-2020 and appellant is directed to approach the proper forum. *(Copy of the Order is annexed as Annexure "B")*.
3. That Appellant is B.S Honors having requisite qualification for the post of SST Bio-Chemistry (BPS-16). *(Copies of the testimonial are annexed as Annexure "C")*.

4. That respondent No. 2 had advertised the posts of SST Bio-Chemistry in BPS-16). *(Copy of the advertisement is annexed as Annexure "D")*.
 5. That Appellant has applied for advertised posts being qualified and consequence upon the recommendation departmental selection committee, appellant is appointed against the vacant posts in the schools through an order Endst. No. 619-25 dated: 14-09-2018 and has taken over the charge in the respective schools. *(Copies of the appointment order and charge order are annexed as Annexure "E")*.
 6. That the Appellant is serving in the department since then satisfactory and there is no complaint whatsoever against the appellant.
 7. That respondent no. 2 had issued another order of appointment bearing Endst. No: 2275-82 dated: 06-05-2019, whereby the appointment of respondents No. 4 to 8 were made and appointment order of the appellant was withdrawn. *(Copy of the order dated: 06-05-2019 is annexed as Annexure "F")*.

8. That appellant submitted the departmental appeal to competent authority on 09-05-2019, which was still not decided by the respondent No. 1. *(Copy of the department appeal is annexed as Annexure "G")*.
 9. That the impugned order dated: 06-05-2019 is liable to be cancelled / struck down inter alia, on the following grounds;

GROUND:

- A. That the impugned order dated: 06-05-2019 is illegal, without jurisdiction, without lawful authority and based on malafide in order to compensate his dear ones / blue eyed chaps.
- B. That the appellant is appointed on merit and serving the departmental to the entire satisfaction of the department, hence order once had taken effect cannot be withdrawn on the grounds mentioned in the impugned order.
- C. That the appellant has also applied for the post of PET at serial No. 3 and the post of CT at serial No. 7 of the merit list and after appointment of the present, post of SST, he opted to forego the appointment order due to

the impugned order his rights of appointment to other posts were abolished and has suffer an irreparable loss.

D. That the respondent NO. 4 to 8 were not appointed in the initial order dated: 14-09-2018 being not eligible having not read Botany or Zoology as per criteria.

E. That candidate at serial No. 26 having 111.24 score having low merit than the appellant was left and appointment order of the appellant was withdrawn, hence, it is also against the policy of the Government and proves the malafide and discrimination of the part of the respondents.

F. That in the impugned order at serial No. 8, the appointment of respondent No. 8 was made who is also having low merit than the appellant.

G. That the selection committee did not consider the appointment of respondents No. 4 to 8 being not eligible and unqualified. (*Copy of the rejection of respondents No. 4 to 8 is annexed as Annexure "H"*).

H. That the respondents No. 4 to 8 managed to obtain forge and illegal equivalency certificate

from the Controller of Examination, Hazara University, Mansehra on 20-02-2019 subsequently vide letter No. 17/HU/Ce/2019/506 dated: 13-06-2019, the controller categorically certified that equivalency certificate was issued just for academic purpose and not for any employment. *(Copies of both the letters are annexed as Annexure "I" and "J")*

- I. That the proper forum for issuance equivalency certificate is Higher Education Commission, Islamabad.
- J. That hon'ble Peshawar high Court, Bench Abbottabad has also issued status quo. *(Copy of the status quo order is annexed as annexure "K")*
- K. Impugned order is a void order.
- L. That other grounds will be agitated at the time of arguments.

It is therefore, most humbly prayed that on acceptance of the instant appeal, the impugned order dated: 06-05-2019 may please be declared as illegal without jurisdiction, without lawful authority based on malafide and collusion and liable to be cancelled/ struck down and appointment order of the appellant bearing Endst: No. 619-25 dated: 14-09-2018

- b) That petitioners were appointed on merit and serving the department to the entire satisfaction of the department, hence order once had taken effect cannot be withdrawn on the grounds mentioned in the impugned order.
- c) That petitioner No.1 & 3 had also applied for the posts of PST, PET and CT and was at serial No.1 of the merit list and after appointment of the present post of SST he



opted to forgo the appointment due to the impugned order their rights of appointment to other posts were abolished and had suffered an irreparable loss.

- d) That respondent No. 4 to 8 were not appointed in the initial order dated 14/09/2018 being not eligible having not read Botany or Zoology as per criteria.
- e) That candidate at serial No. 26 having III-24 score having low merit then the petitioners was left and appointment order of the petitioners was withdrawn, hence it is also against the policy of the Government and proves the malafide and discrimination on the part of the respondents.
- f) That in the impugned order at serial No. 8 the appointment of respondent No. 8 was made who is also having low merit then the petitioners.
- g) That court fee stamp paper worth Rs. 500/- is affixed.

It is therefore, most humbly prayed that on acceptance of instant writ petition; impugned order dated 06/05/2019 may kindly be cancelled/ struck down and order of the appointment of the petitioners bearing Endorsement No.619-25, dated 14/09/2018, may kindly be restored with all back benefits. advertisement, the respondent invited application for appointment against different posts including the post of SST Bio / Chemistry in BPS-16 on the terms and conditions mentioned therein. Petitioners having requisite qualification applied for the same, competed with others and finally selected as such on 14.09.2018. In pursuance thereof, they submitted arrival and assumed the charged. However, on 06.05.2019, their appointment order was withdrawn on the ground that they were low in merit, which necessitated to file the present constitutional petition.

3. Arguments heard and record perused.

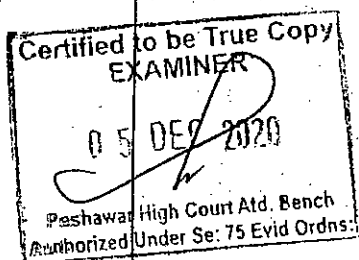
4. It is evident from the record that vide appointment order dated 14.09.2018, petitioners were appointed as SST Bio / Chemistry in BPS-16, however, at a belated stage their appointment order were withdrawn, on 06.05.2019. Admittedly, the petitioners are civil servants. They have challenged the withdrawal of their appointment order through instant petition. The dispute brought before this court relates to the terms and conditions of the civil servants, the Service Tribunal constituted under Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974, has jurisdiction to hear appeals of the civil servants as defined in Section 2(a) of the Service Tribunal Act and Section 2(1)(b), of the Civil Servant Act, 1973, it has the power to confirm, set aside, vary or modify the order



~

appealed against. All question of law and facts urged before us are open to be gone into by the Tribunal. A plane reading of Article 212 of the Constitution of Islamic of Republic of Pakistan, 1973 would make it crystal clear that the Tribunal has the exclusive jurisdiction to hear disputes in these matters and jurisdiction of High Court is also ouster to all such matters which fell within the jurisdictional domain of Service Tribunal. In this context, reliance can be placed on the judgment reported as *Fauzia Siddique Qureshi Vs Secretary, Ministry of Education Islamabad and others (2004 SCMR 521)*.

In this behalf, reference may also be made to the case reported as *Peer Muhammad Vs Government of Balochistan through Chief Secretary and others (2007 SCMR 54)*, wherein it was ruled that Article 212 of the Constitution of Islamic Republic of Pakistan ousts jurisdiction of all other courts and orders of the departmental authority even though without jurisdiction or malafide can be challenged only before the Service Tribunal and jurisdiction of Civil Court including High Court is specifically ousted. The plea of malafide does not confer upon High Court jurisdiction to act in the matter in view of the Constitutional ouster as contained in Article 212 of the Constitution of Islamic Republic of Pakistan and Service Tribunal has full jurisdiction to interfere in such like matters. In this respect further reliance can be

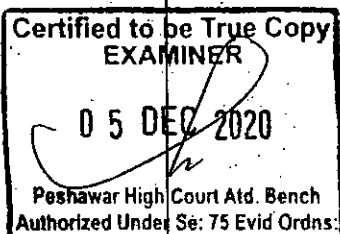

placed on the judgment reported as *Khawaja Abdul Wahid Vs Chairman, WAPDA (1986 SCMR 1534)*. In this regard we are also fortified by the dictum laid down in case reported as *Ali Azhar Khan Baloch Vs Province of Sindh (2015 SCMR 456)*, wherein it was ruled as under:

"Article 212 of the Constitution ousted the jurisdiction of High Courts and civil courts in respect of the matters pertaining to terms and conditions of civil servants--- Provisions of Art. 212 of the Constitution did not confer a concurrent jurisdiction to civil courts, High Courts and Tribunals--- Ouster of jurisdiction contemplated under the Art. 212 of the Constitution was a constitutional command, and, therefore, of necessity restricted the jurisdiction of civil courts and High Courts on the subject, which squarely fell within the exclusive domain of Service Tribunals--- Exercise of jurisdiction by way of suit and constitutional petition filed by a civil servant with regard to his terms and conditions of service was violative of Arts. 175, 212 & 240 of the Constitution and the law---Review petition was dismissed accordingly.

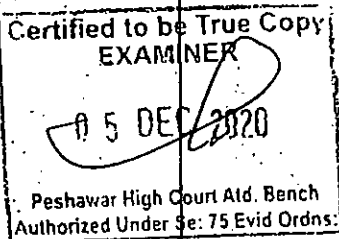
212---Civil service---Terms and conditions of service---Ouster of jurisdiction of civil courts and High Courts---Scope---High Court should not entertain a suit or petition filed by a civil servant relating to his terms and conditions of service, in view of the bar contained under Art. 212 of the Constitution--- Once a civil servant has



exhausted all his legal remedies (up to the Supreme Court), he could not initiate a second round of litigation by filing a constitutional petition or suit on the same subject--Civil servant could not raise any issue which pertained to terms and conditions of his service, particularly, when such issue had finally been decided by the Supreme Court.

Forum--Service Tribunal, jurisdiction of--Mode of correction in the date of birth of a civil servant was provided under R. 12A of the Civil Servants (Appointment, Promotion and Transfer) Rules, 1973, which was part of the terms and conditions of service of a civil servant--Correction in date of birth by a civil servant could not be done through a civil suit (in view of the bar contained under Art. 212 of the Constitution)-- Civil servant had to approach the Service Tribunal for alteration in his date of birth."

The judgment reported as *Jawad Ali and other Vs Superintendent Jail and others (2017 PLC (CS) 587)*, relied upon by the learned counsel for the petitioners is out of context because in the said case, the appointment order of the writ petitioners were cancelled on the desire of competent authority, and that too without assigning any reason. However, in the instant case, the appointment orders of the petitioners was withdrawn, on the complaint of the candidates who were ahead of the petitioners on merit, after probing into the matter.

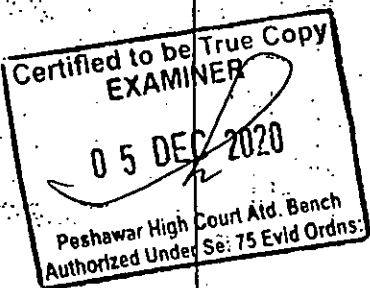
